Count I: 4D's creation of plans for the Project despite not possessing a Certificate of Authority to practice Architecture in the State of Oklahoma, Count II: 4D holding itself out as having the capability to practice architecture in the state of Oklahoma by representing that it "has the necessary qualifications, experience and abilities to provide architectural services to the Owner", in the agreement despite the fact that 4D did not and currently does not possess a Certificate of Authority to practice Architecture in the State of Oklahoma, Count III: Mr. Sayegh unlawfully practicing architecture by creating architectural plans for the Project without a license to practice Architecture in the State of Oklahoma, and Count IV: Holding himself out as having the capability to practice architecture by representing that he "has the necessary qualifications, experience and abilities to provide architectural services to the Owner", in the agreement despite the fact he did not possess and currently does not possess a license to practice Architecture in the State of Oklahoma. Motioned seconded by Mr. Hornbeek, Voting aye: Messrs. Blackburn, Hornbeek, Howard, Taylor, and Mses. Dillingham and Brunsteter. Voting nay: None. Voting abstain Messrs. Baker, Hasenbeck and Gaskins. Motion approved.
