Making public policy and developing the programs that carry out this policy are the work of government. By participating in public life, architects, landscape architects, and interior designers have the opportunity to improve the built environment and the lives of those who experience it. In this capacity, we increase their exposure, make new contacts, learn how things get done in the public arena, and gain knowledge that can be helpful in serving our professions.

The policy-making process seeks to synthesize the needs and aspirations of the public while recognizing that the public is a collection of people and organizations with diverse interests and motivations. These people and organizations develop and advocate positions on current issues and form alliances with the intent of influencing policy. For their part, legislators and government officials responsible for shaping policy depend on the information and positions presented to them.

Know that the Board of Architects, Landscape Architects, and Registered Interior Designers is one of those advocate groups. We are working in your interest to maintain the integrity of each of our professions. At any moment, government officials, legislatures, and even the courts are considering rules, initiatives, and cases in which the Board has knowledge or interest.

Much of our profession's day-to-day practice is regulated by government in the form of zoning and planning ordinances, community design standards, landmark and environmental management standards, building codes and standards, and rules regulating professional practice and conduct. As outgrowths of administrative law, these regulations are often complex and require technical expertise in their administration, interpretation, and enforcement; when given the opportunity the Board responds to those needs.

The Board participates in the policy-making process by contributing technical expertise on important problems and questions in the public arena, as advocates, articulating and communicating our professions' position on issues and initiatives. We become involved in the process of contributing ideas and even language to executives and legislators, especially to their bill-drafting staffs.

In closing, I want each of you to know that the Board and Staff are working to keep our professions in the forefront, and watching for any impactful changes that might affect our Act in a negative way. 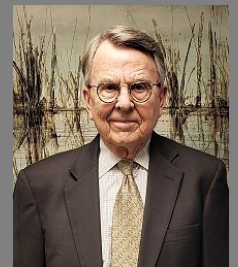

January 11, 2020

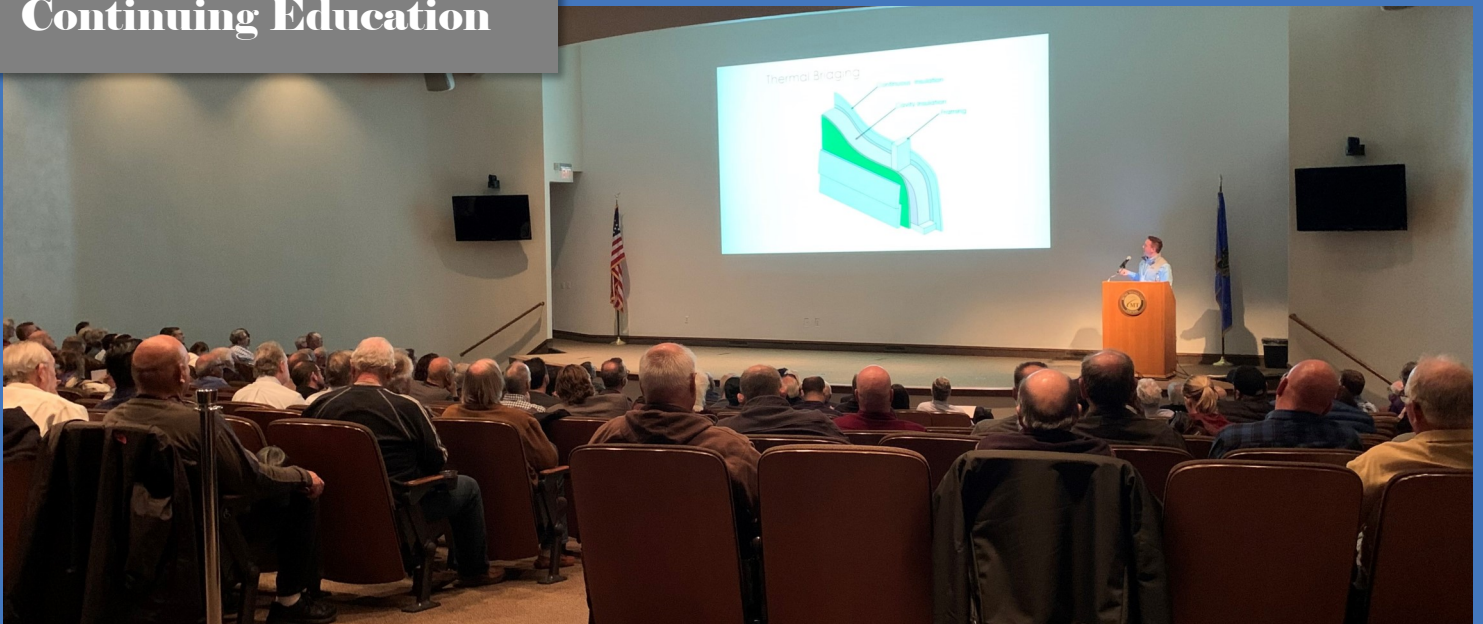

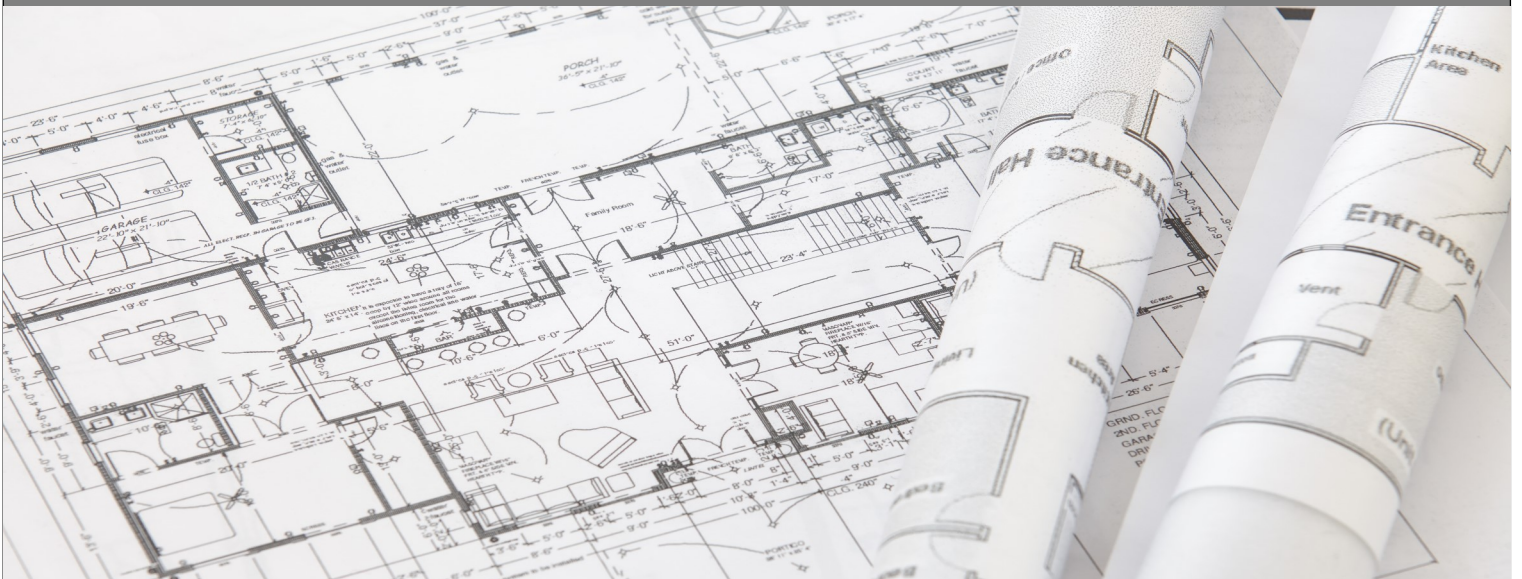

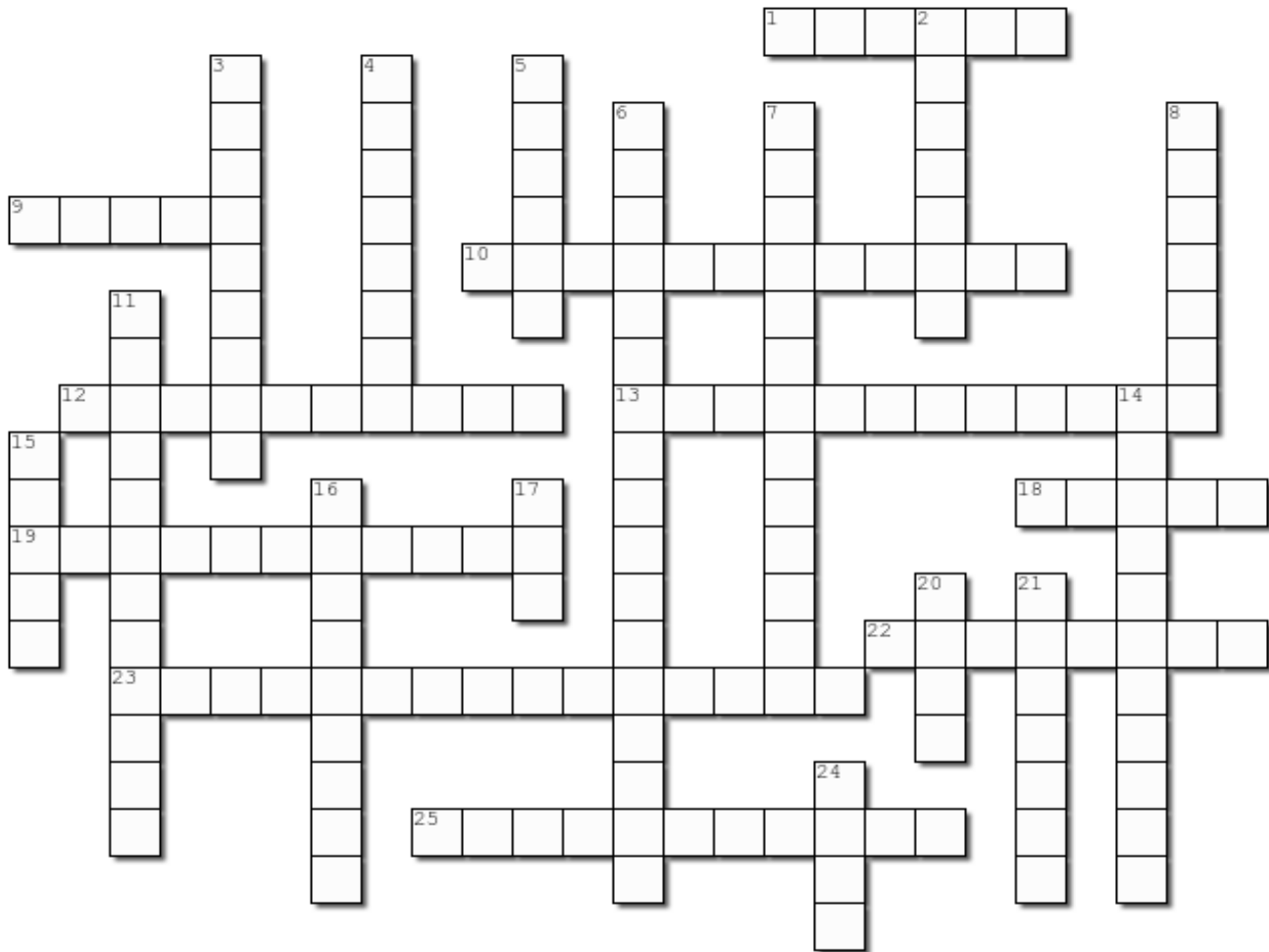
PLAN STAMPING: What is it and what are the consequences?

Section 46.25 of the Oklahoma State Architectural and Registered Interior Designers Act states that

“No licensed Architect may sign or seal technical submissions unless they were prepared by or under the responsible control of the architect; except that: 1. The person may sign or seal those portions of the technical submissions that were prepared by or under the responsible control of persons who are licensed under the State Architectural and Registered Interior Designers Act if the Architect has reviewed and adapted in whole or in part such portions and has either coordinated their preparation or integrated them into the work; and 2. The person may sign or seal those portions of the technical submissions that are not required to be prepared by or under the responsible control of an architect if the architect has reviewed and adapted in whole or in part such submissions and integrated them into the work...”

So, if a contractor or a licensed Architect from another state asks an Oklahoma-licensed Architect to stamp the plans that they have already prepared in exchange for a fee, should the Oklahoma-licensed Architect stamp those plans? The short answer is no. An Oklahoma-licensed Architect cannot stamp plans that they did not personally prepare; however, an Architect can stamp plans in which prototypical work was incorporated into their work. When a licensed Architect stamps plans, they are essentially stating that they are responsible for the work that has been done to prepare the plans, that they are certain that this design does not jeopardize the safety of the public, and that the plans are in full compliance with the codes and standards used in Oklahoma. Therefore, if an Architect did not prepare that set of plans, he or she should not affix their stamp to them. Misuse of a stamp or a seal is a violation and can result in civil penalties, as well as having consequences for renewing or maintaining a license in Oklahoma. **Bottom line: Don't stamp plans if you weren't involved in their preparation and creation, or if you haven't included them in your work, if another person began the work. It is illegal to stamp plans that you did not prepare.**
