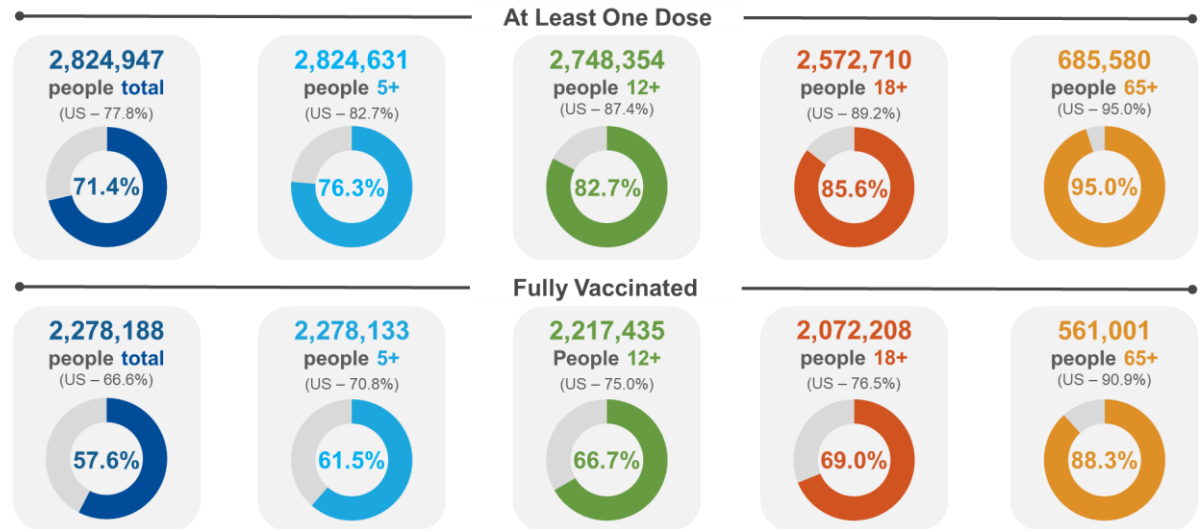

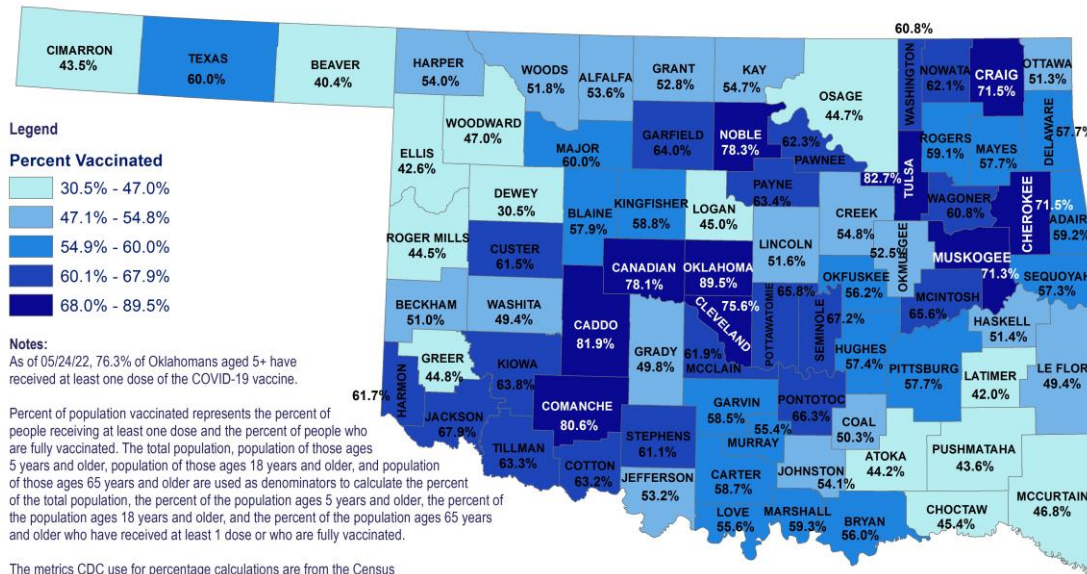

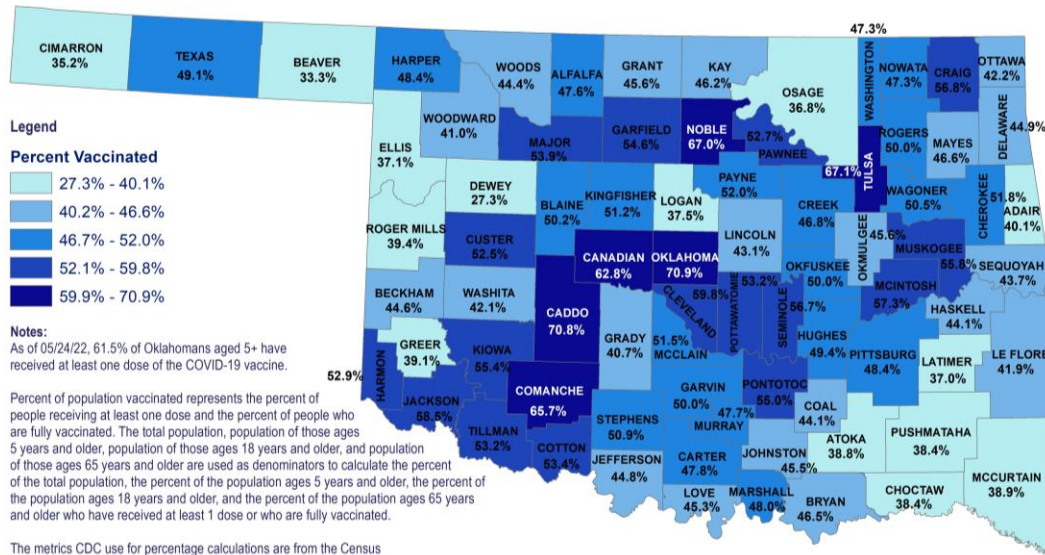

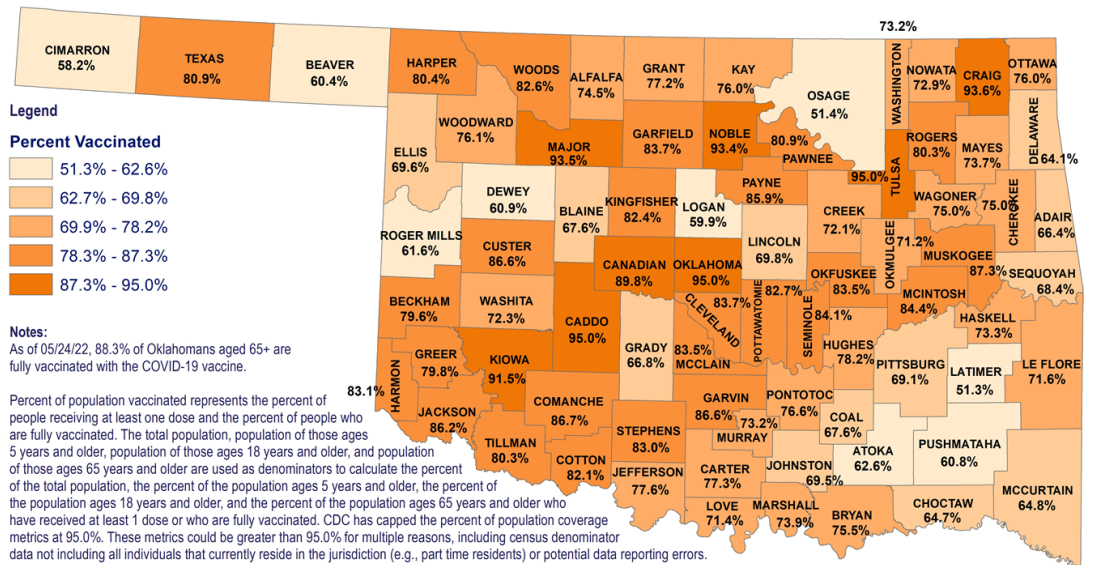

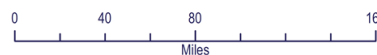

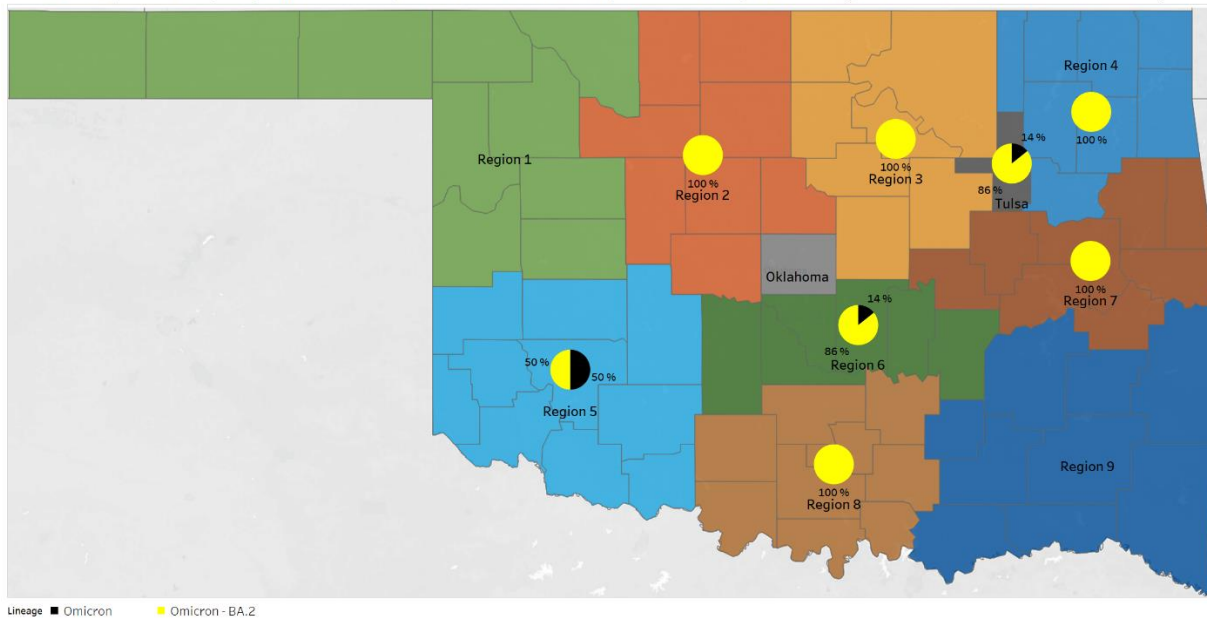

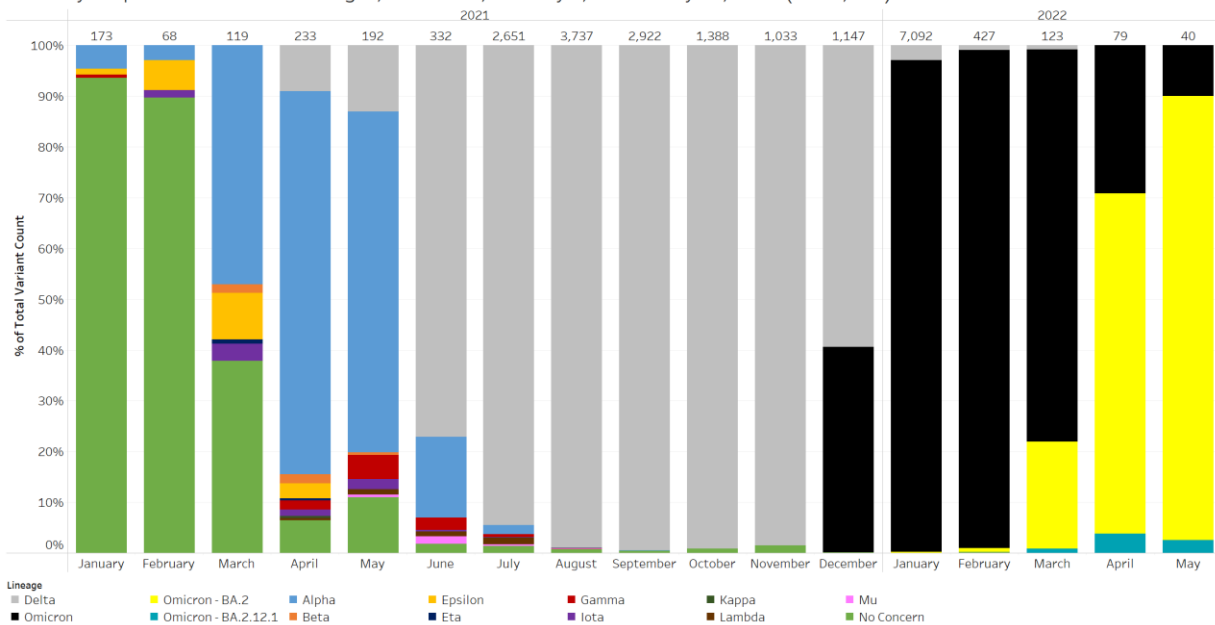
COVID-19 VARIANT STRAINS SEQUENCED*

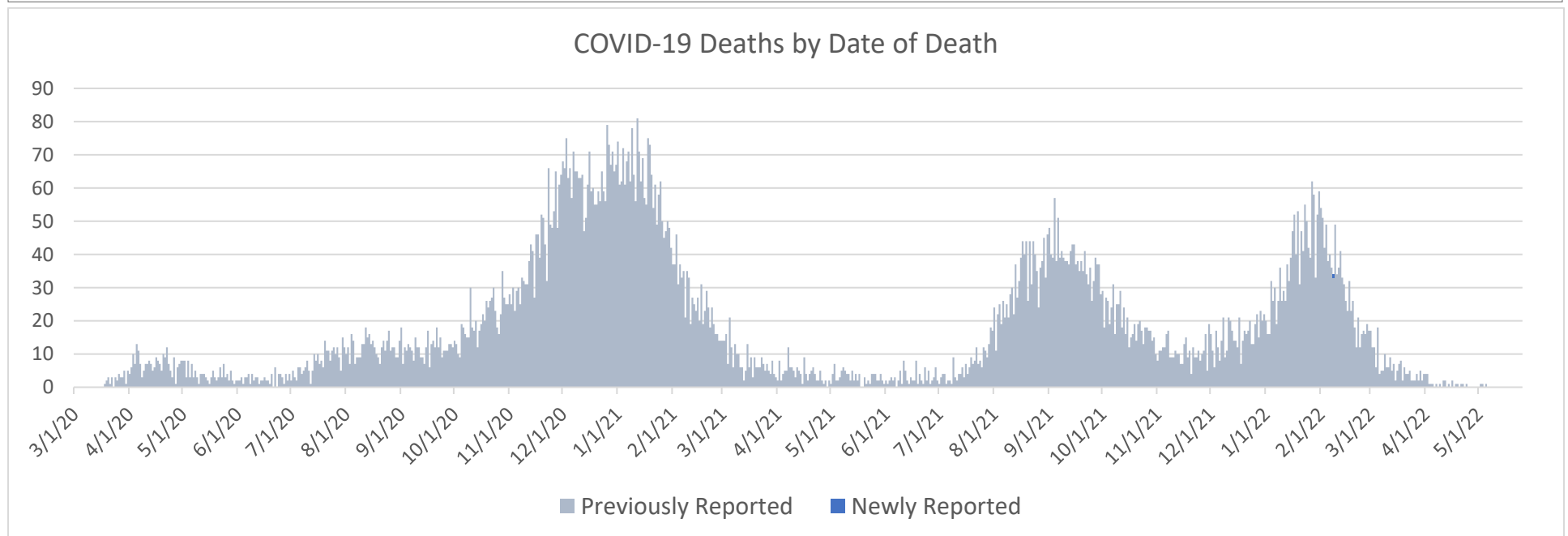

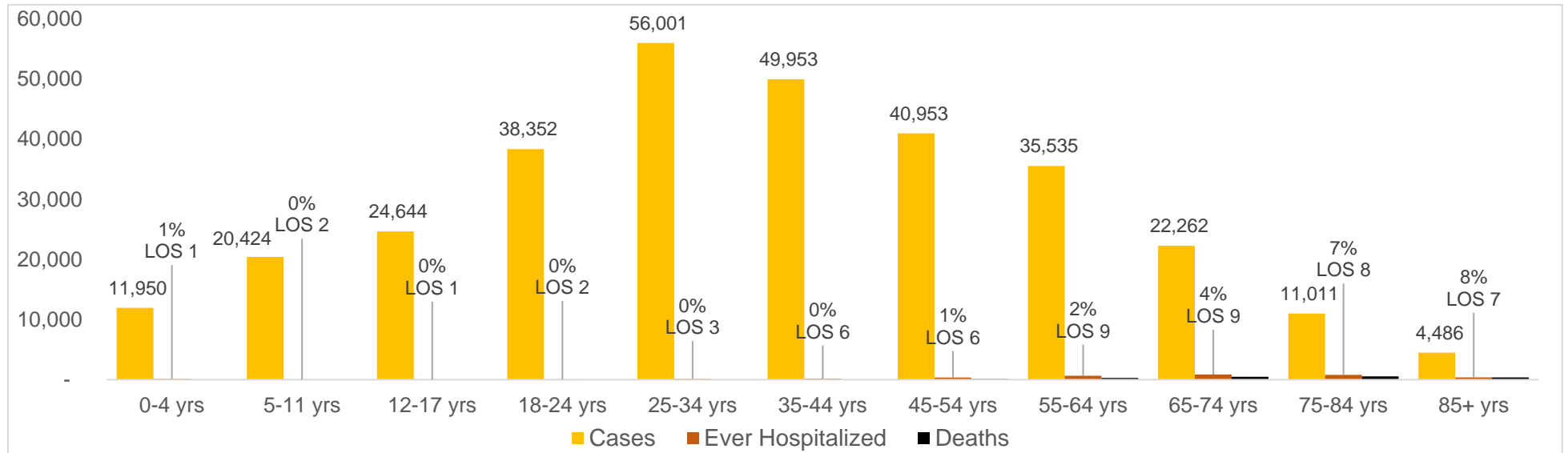

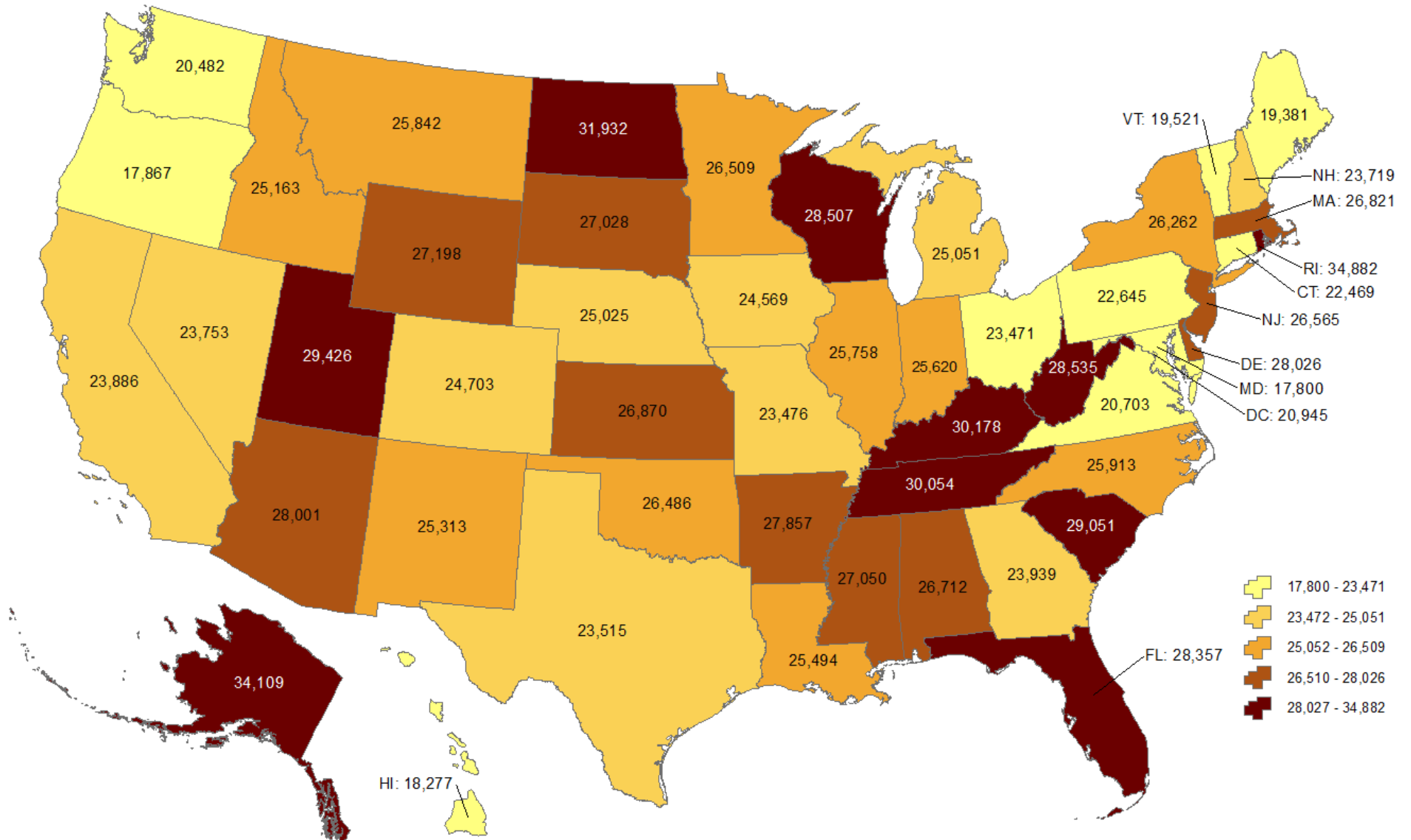

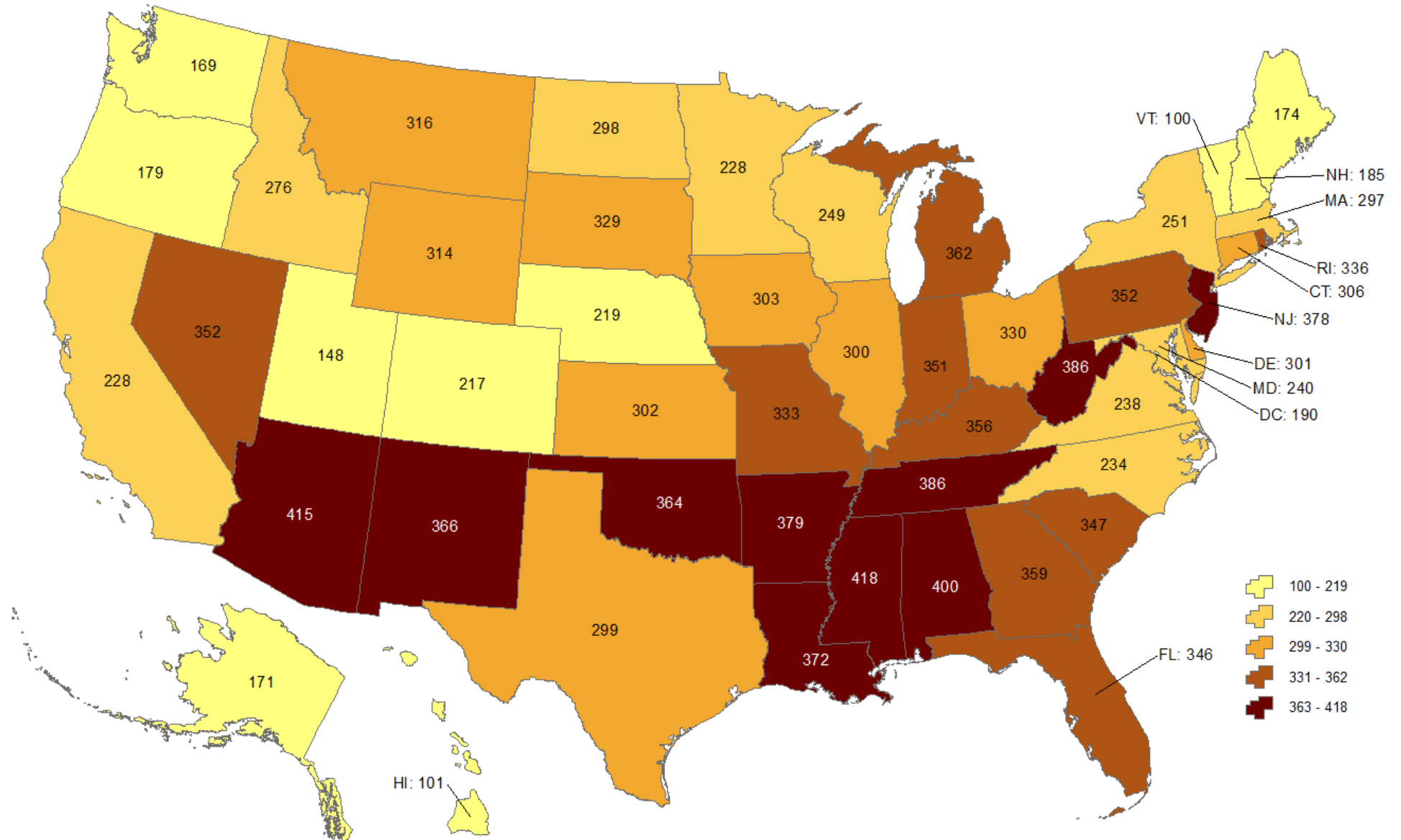

Cumulative death rate of reported COVID-19 cases

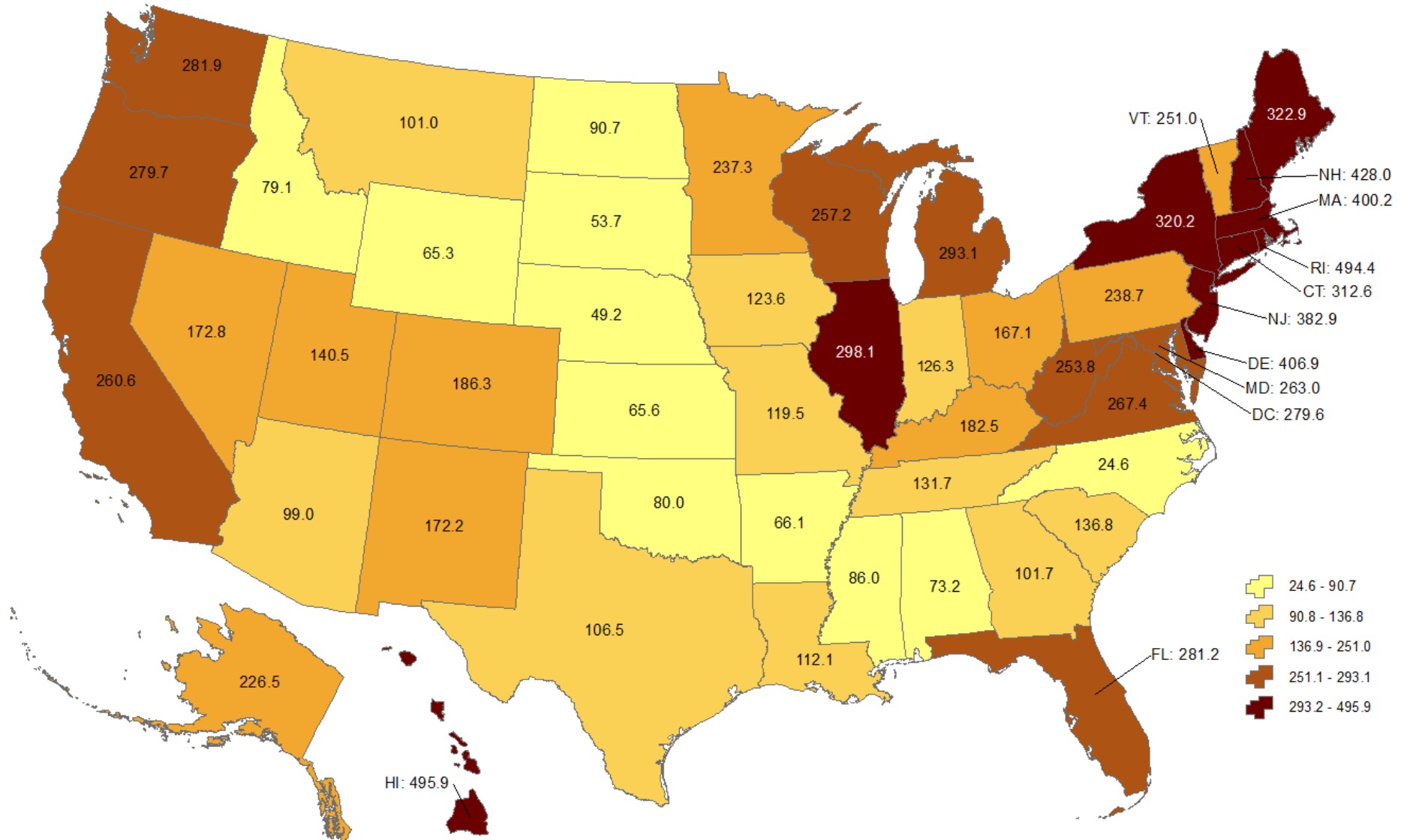

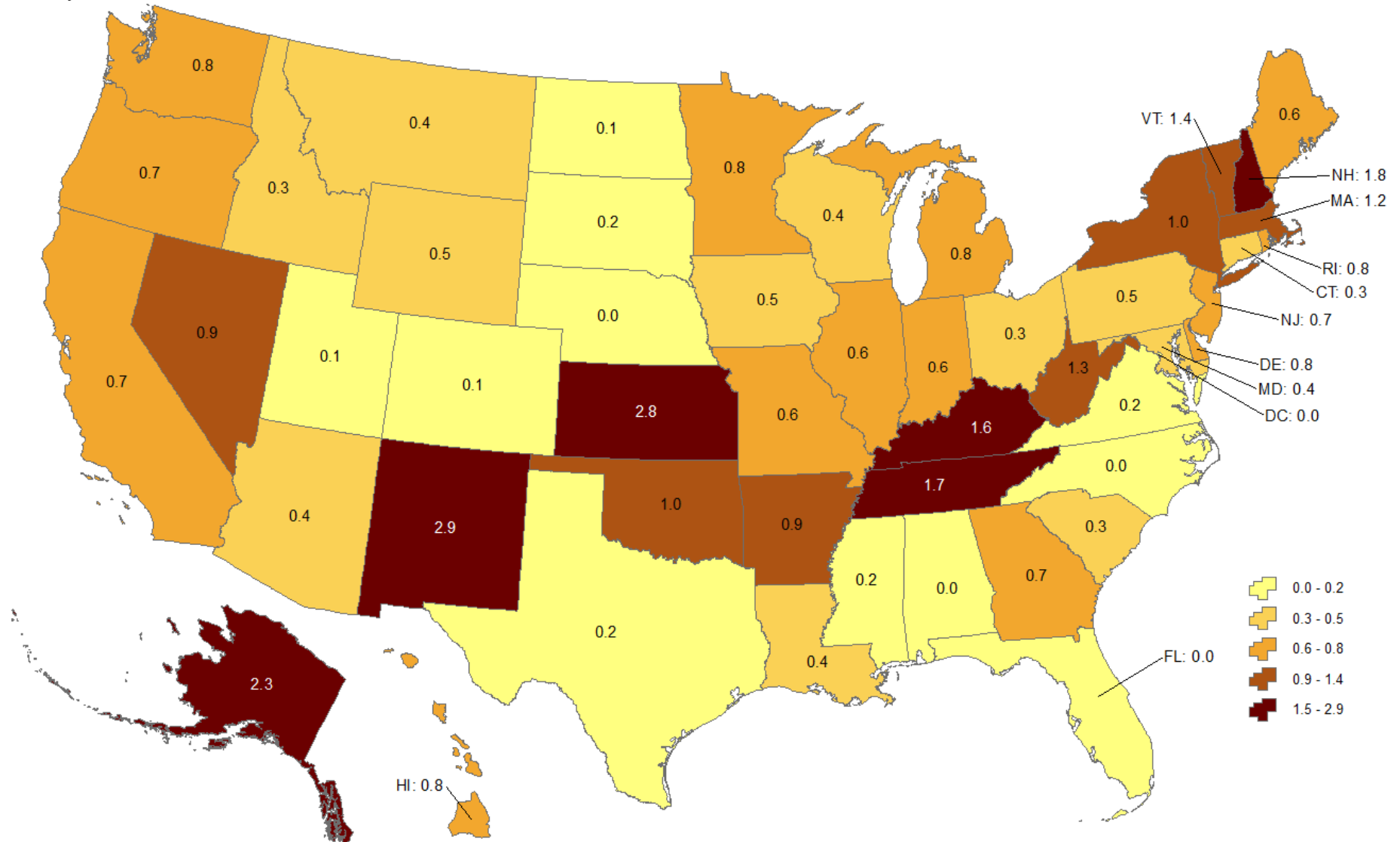

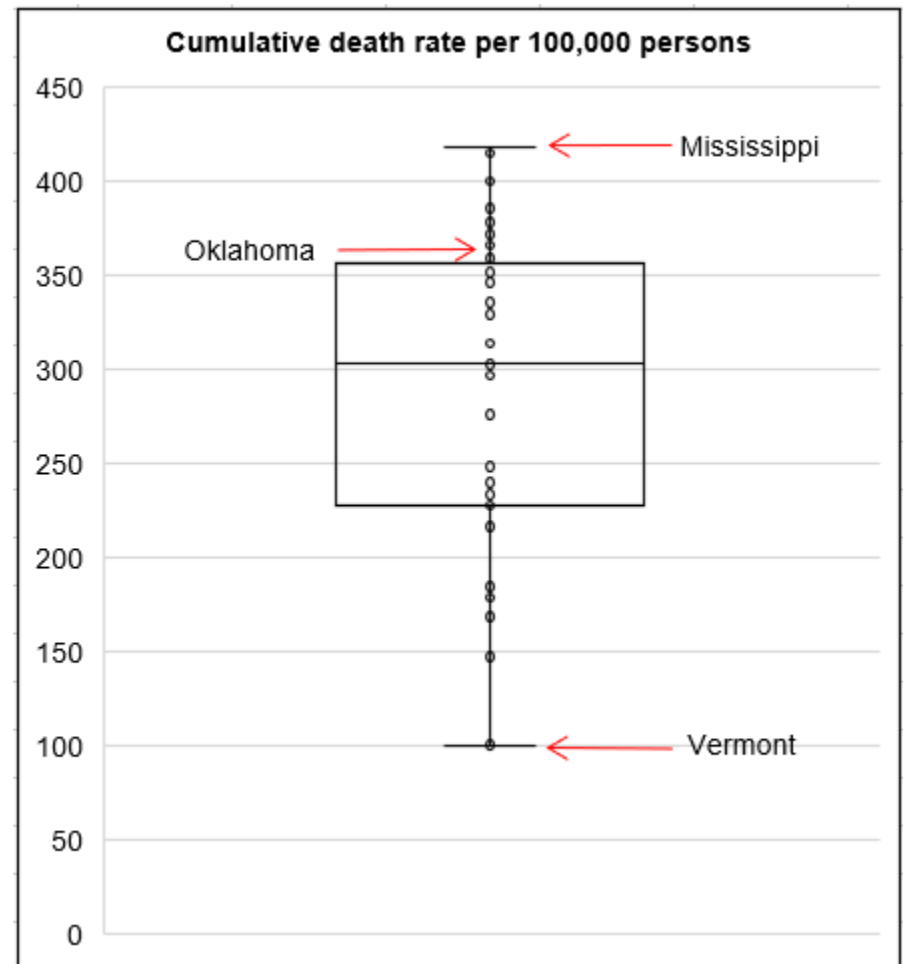
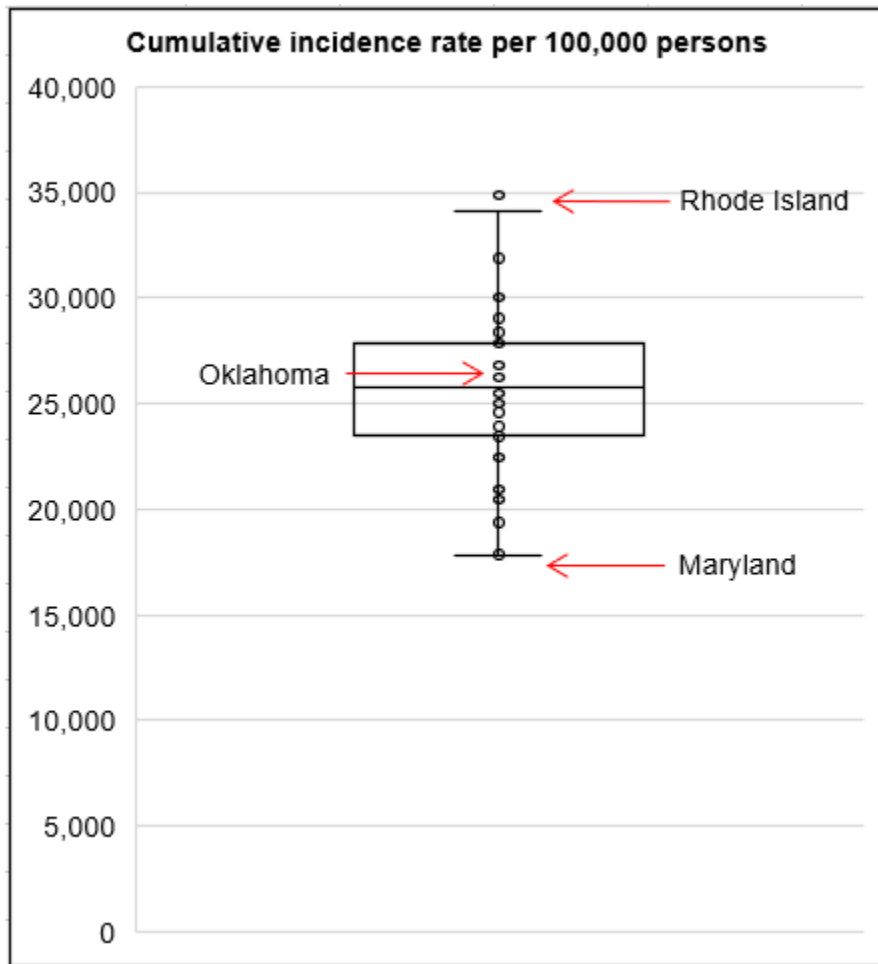

Weekly number of deaths (from all causes)

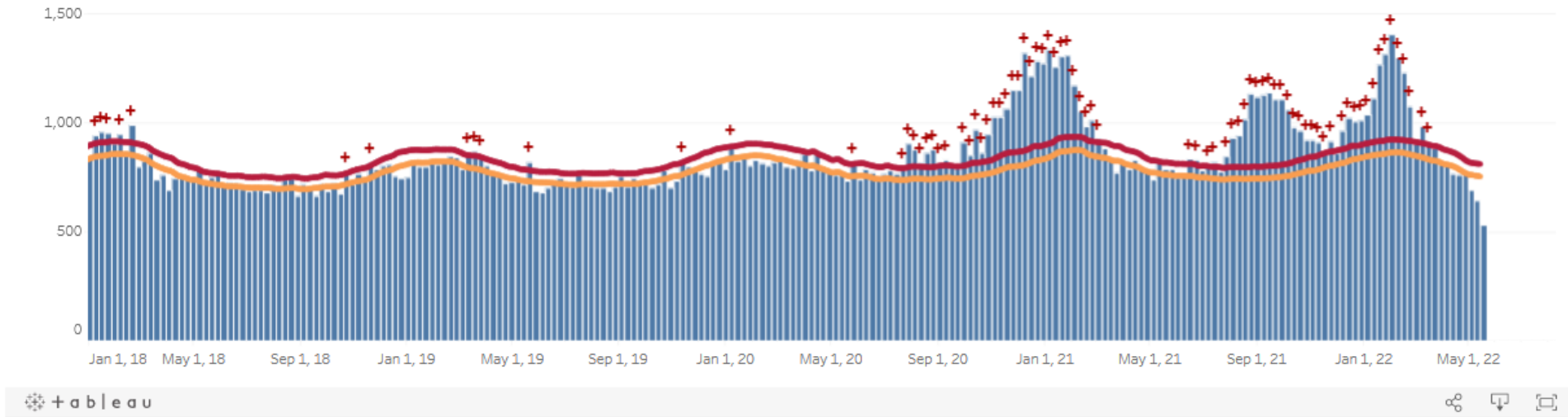
