Note on Newly Reported Deaths

On June 6, 2022 there was a nationwide, temporary pause in the processing of death certificate data while the National Vital Statistics System (NVSS) was undergoing a system-wide upgrade. These upgrades are now complete. However, there may still be a backlog of deaths being processed. The increase in deaths reported this week may be impacted by this pause in reporting.

1. Weekly case total is based on the number of cases with a symptom onset/specimen collection date in the given time frame. The cumulative total includes new cases as well as older cases identified as a result of delayed reporting.

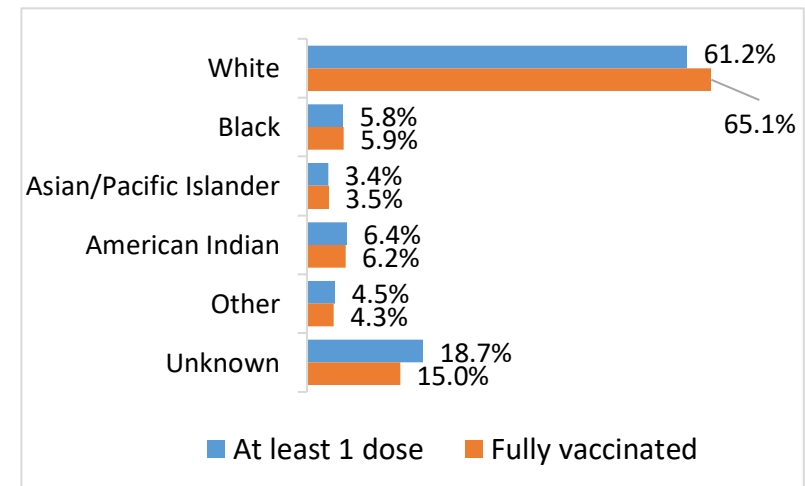
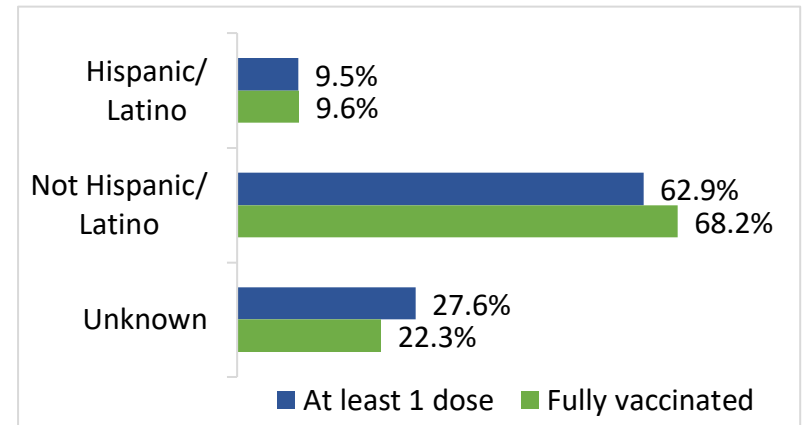
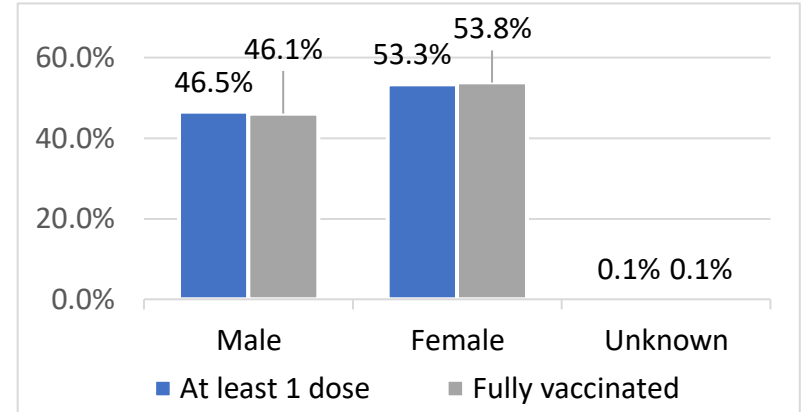
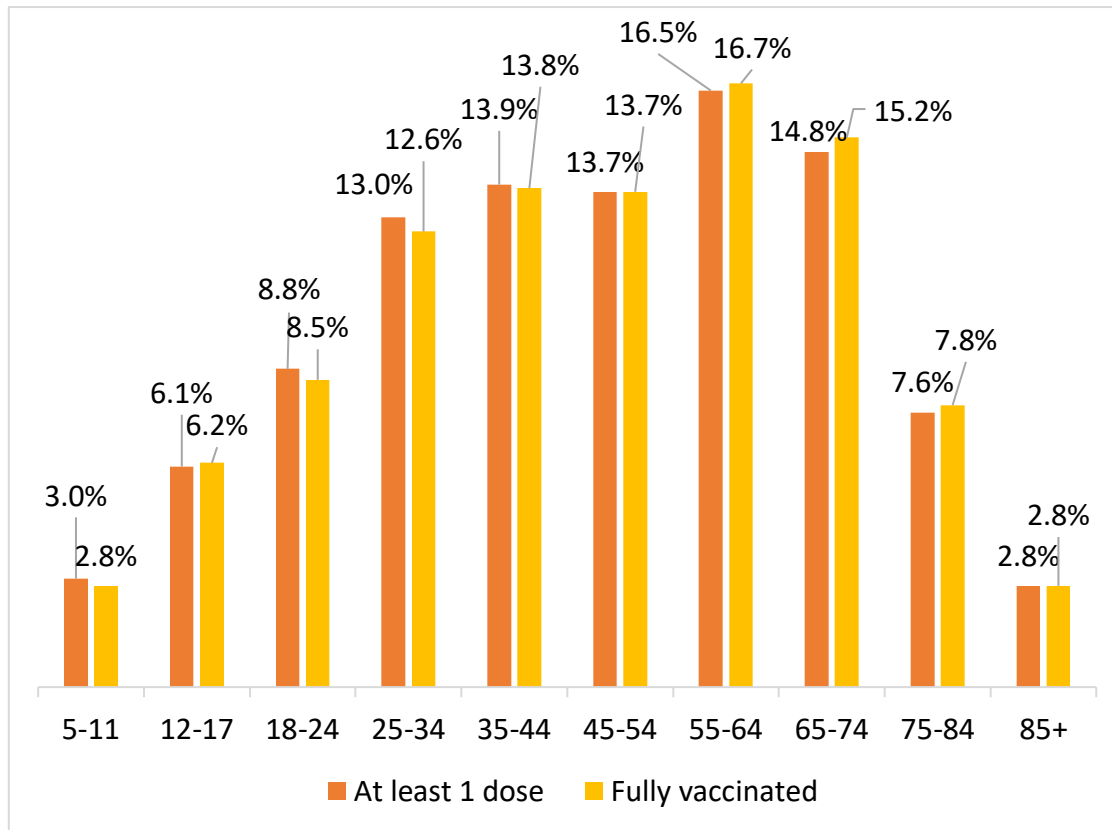

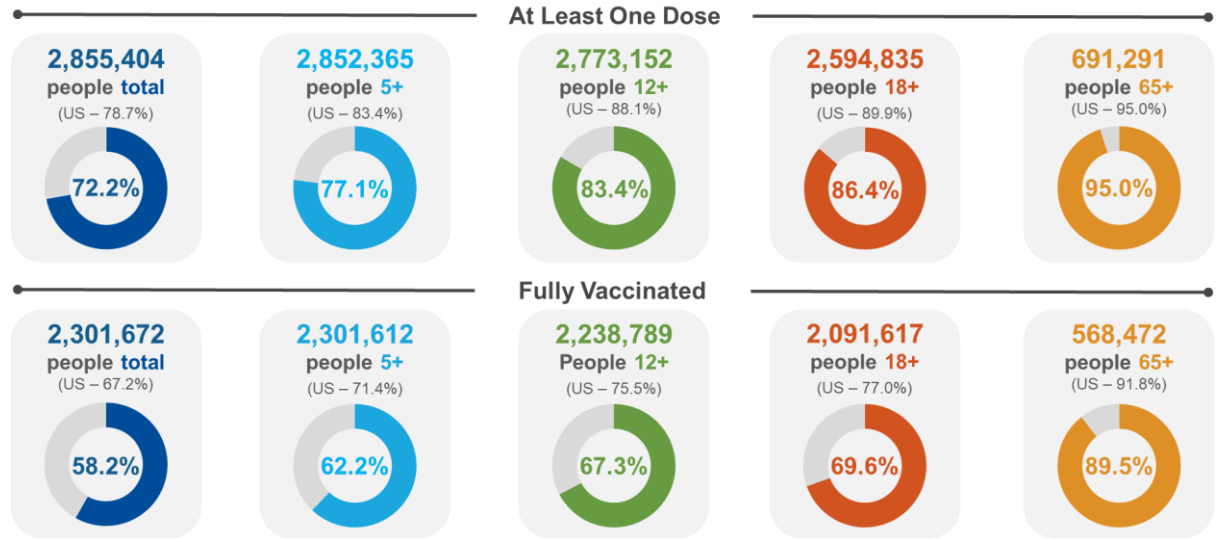

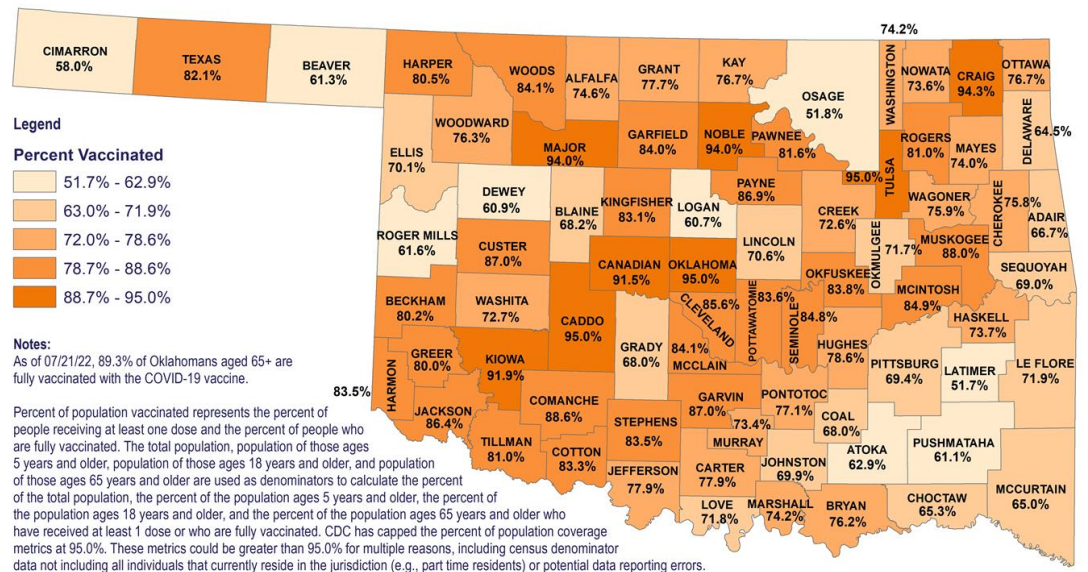

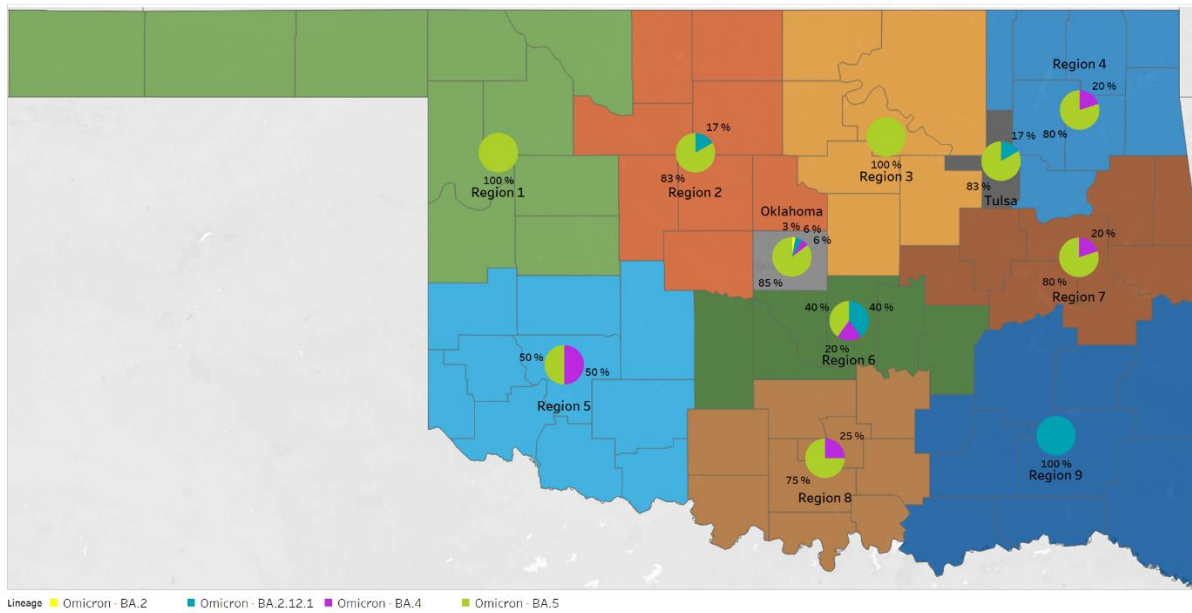

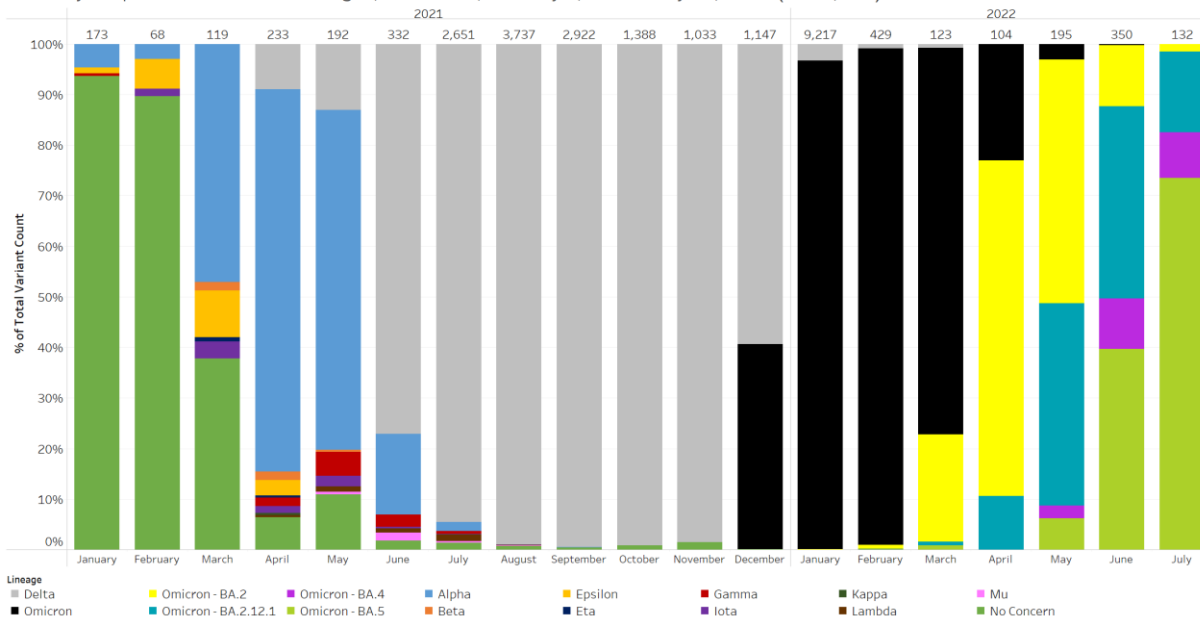
COVID-19 VARIANT STRAINS SEQUENCED*

Variant Proportions by Region, Dates of Specimen Collection: July 5, 2022 - July 14, 2022, (N=86):



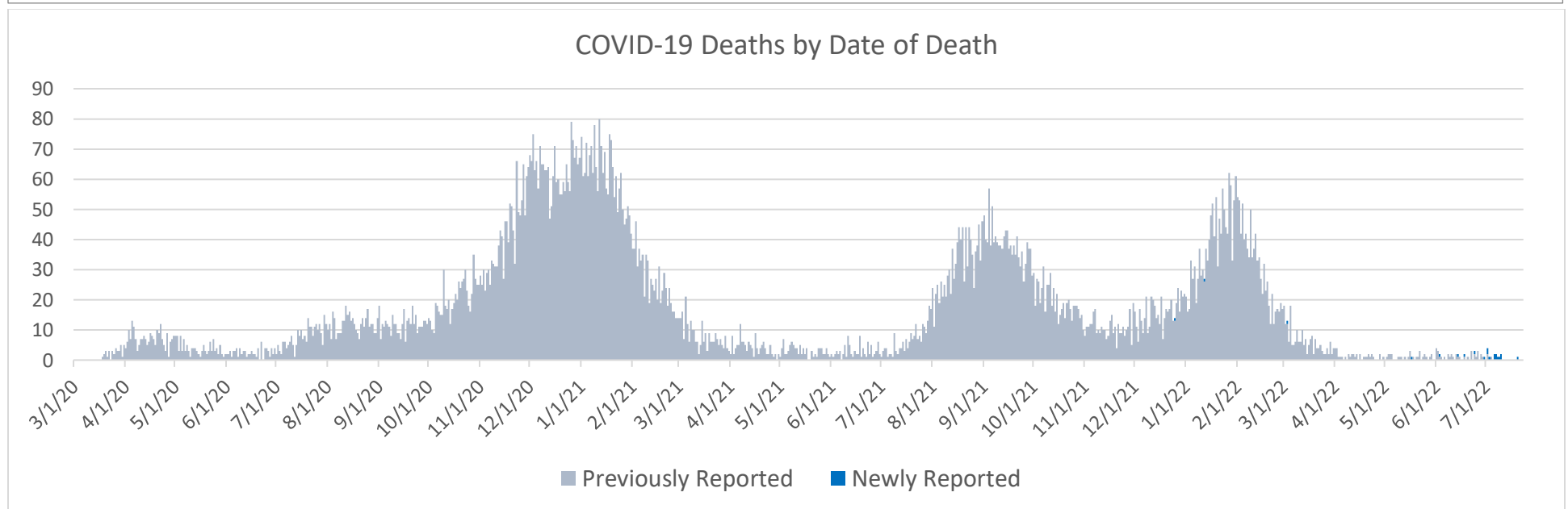
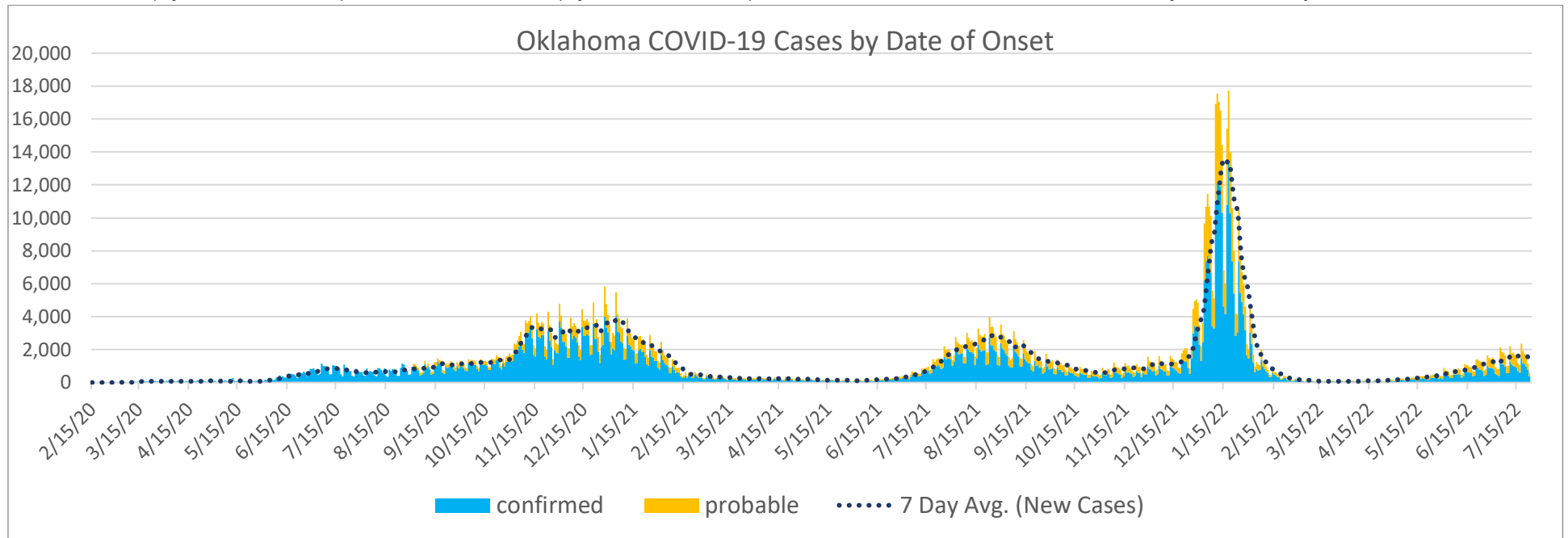

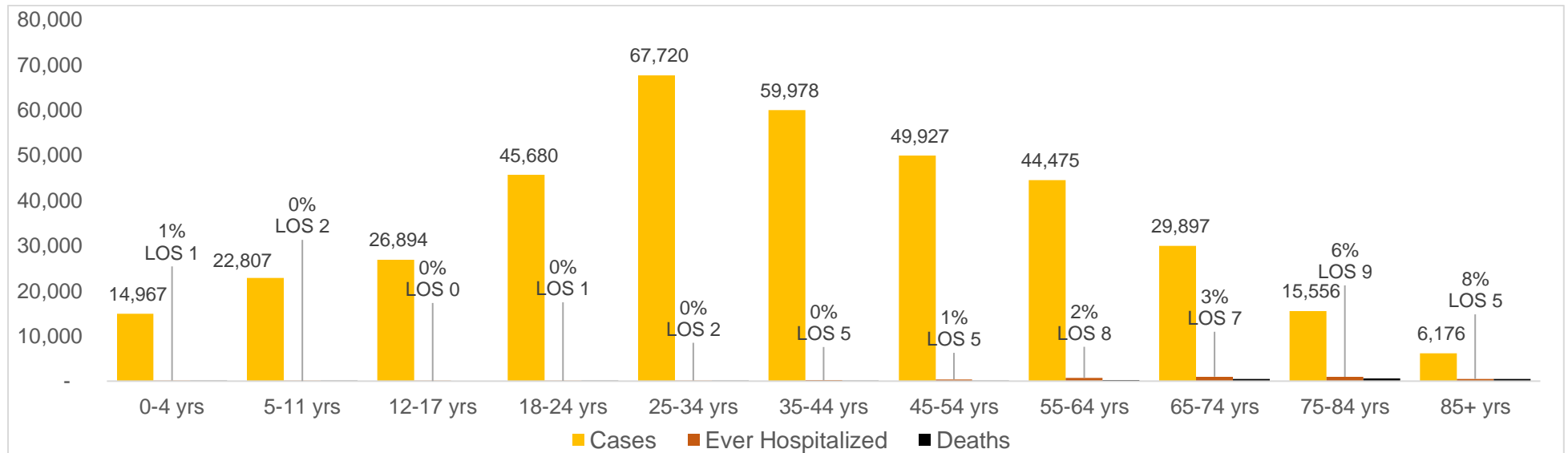

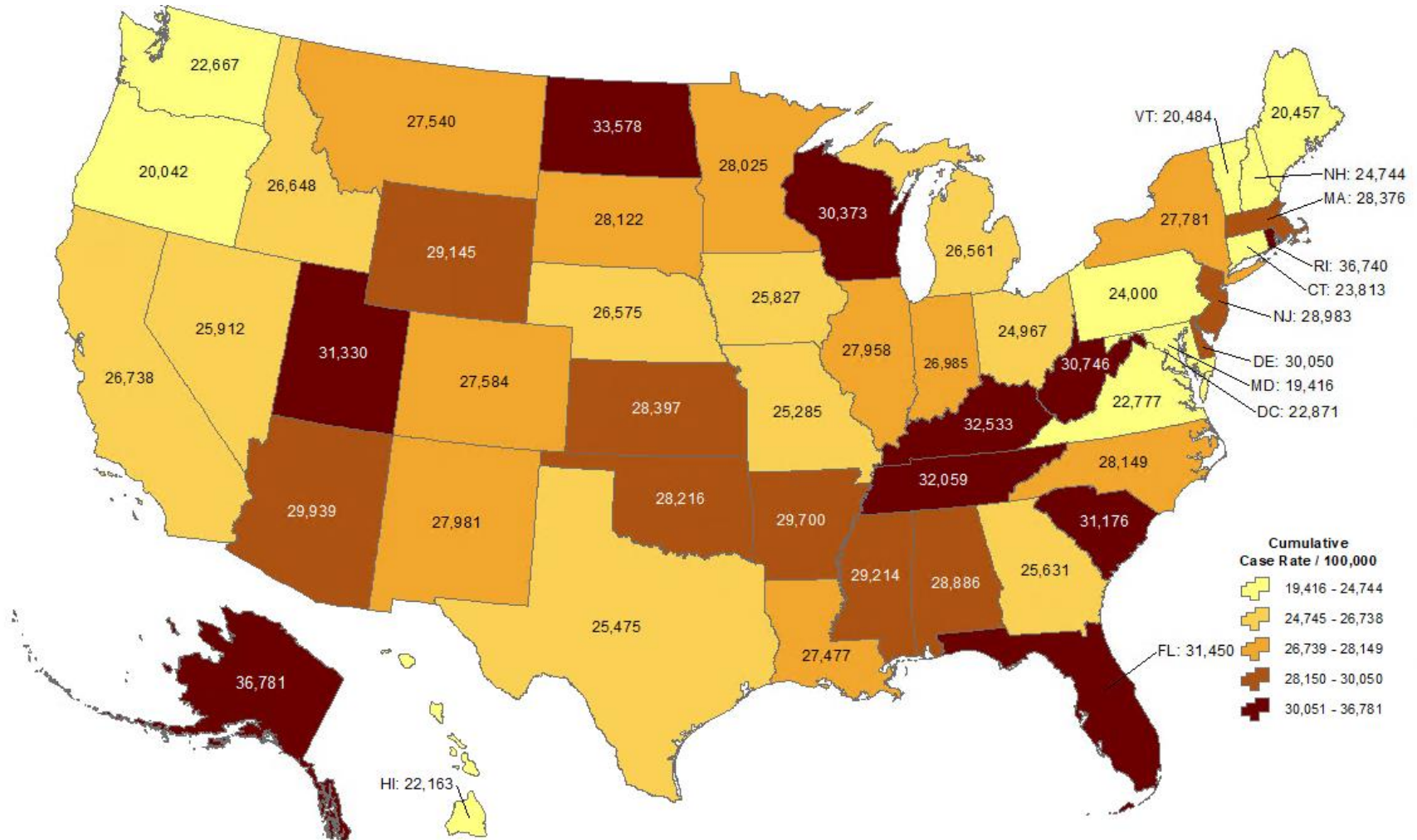

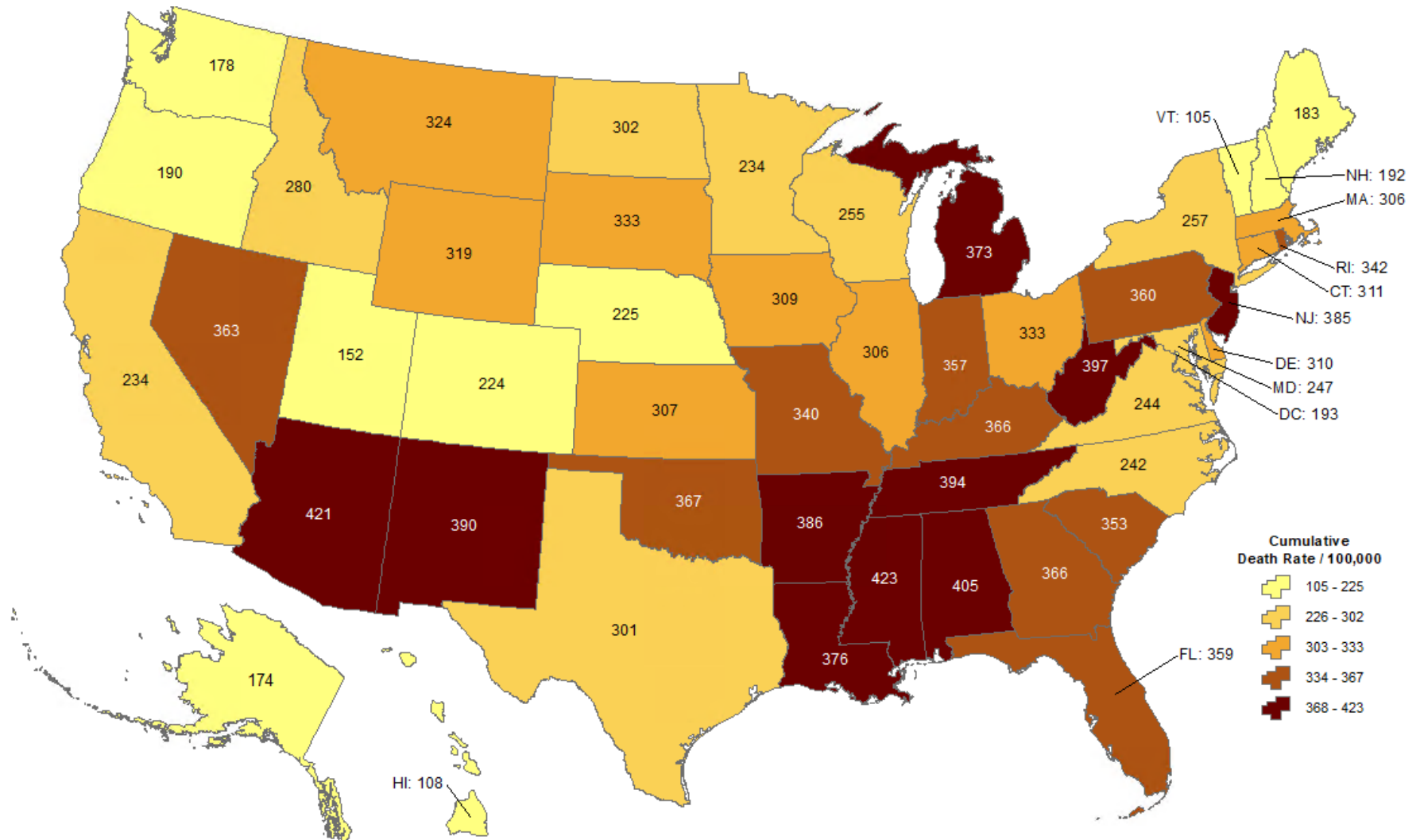

Cumulative death rate of reported COVID-19 cases

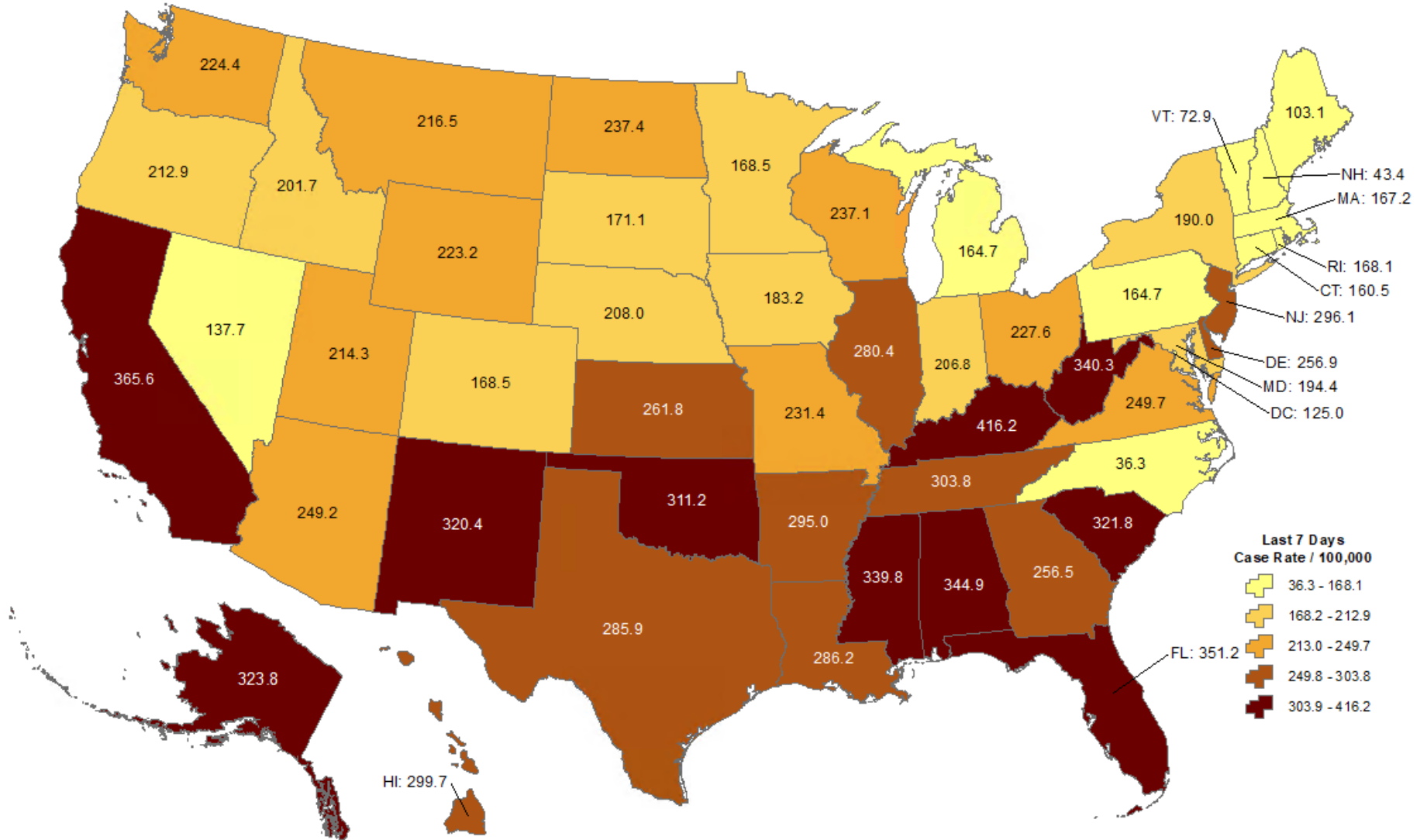

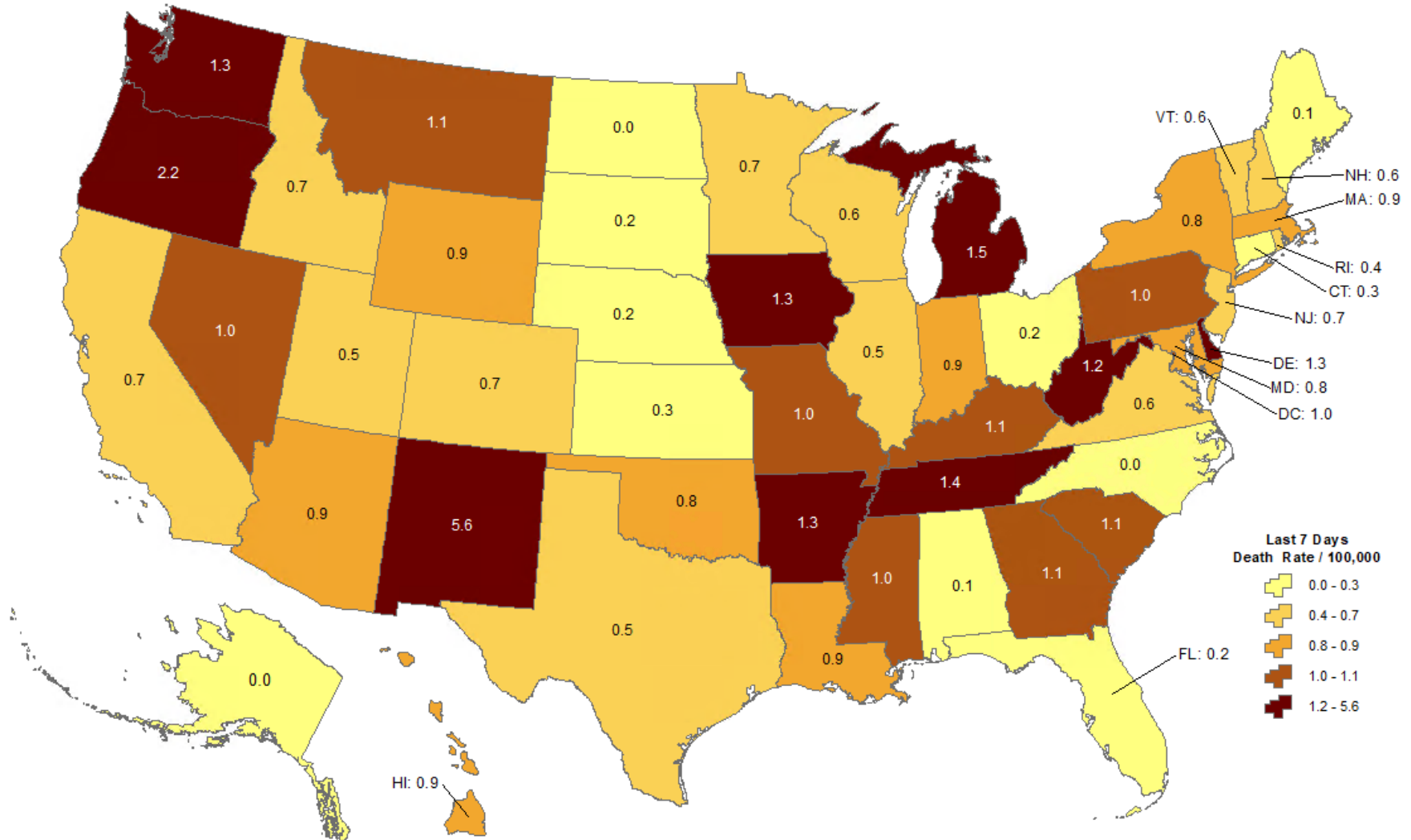

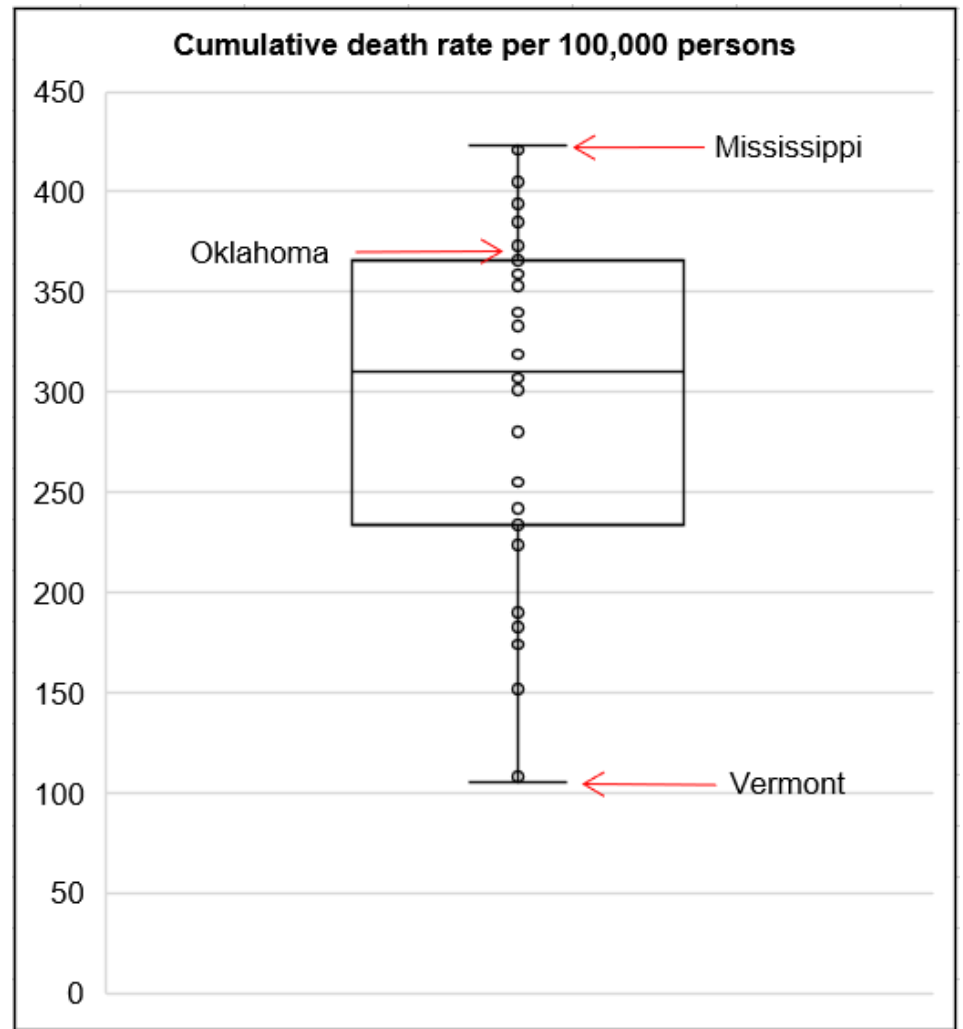
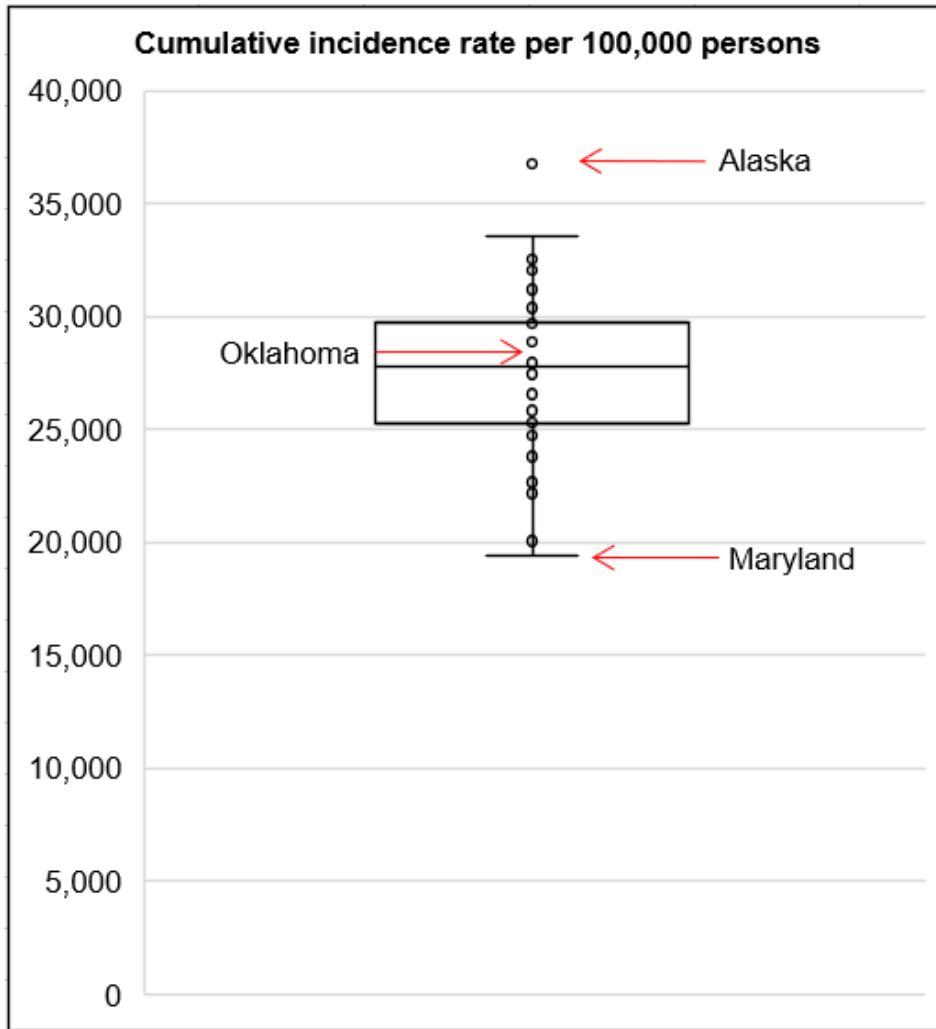

Weekly number of deaths (from all causes)

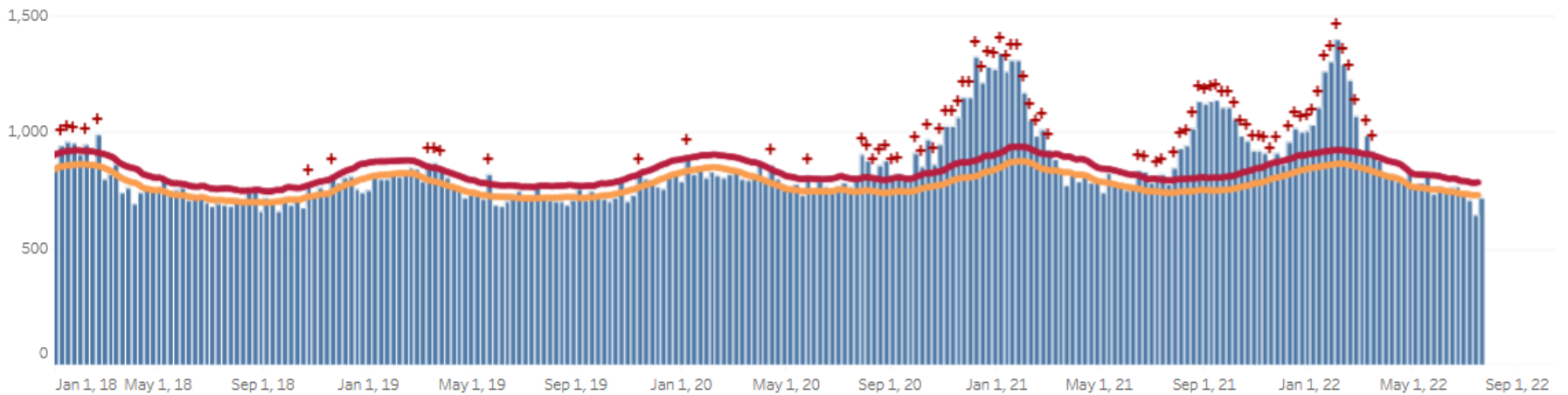
