Tobacco Regulations

The use of any tobacco or tobacco-like product on any and all properties owned, leased, or contracted for use by the Oklahoma Department of Corrections (ODOC), including but not limited to buildings, land and vehicles owned, leased, or contracted for use by agencies or instrumentalities of the department is prohibited. (5-ACI-3B-04M, 4-ACRS-1C-16M)

I. Definitions

A. <u>Tobacco-Free Environment</u>

An environment in which control measures are used to ensure public visitors, employees and inmates do not smoke and are not involuntarily exposed to second hand smoke or other tobacco products.

B. Tobacco-Like Products

All products associated with the use of any tobacco product, such as lighters, matches, pipes, electronic cigarettes, vapor producing devices, cigarette papers and imitation tobacco.

C. Smokeless

Tobacco that is chewed or snuffed rather than smoked by the user.

D. <u>Smoking</u>

The direct inhalation of tobacco smoke including the use or carrying by a person of a lighted cigar, cigarette, pipe or other lighted smoking or vapor-producing device.

II. Applicability (5-ACI-3B-04M, 4-ACRS-1C-16M)

This procedure applies to:

- 1. All employees, contract employees, service providers, volunteers and visitors:
- 2. All inmates confined in departmental facilities or facilities leased or contracted for use by the department;
- All state-owned property and buildings located on said property to include all grounds;
- 4. All areas of private prisons, county jails, halfway houses, and residential treatment facilities where ODOC inmates are housed as specified in the contract; and
- 5. All state-owned vehicles including vehicles used by prisoner public works contractors.

III. Specific Guidelines

A. <u>Prohibited Activities for All Facilities Owned, Contracted for Use, or Leased by the State of Oklahoma</u>

- Smoking, use of smokeless tobacco and/or tobacco-like products and possession of tobacco and/or tobacco-like products is prohibited, except as authorized by <u>OP-030112</u> entitled "Religious Services."
- Staff found to be in possession of tobacco and/or tobacco-like products will be referred to the Employee Assistance Program and/or subject to disciplinary action in accordance with <u>OP-110415</u> entitled "Progressive Disciplinary Procedures."
- Inmates found to be in possession of tobacco and/or tobacco-like products will be subject to behavior modification intermediate sanctions as established by the facility head and/or disciplinary action in accordance with <u>OP-060125</u> entitled "Inmate/Offender Disciplinary Procedures."
- 4. Canteens will offer smoking cessation products (e.g., nicotine patches). The cost of smoking cessation products will not be counted

against the inmate's weekly draw amount, and will be provided at cost, with no canteen markup.

B. State Vehicles

The use of tobacco or tobacco-like products of any kind is prohibited in all state-owned vehicles.

C. <u>Leased Space</u>

ODOC employees who occupy offices in leased space in buildings that have other offices leased to businesses/organizations that are not state agencies will be tobacco-free for the parts of the property that are under ODOC control. For shared and common areas not under the agency's control, employees at these locations will comply with all regulations governing smoking and the use of tobacco and "tobacco-like" products as designated by the building proprietor. (5-ACI-3B-04M, 4-ACRS-1C-16M)

D. <u>Non State-Owned Facilities Housing ODOC Inmates</u>

All areas of private prisons, county jails, residential treatment facilities and halfway houses where ODOC inmates are housed will be tobacco-free in accordance with this procedure.

E. Signage

Appropriate signage provided by Oklahoma Correctional Industries (OCI) stating the tobacco restrictions will be placed at all entrances to state-owned property and at standard locations at the facility/unit as directed by the facility/unit head.
