STATE QUESTION NO. 319

LEGISLATIVE REFERENDUM NO. 91

Submitted by Senate Joint Resolution No. 8, page 484, Session Laws 1945.

The gist of the proposition is as follows:

Shall a proposed amendment to Section 9, Article 10, Oklahoma Constitution, providing that upon certification of the need therefor by the governing board, an additional levy of not to exceed one mill on the dollar valuation on any property within the county shall be levied by the excise board, the proceeds therefrom to be used exclusively for the purchase of equipment, acquisition of sites and erection of buildings for separate schools for which and negro children, be approved by the people?

STATE QUESTION NO. 314

INITIATIVE PETITION NO. 224

The gist of the proposition is as follows:

Shall a proposed amendment to Section 9, Article X, Oklahoma Constitution, providing that the annual ad valorem tax rate for school purposes may be increased, in any school district; by not to exceed fifteen (15) mills on the dollar valuation, upon all property therein, if a majority of the qualified voters of such district voting at an election, vote for such increase, be approved by the people?
