CONTEST OF CANDIDACY

Comes now Robert D. Johnson, by and through his counsel, Robert G. McCampbell, and alleges and states as follows:

1. Darrick Ross Matthews has filed a Declaration of Candidacy in the Special Election for Senate District 22.

2. Robert D. Johnson has also filed a Declaration of Candidacy in the Special Election for Senate District 22. Mr. Johnson files this petition to contest the candidacy of Mr. Matthews pursuant to 26 O.S. 5-118.

3. One of the requirements to be a candidate for Senate is that the candidate must have been a registered voter in the district for the six months immediately preceding filing for office. Specifically, **“A person must have been a registered voter in the district and a resident residing within such district for the six month period immediately preceding the first day of the filing period”** 14 O.S. § 80.8, emphasis added.

4. Mr. Matthews was not a registered voter in Senate District 22 for the six-month period immediately preceding the first day of the filing period, which was December 7.

5. Mr. Matthews is therefore ineligible and should be stricken from the ballot.

6. Exhibit A attached is a copy of certified records of the Oklahoma County Election Board.

7. The certified records of the Oklahoma County Election Board show as follows:

- (a) Beginning on August 31, 2018, Mr. Matthews was registered to vote at 21321 Highlander Ridge Dr., in Edmond, Oklahoma. That address is within Senate District 22.
- (b) On November 4, 2020, Mr. Matthews changed his registration so that he was registered to vote at 1400 Autumn Creek Dr., Edmond, Oklahoma. That address is not within Senate District 22, but is within Senate District 41.
- (c) Ten days later, on November 14, 2020, Mr. Matthews changed his voter registration back to 21321 Highlander Ridge Dr., Edmond, Oklahoma.

8. For the period November 4 to November 14, 2020, Mr. Matthews was not a registered voter in Senate District 22.

CONCLUSION

Because Mr. Matthews cannot meet the requirement of 14 O.S. § 80.8 of being registered to vote in the district for the previous six months, his name should be stricken from the ballot.

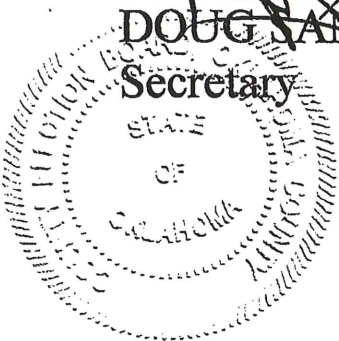

Robert D. Johnson maintains a homestead in Senate District 47, outside of Senate District 22. Mr. Johnson claimed the Homestead Exemption for this tax year 2020 outside of the district. Further, Mr. Johnson filed as a lobbyist at the above homestead, represented to the Oklahoma Bar Association that he resides at the homestead, and the published address in his parish's directory is the homestead outside of SD-22.

Mr. Johnson's wife, Colleen, is registered at the address in SD-47, while he is registered to vote at a home he sold in 2018 and no longer resides.

Mr. Johnson's Declaration of Candidacy lists a residence that differs from where he claimed domicile in 2020 and different than his voter registration. The evidence overwhelmingly suggests that Mr. Johnson does not live in SD-22, but rather SD-47. As such, his candidacy must be denied.

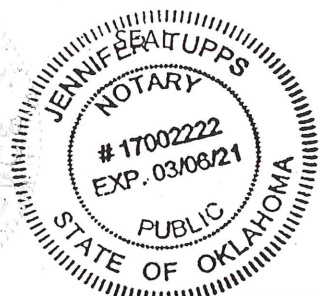
