April 6, 2015

The State Election Board met in a Regular meeting at 3:00 p.m. in Room B-6 of the State Capitol Building. Advance notice of the meeting was performed by filing a written notice with the Secretary of State on November 21, 2014, at 2:08 p.m. A copy of the agenda is attached.

BUSINESS CONDUCTED AT THE MEETING

1. **BUSINESS CONDUCTED:** Elect Chairman and Vice-Chairman, pursuant to the provisions of 26 O.S. § 2-101.7.

1A. **ACTION TAKEN:** Mr. Montgomery moved to elect Steve Curry as the Chairman of the Oklahoma State Election Board. Dr. Mauldin seconded the motion. **ROLL CALL VOTE:** Mr. Curry-aye; Mr. Montgomery-aye; Dr. Mauldin-aye. Motion passed, 3-0.

1B. **ACTION TAKEN:** Mr. Curry moved to elect Thomas Montgomery as the Vice-Chairman of the Oklahoma State Election Board. Dr. Mauldin seconded the motion. **ROLL CALL VOTE:** Mr. Curry-aye; Mr. Montgomery-aye; Dr. Mauldin-aye. Motion passed, 3-0.

At this point, Mr. Ziriaux passed the gavel to Chairman Curry.

ACTION TAKEN: Dr. Mauldin moved that the State Election Board approve the list of Democrat County Election Board members and alternates in 20 counties for four-year terms beginning May 1, 2015, and ending April 30, 2019, as submitted, pursuant to the provisions of 26 O.S. § 2-111, for Alfalfa, Atoka, Bryan, Canadian, Cleveland, Comanche, Creek, Dewey, Greer, Harper, Love, McClain, Muskogee, Nowata, Oklahoma, Okmulgee, Pittsburg, Pontotoc, Pottawatomie, and Texas Counties. Mr. Montgomery seconded the motion. **ROLL CALL VOTE:** Mr. Curry-aye; Mr. Montgomery-aye; Dr. Mauldin-aye. Motion passed, 3-0. (List attached)
