May 12, 2020

The State Election Board met in a Virtual Special meeting at 4:00 P.M. in Room G41 (SEB Multipurpose Room), Jim Thorpe Building, S.W. of the State Capitol Building, 2101 N. Lincoln Blvd., Oklahoma City, OK 73105. This Special meeting was held consistent with the amendments to the Open Meeting Act, 25 O.S. 2011, § 301 et seq., signed into law by Gov. J. Kevin Stitt on Wednesday, March 18, 2020. See Senate Bill No. 661, 2020 O.S.L 3, § 3. 


