## **EXECUTIVE SUMMARY**

### **INTRODUCTION**

Pursuant to [26 O.S. § 3-130](#), State Election Board Secretary Paul Ziriak directed all seventy-seven (77) county election boards to conduct post-election manual tabulation audits of the General Election held on Tuesday, November 8, 2022.

The post-election audits were conducted November 29-30, 2022, and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit in advance. Additionally, the State Election Board notified the public about the upcoming post-election audits on its website and through the State Election Board's electronic news delivery system.

The post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board. Each post-election audit included a manual tabulation of votes cast in each race that was audited.

Participating precincts and races were randomly selected for the post-election audits. Additionally, the results of a candidate-requested recount of the November 8, 2022, election is also included in this report.

**The post-election audits of the 2022 General Election confirmed the outcomes of the races that were audited.** A total of 108 manual post-election tabulation audits were conducted, and 106 of these identified zero differences compared to the certified election results. Two of the audits identified minor differences compared to the certified election results; however, these would not have impacted the outcome of the election. ## **RECOUNTS**

Following the General Election held on November 8, 2022, one candidate-requested hand recount was conducted by the Tulsa County Election Board.

Results of the recount for the City of Tulsa, City Council, District 5 race confirmed that the petitioner won the election; however, minor changes in vote totals occurred as a result of the recount.

The manual post-election audit completed in Harper County of Election Day ballots in Precinct 300402 confirmed the certified count for United States Senator for the General Election. However, the audit revealed that two provisional ballots cast on Election Day were incorrectly categorized as mail absentee votes for Precinct 300402, rather than being included in the Election Day tally for Precinct 300402. Provisional ballots were counted on Friday, November 11, 2022.

Refresher training will be provided to county election board personnel to ensure proper procedures are followed in the future.

**County:** Johnston

**Audit Date:** 11/29/2022

During the post-election audit completed in Johnston County, it was discovered that one ballot was missing from the sealed transfer case containing Election Day ballots for Precinct 350012. The Secretary of the County Election Board ordered the ballots to be counted multiple times by three different auditors to confirm that the ballot was missing. The Inspector for Precinct 350012 was subsequently interviewed by the Secretary. A thorough search of the polling place was then conducted by the Inspector. Additionally, county election board personnel searched the receptacles for election supplies and materials that had been returned by the Inspector on the night of the election. The ballot was not located as a result of the searches.

While the ballot was not recovered, there appears to be no evidence of intentional wrongdoing by the precinct officials. The most likely explanation is that the precinct officials failed to properly secure the ballot in the transfer case after the polls closed.

The County Election Board Secretary will provide refresher training to the precinct officials to ensure proper procedures are followed in the future.

The post-election audit completed in Okmulgee County of Election Day ballots in Precinct 560020 revealed that one ballot recorded by the voting device as an "undervote" should have been recorded as a vote for candidate Margaret Warigia Bowman (DEM) – one more than the certified total. Three manual audits and one electronic audit confirmed the count difference.

This difference was likely the result of a voter placing an "I Voted" sticker on the ballot, which caused it to jam in the scanner. The sticker likely obscured the voting target for that race, resulting in it being recorded as an "undervote." The Secretary of the County Election Board was called to the polling place by precinct officials to repair the device after normal procedures did not clear the voter-caused paper jam. The Secretary remained at the polling place for a period of time following the repair to monitor the scanning of ballots to ensure the voting device was functioning properly.

**BACKGROUND**

The Secretary of the State Election Board ordered the inclusion of the results of the official recount by the Tulsa County Election Board of the City of Tulsa, City Council, District 5 race as part of the Post-Election Audit Report for the November 8 General Election. This non-partisan race included two candidates: Grant Miller and Mykey Arthrell.

**SUMMARY**

The Tulsa County Election Board conducted the recount on November 14, 2022, at the request of Miller. The manual recount included in-person absentee ballots, mail absentee ballots, and the ballots from eighteen (18) Election Day precincts. The recount confirmed the results of the election; however, it resulted in Miller losing one vote and Arthrell gaining two votes. Miller won by a margin of 24 votes, instead of the 27 votes originally reported following the election. A summary of the results can be found below:

**SUMMARY**

The Secretary of the Rogers County Election Board conducted a manual post-election audit of the Superintendent of Public Instruction race for Precinct 660023 on November 29, 2022, only to discover it was the incorrect race to be audited. The error, however, was quickly noted by the Secretary and an audit of the State Treasurer race for Precinct 660023 – the correct race – was immediately conducted. Results of both audits were reported to the State Election Board.

While the Superintendent of Public Instruction race in Precinct 660023 was not scheduled to be audited, the audit, nevertheless, confirmed the certified election results with zero differences reported. The results of this “additional” post-election audit can be found below:
