EXECUTIVE SUMMARY

INTRODUCTION

Pursuant to [26 O.S. § 3-130](#), State Election Board Secretary Paul Ziriaux directed all seventy-seven (77) county election boards to conduct post-election manual tabulation audits of the March 7, 2023 State Question Special Election.

The post-election audits were conducted during the period of Monday, May 22, 2023 through Thursday, May 25, 2023, and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance.

The post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board.

All seventy-seven counties were selected for the post-election audits of State Question 820; however, participating precincts were randomly selected. No additional audits of races or propositions were conducted.

The post-election tabulation audits confirmed the certified election results, with the results from each audit matching the certified vote totals.
