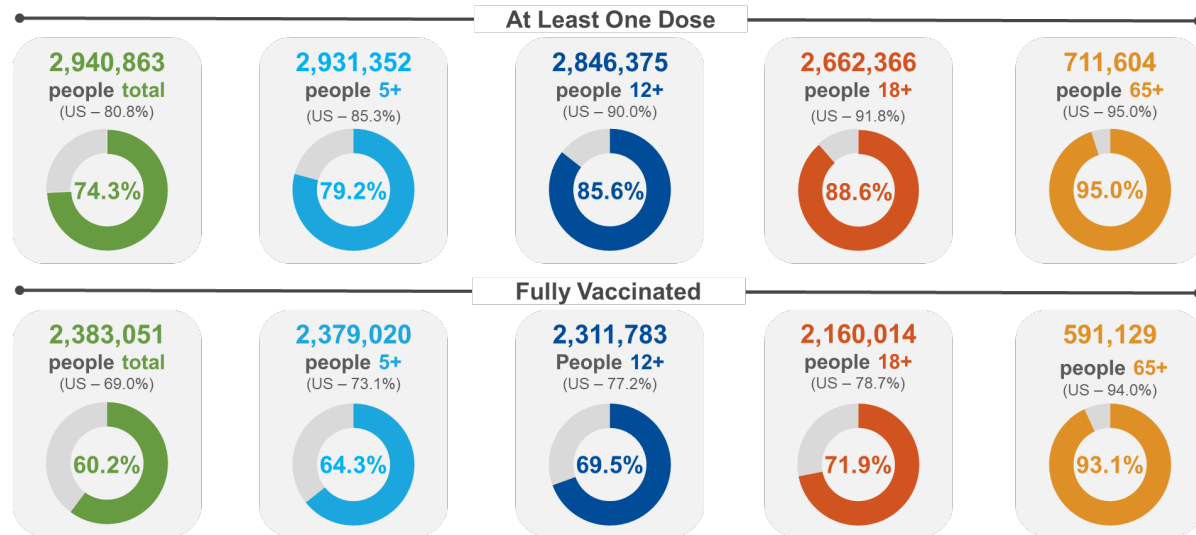

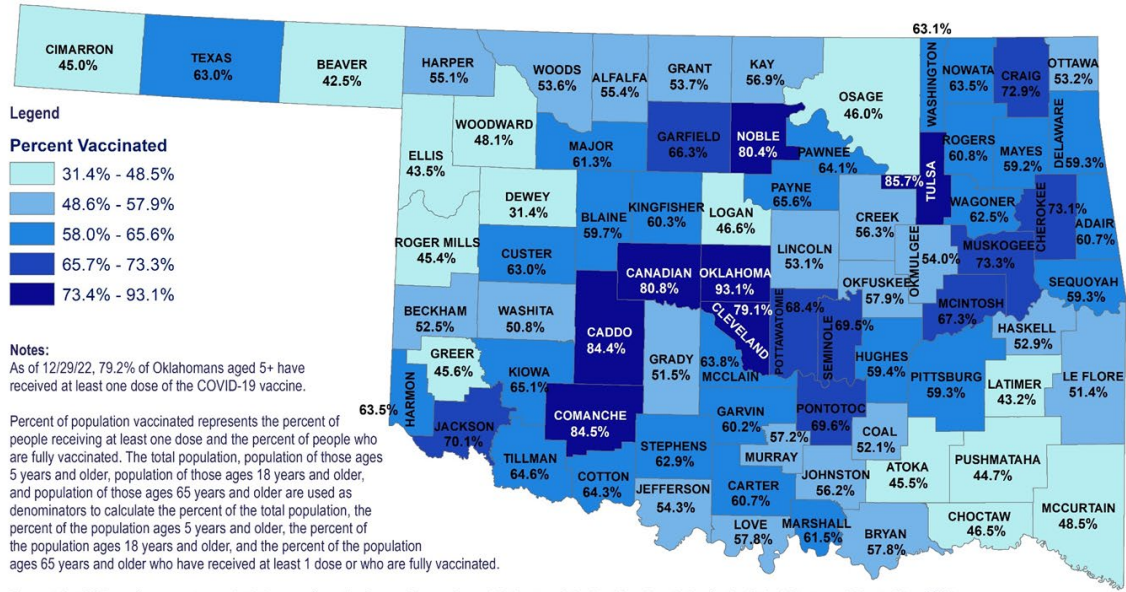

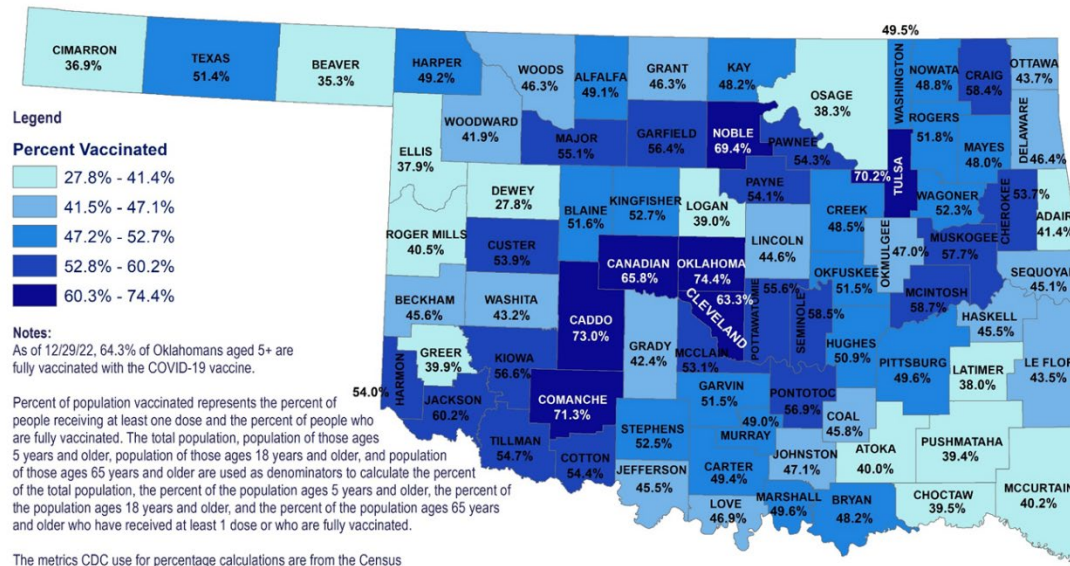

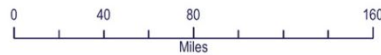

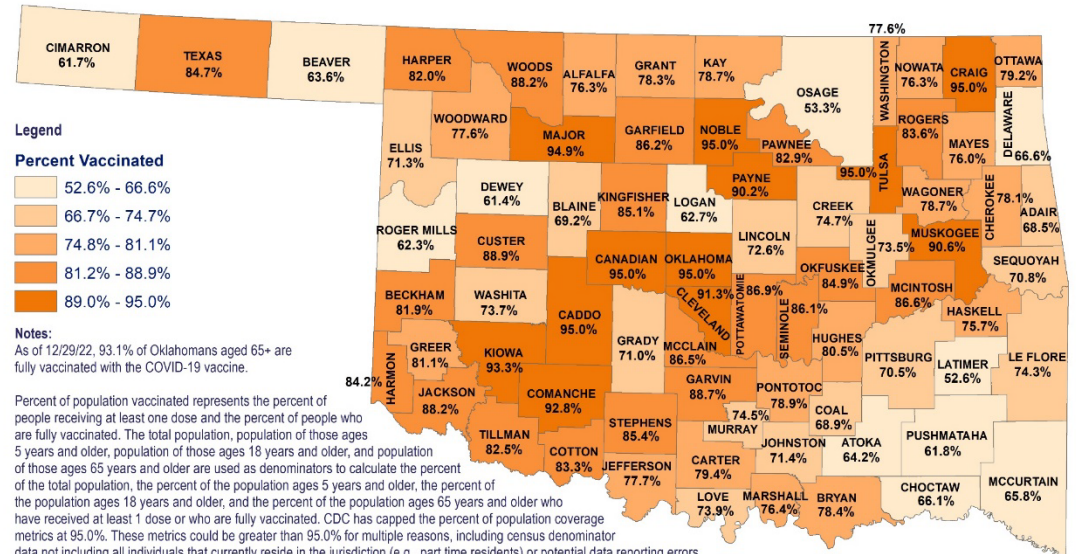

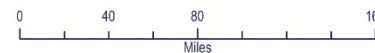

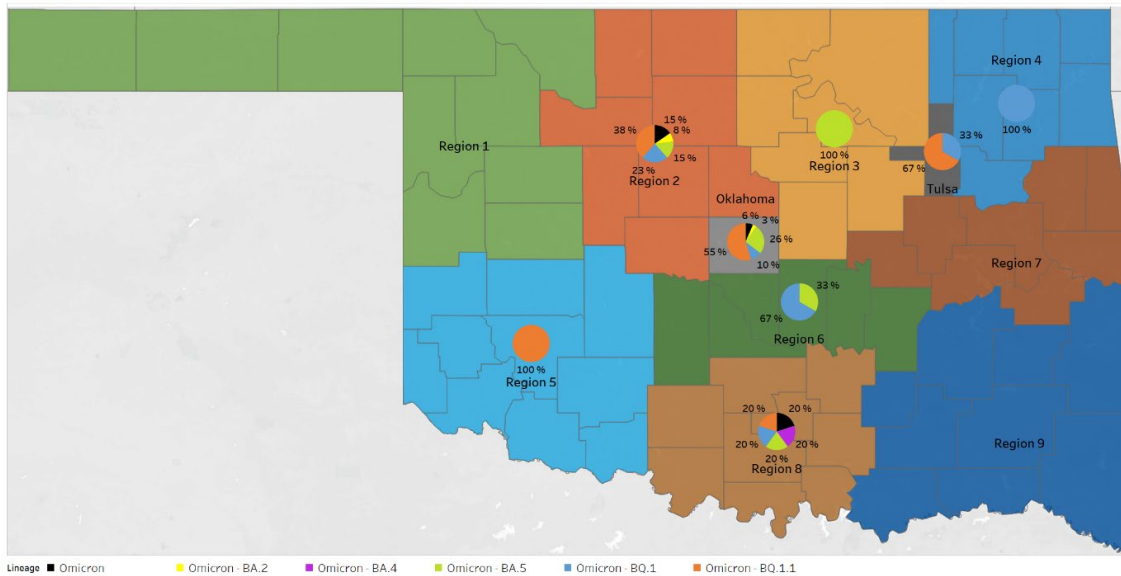

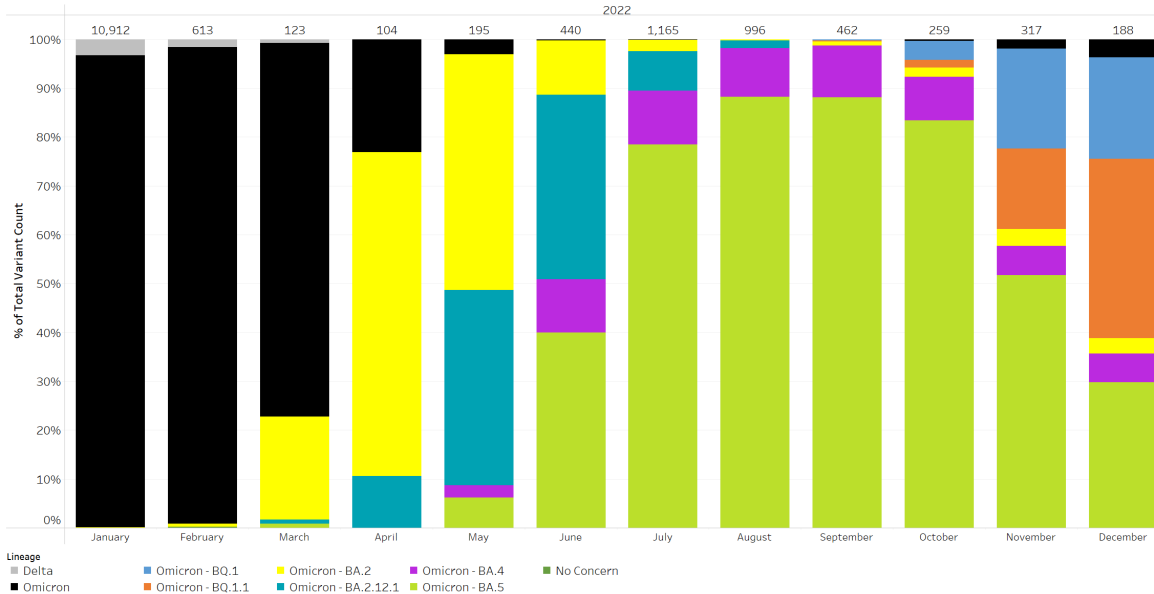
Variant Proportions by Region, Dates of Specimen Collection: December 7, 2022 - December 16, 2022, (N=62):

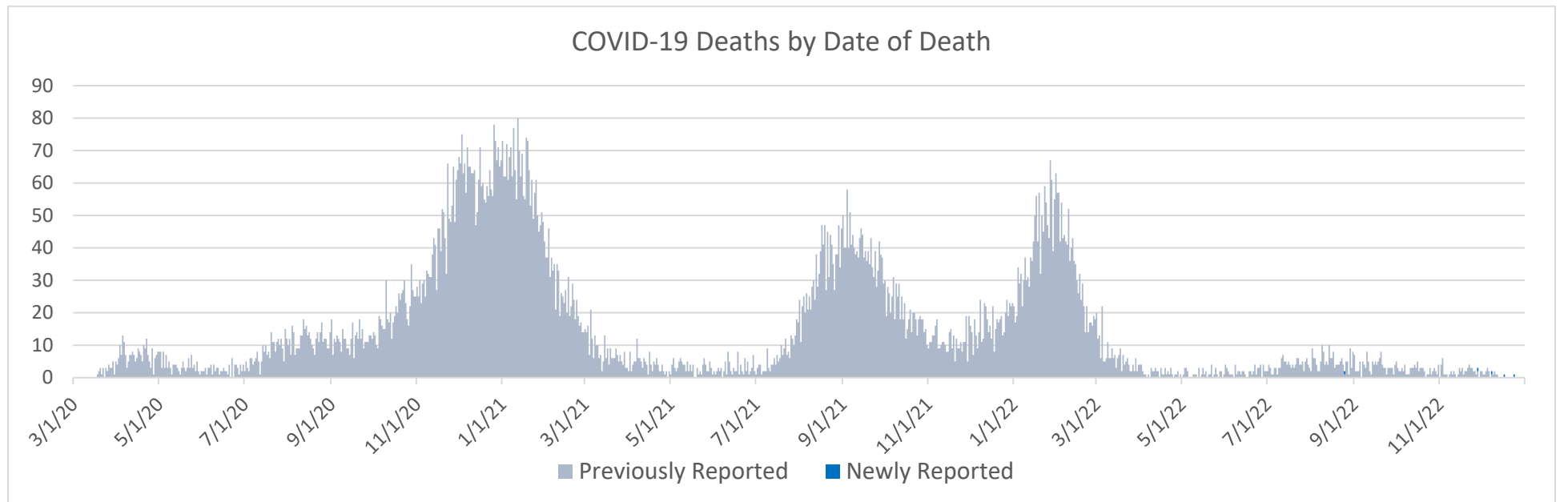
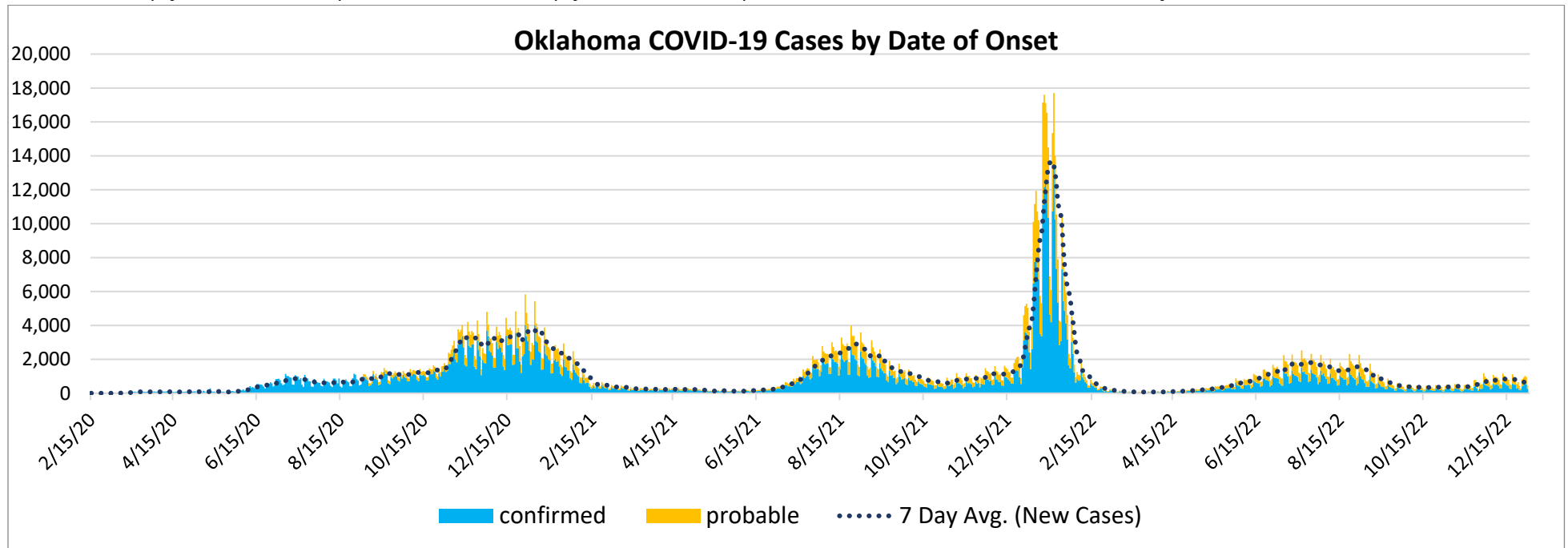
Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - January 3, 2023 (N=15,774)

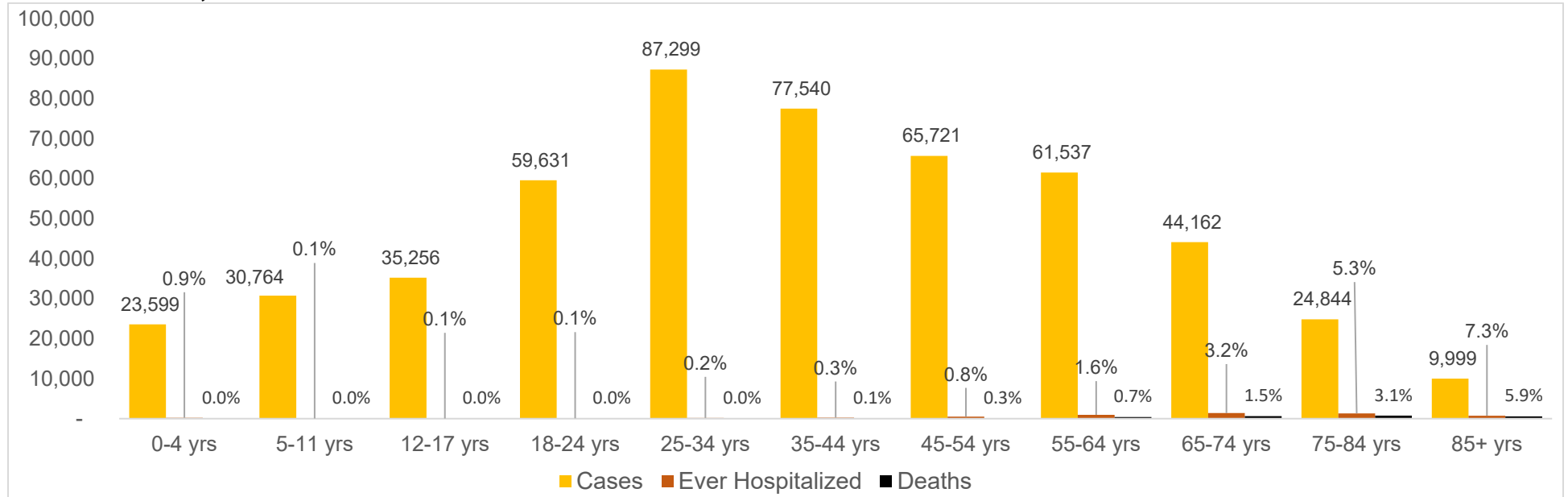

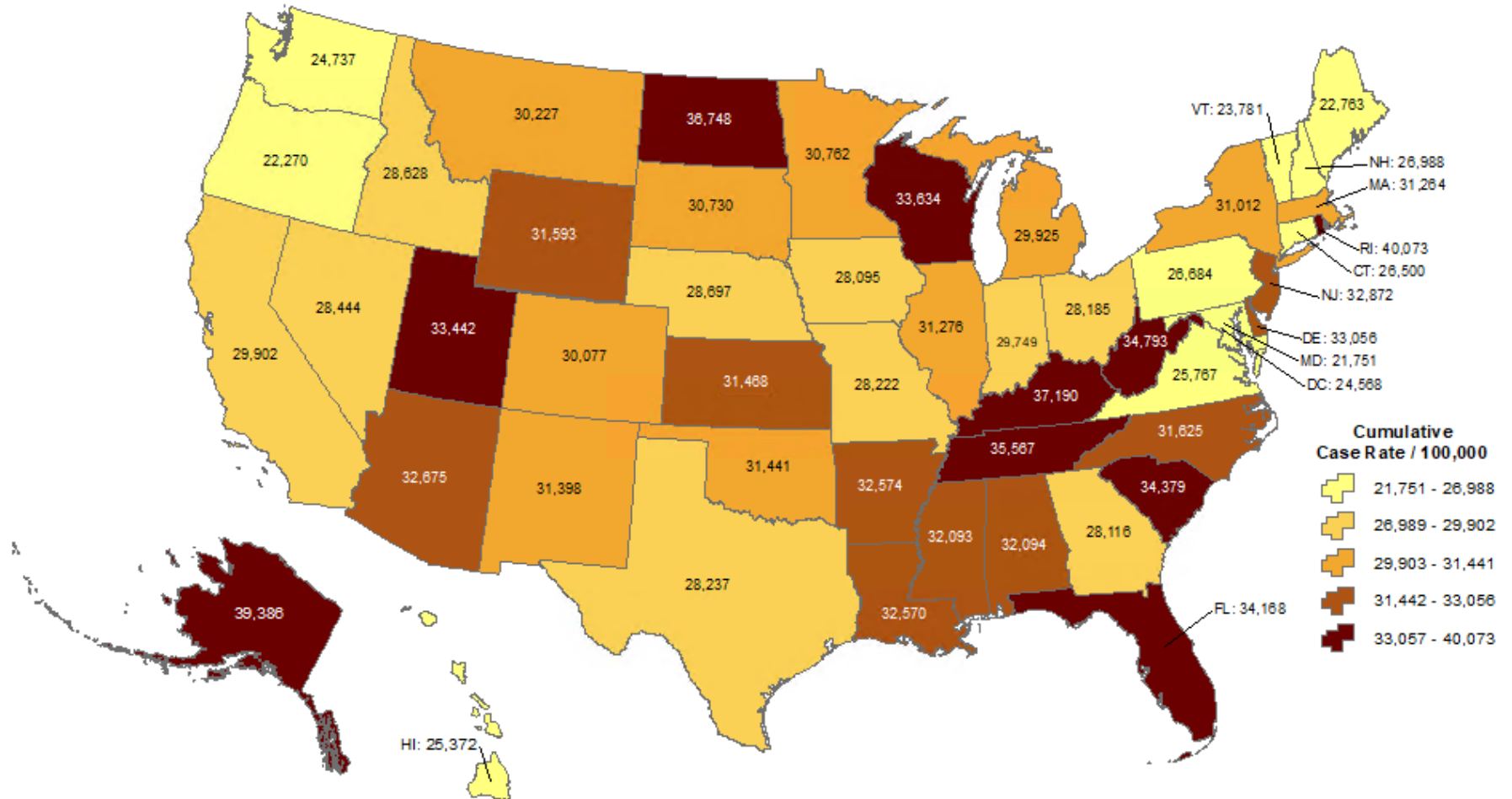
2022 CASES, PERCENT HOSPITALIZED AND DEATHS BY AGE GROUP

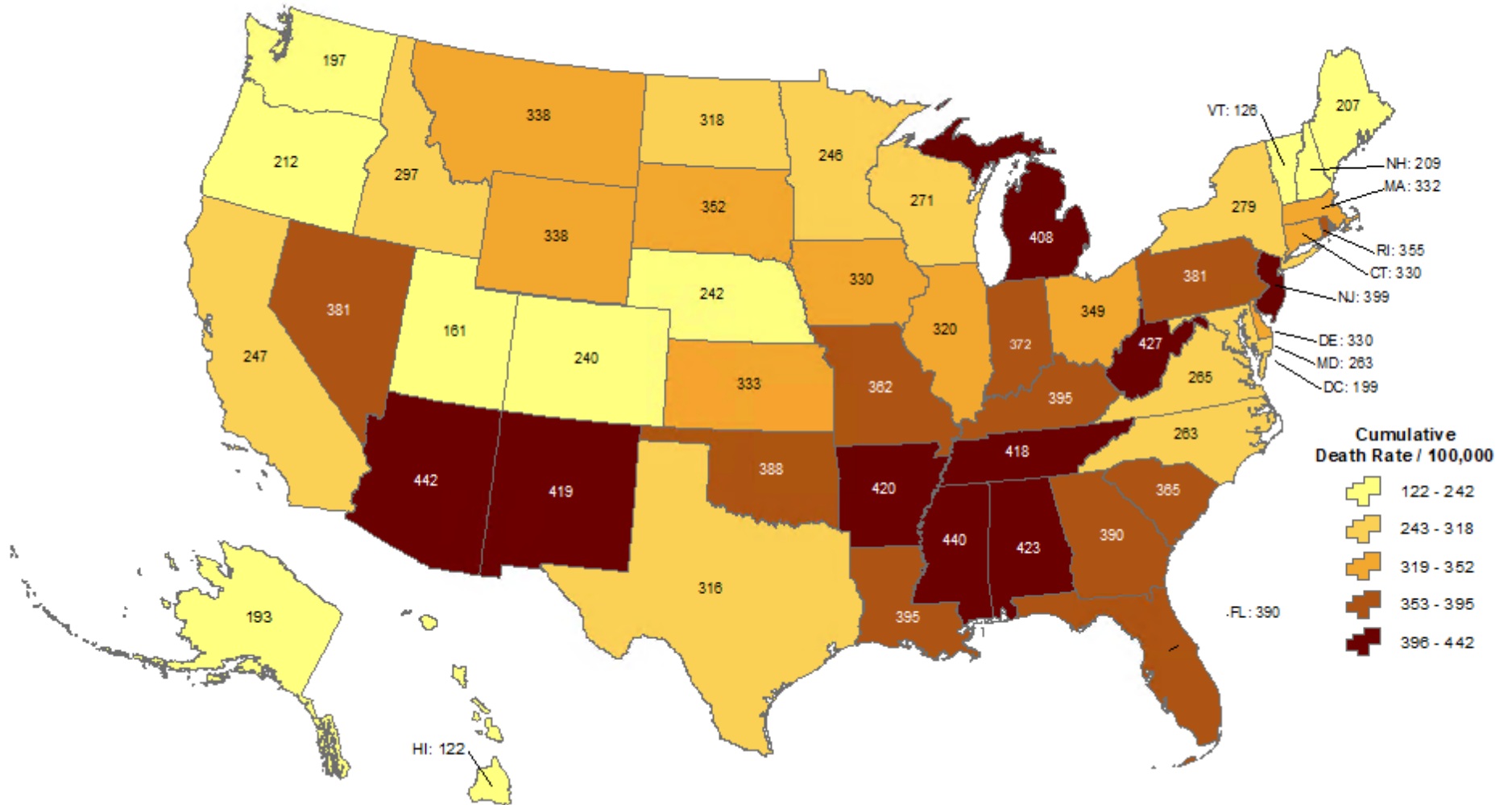

Cumulative death rate of reported COVID-19 cases

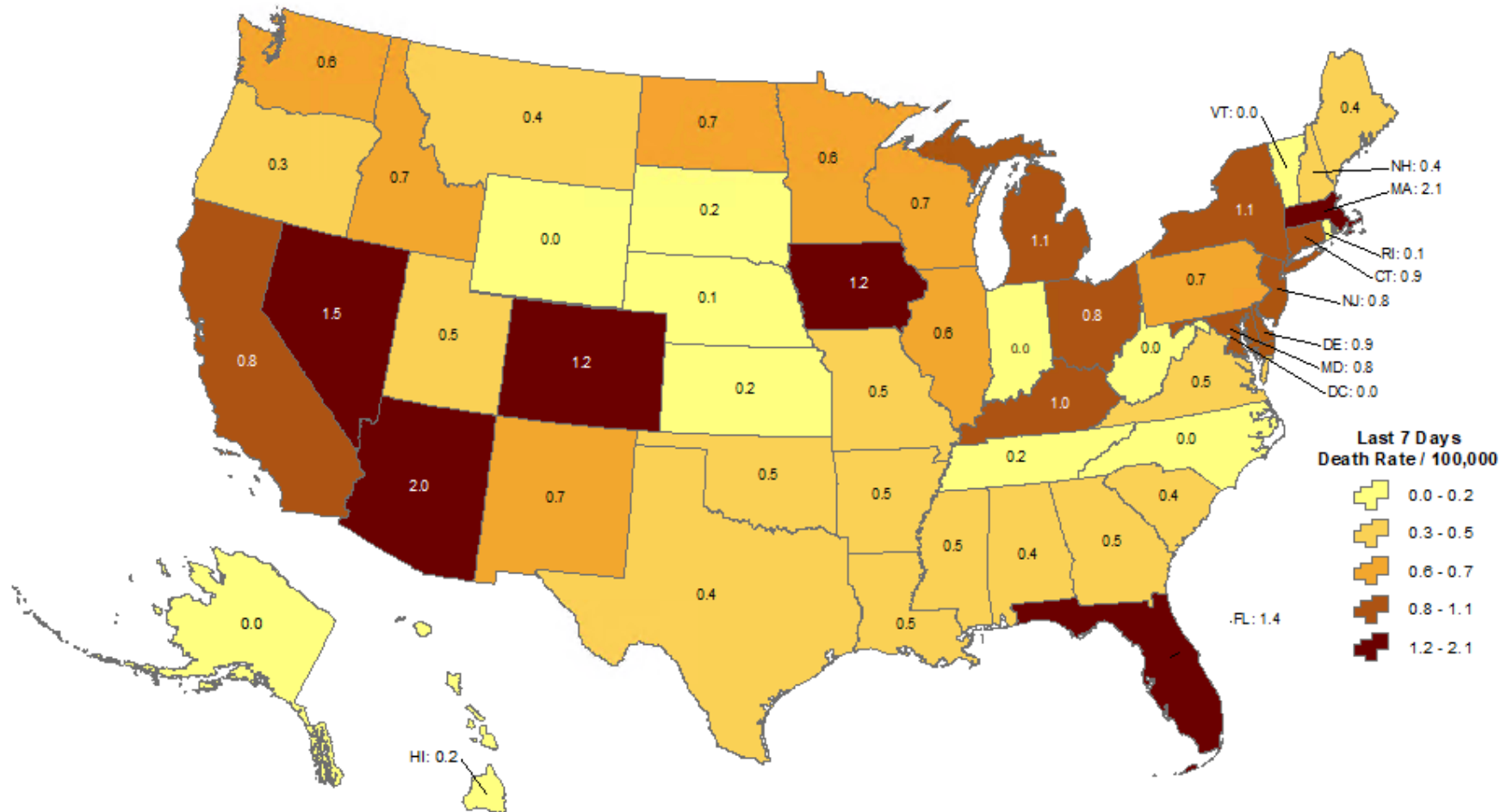

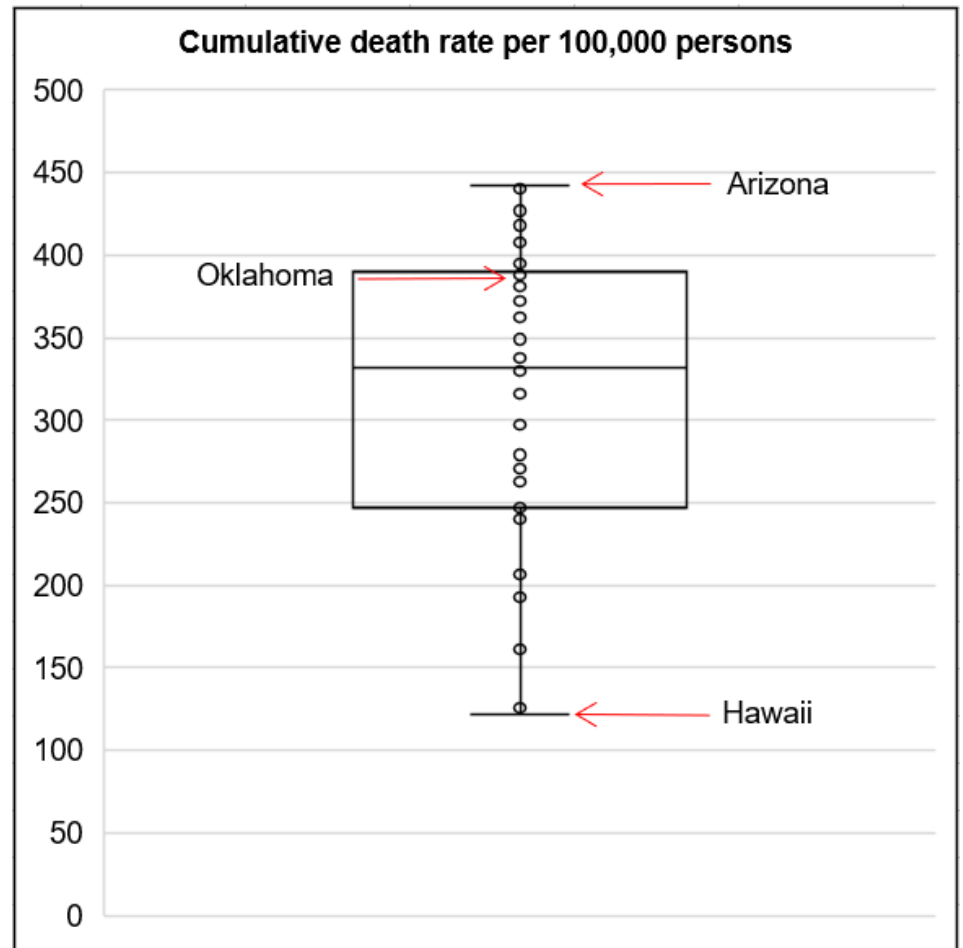
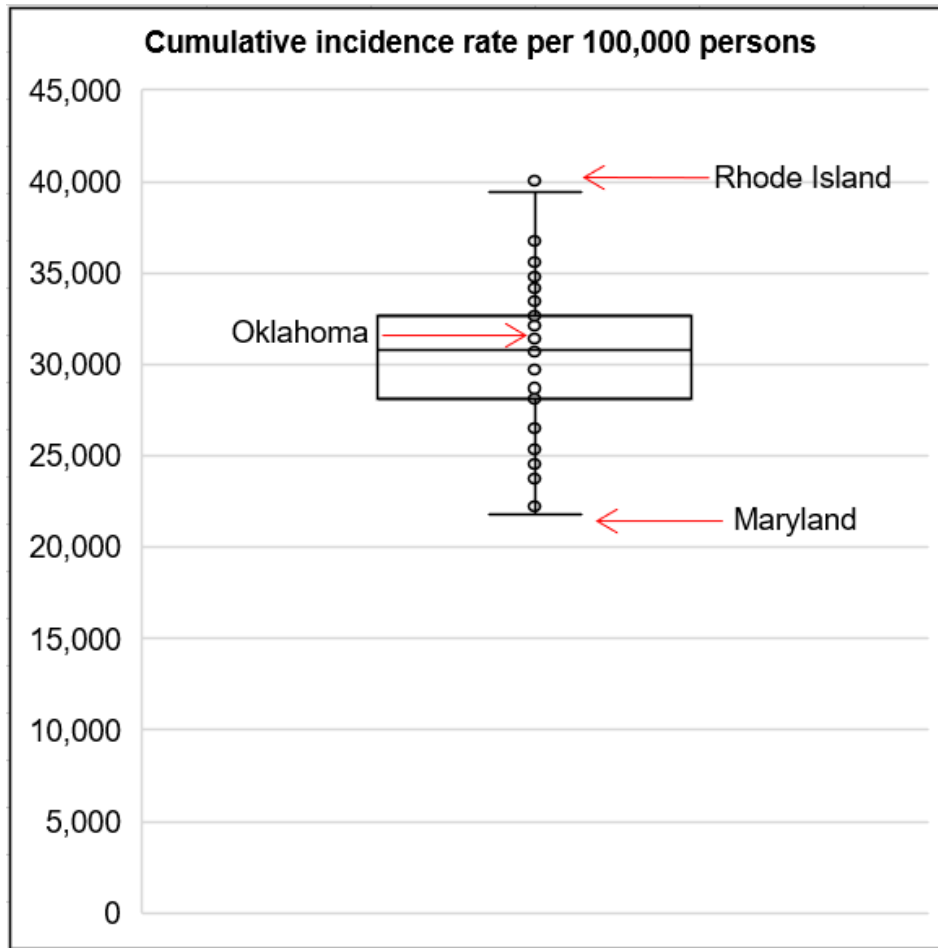

Weekly number of deaths (from all causes)

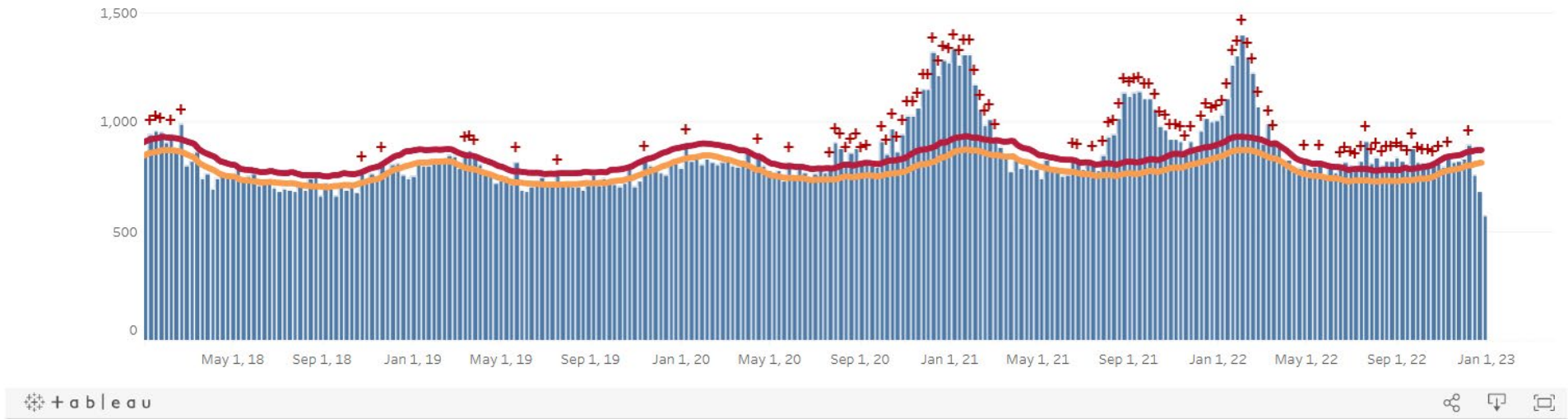
