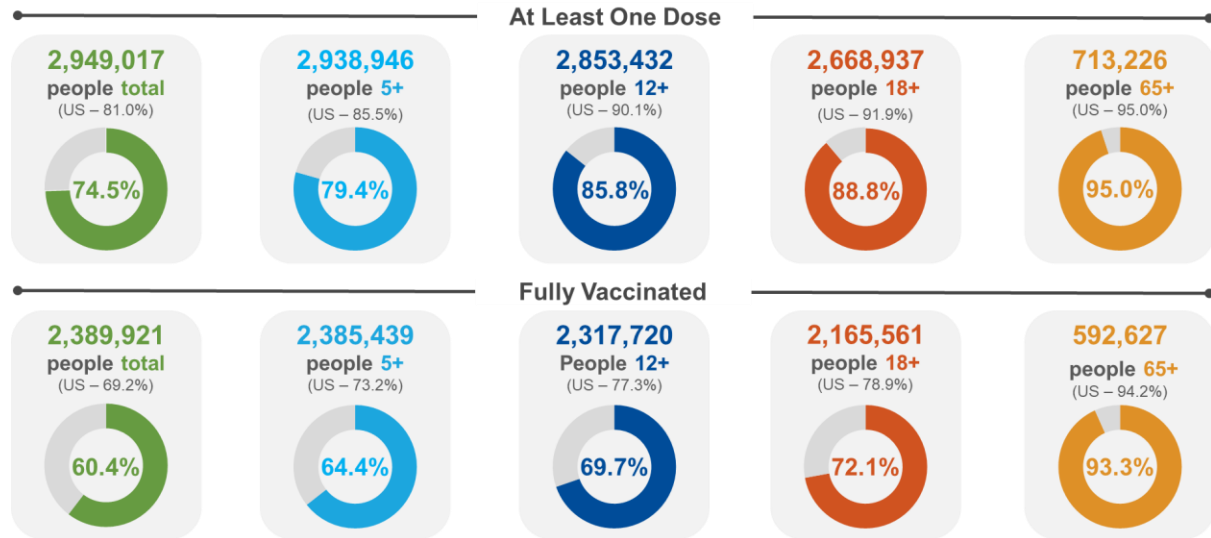

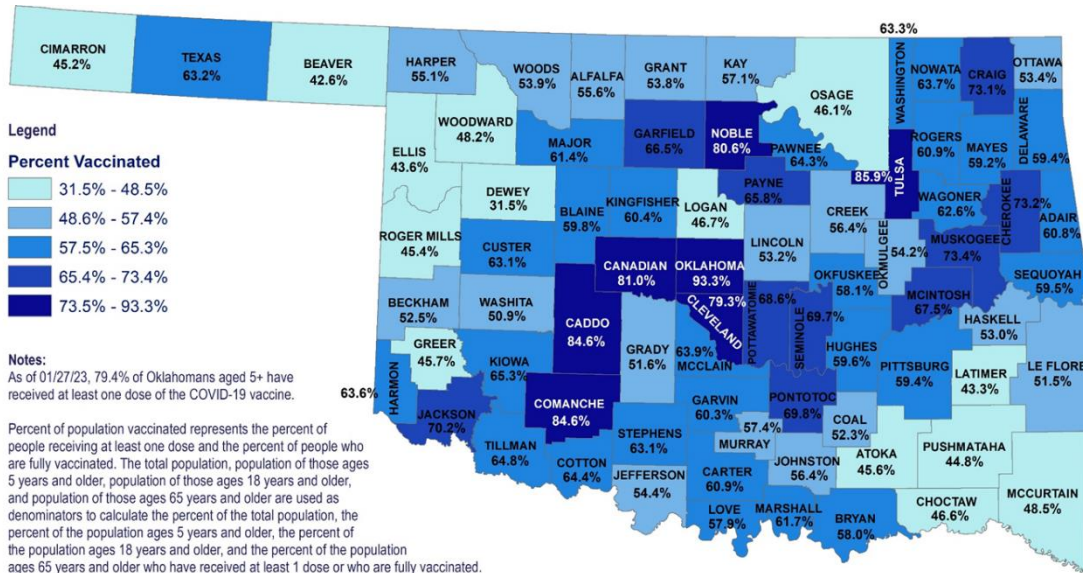

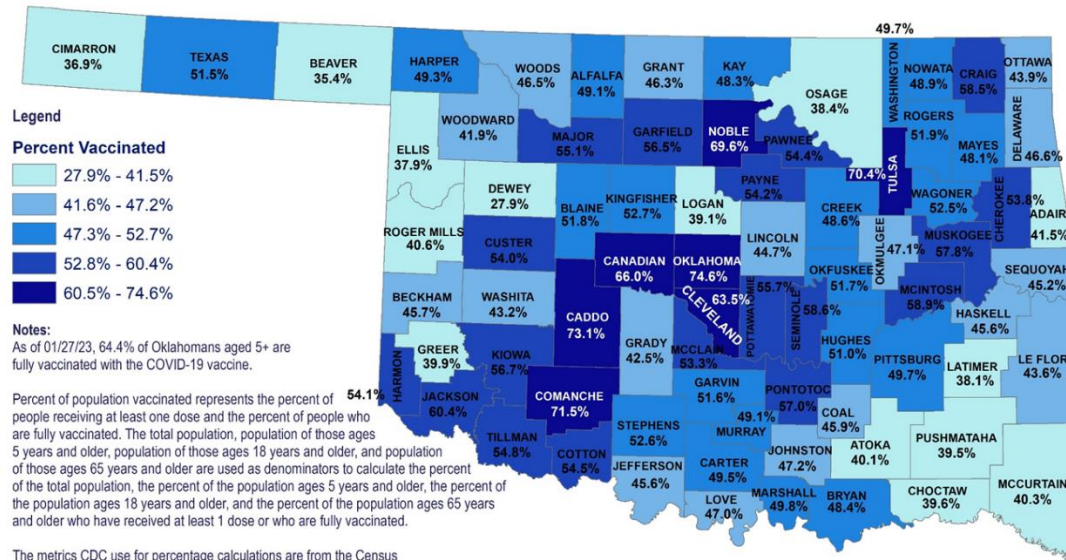

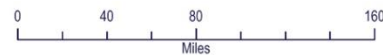

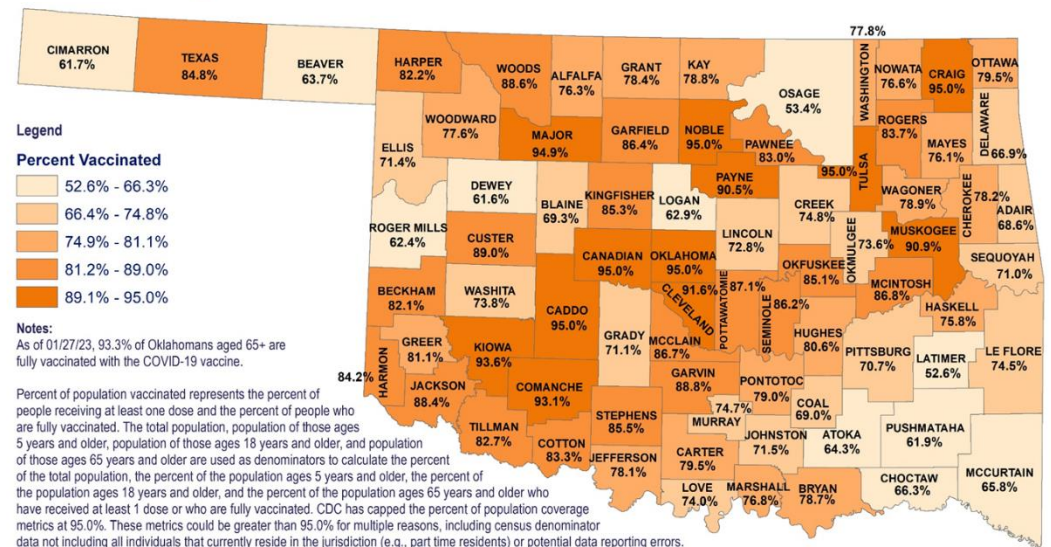

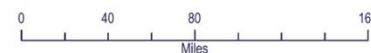

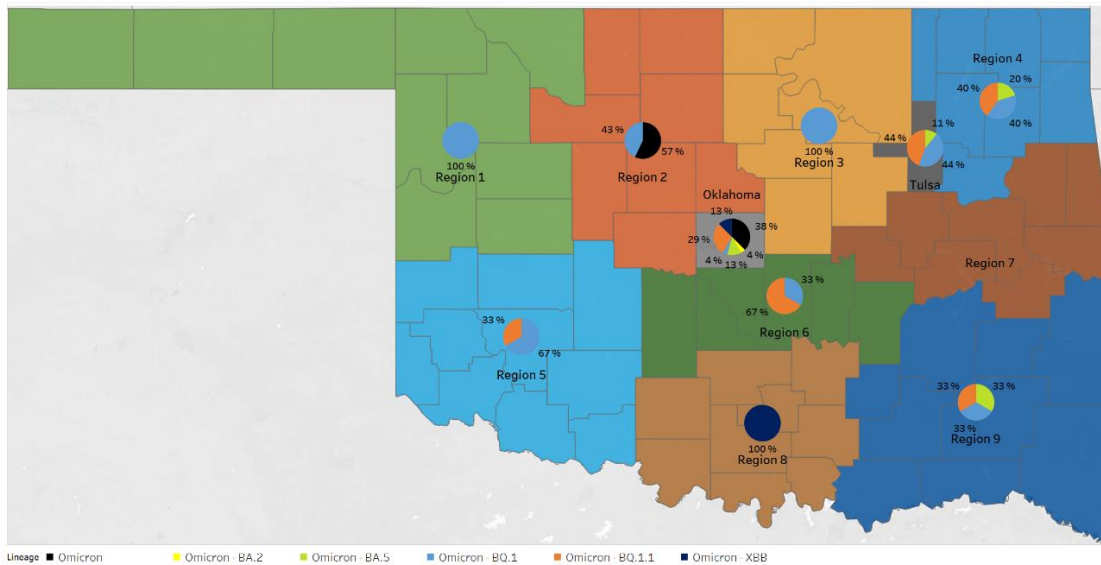

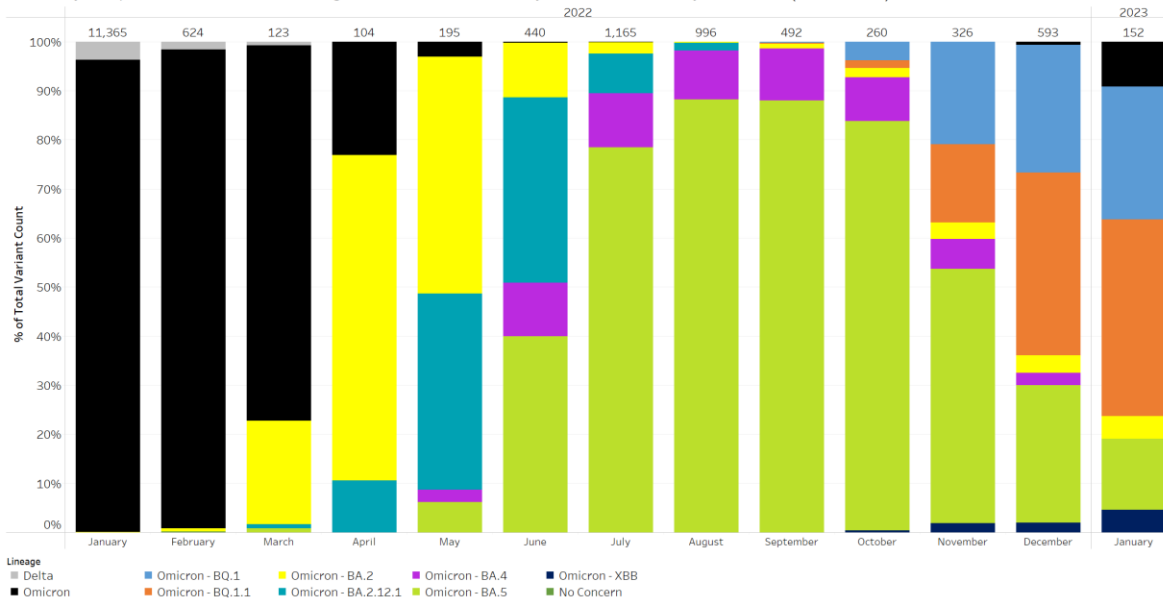
Variant Proportions by Region, Dates of Specimen Collection: January 6, 2023 - January 15, 2023, (N=57):

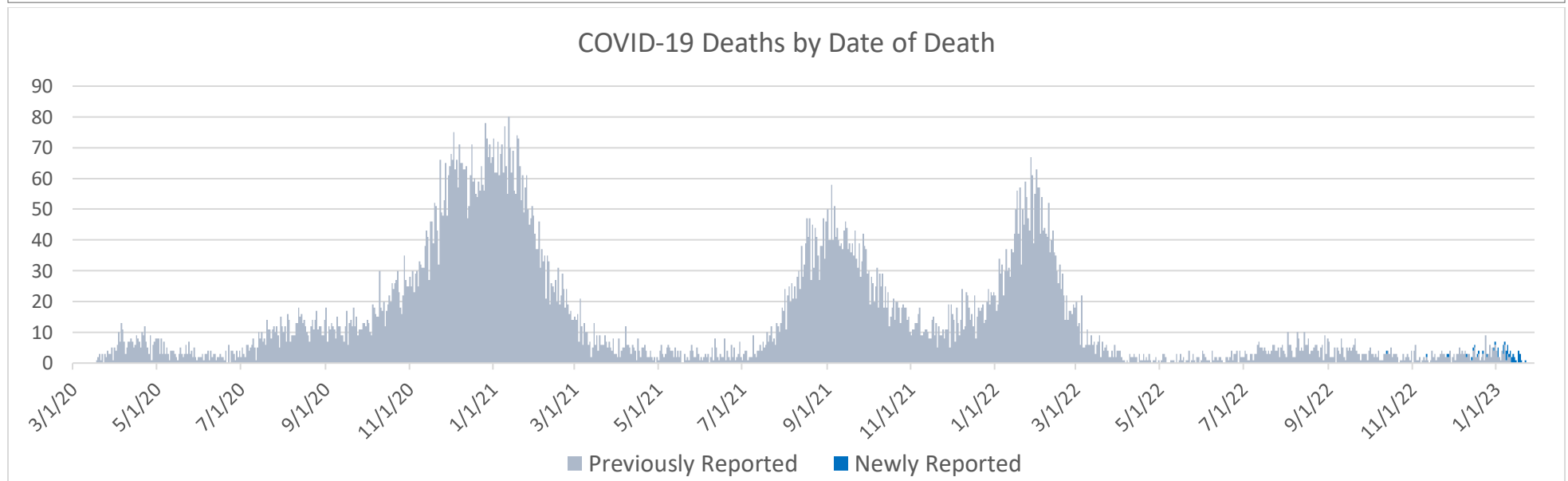
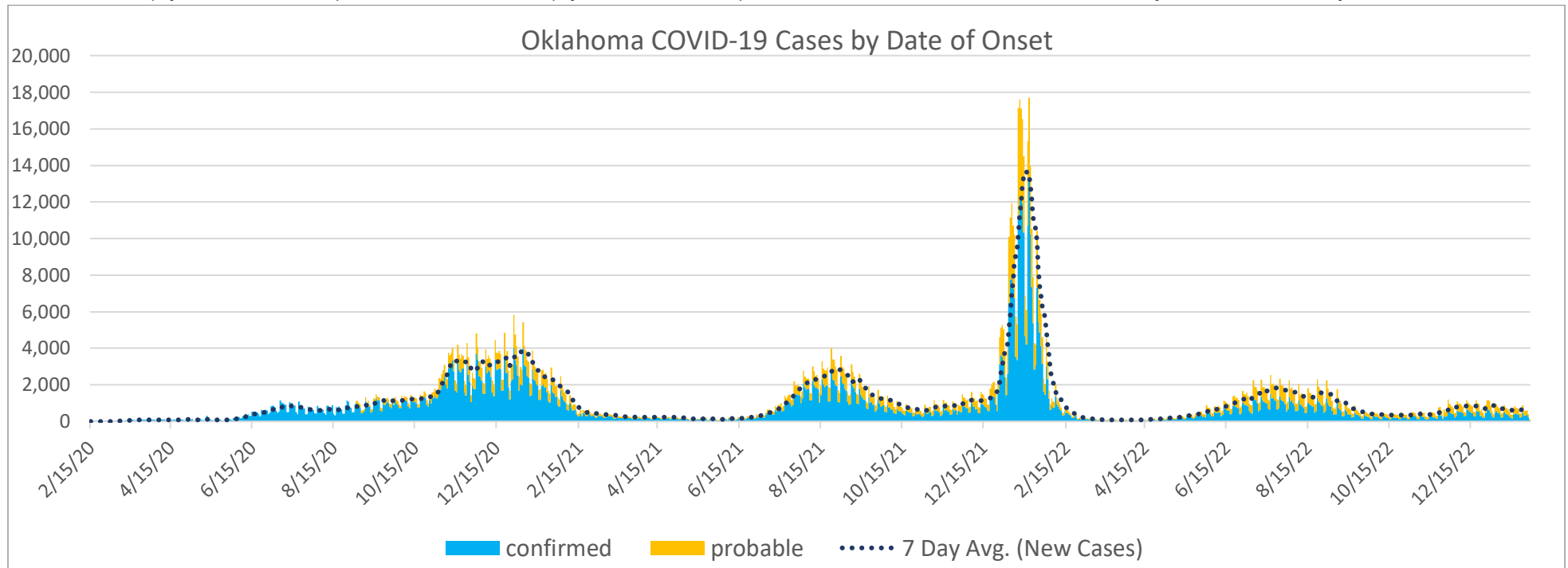
Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - January 30, 2023 (N=16,835)

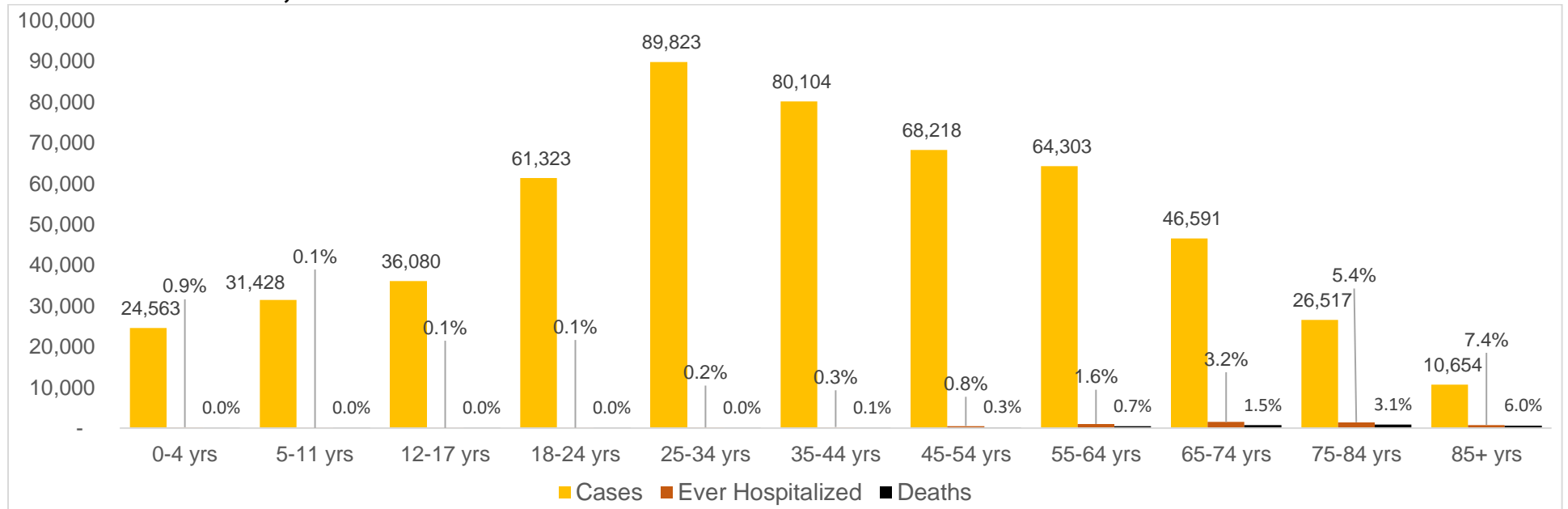

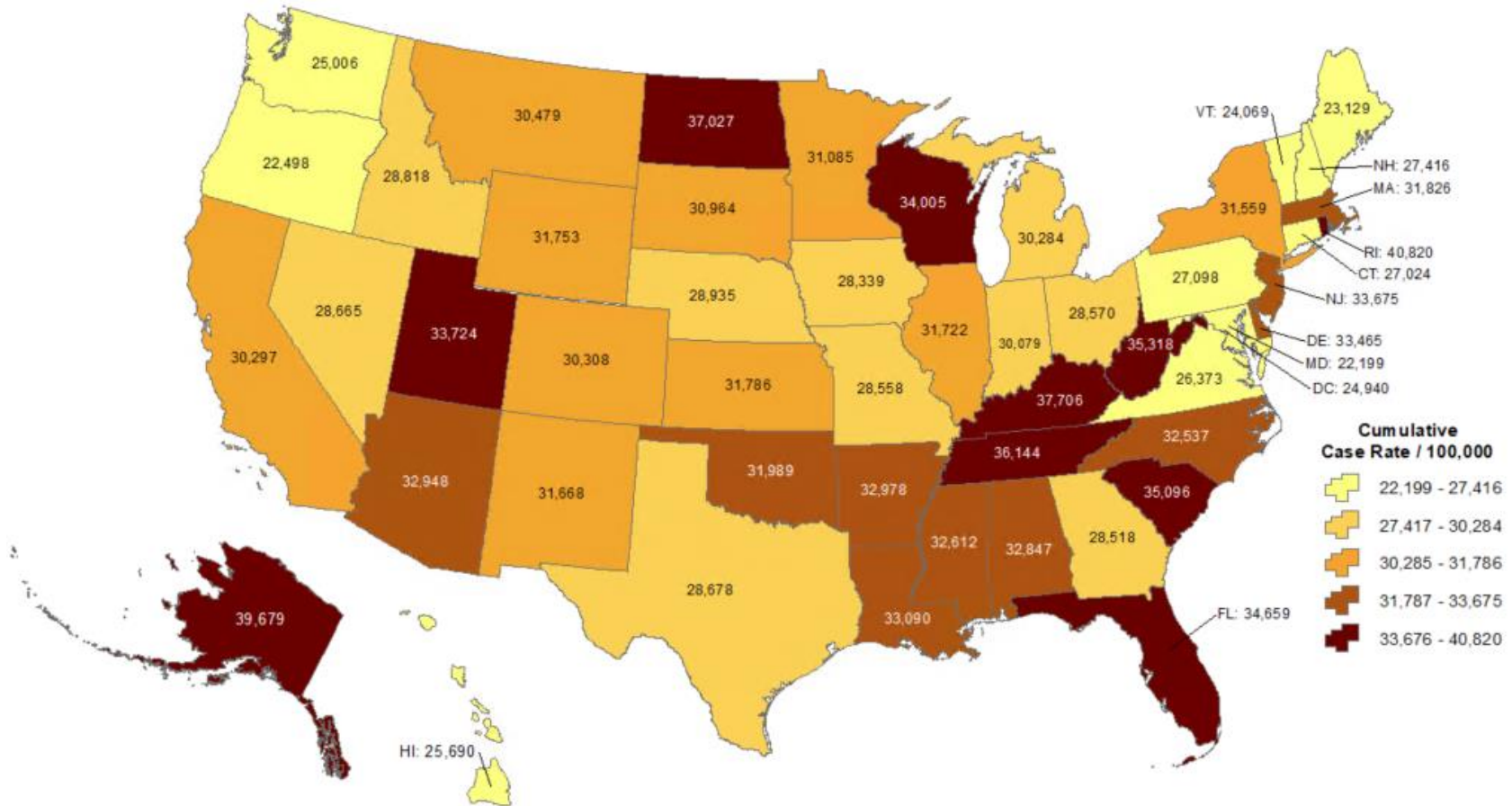
2022-2023 CASES, PERCENT HOSPITALIZED AND DEATHS BY AGE GROUP

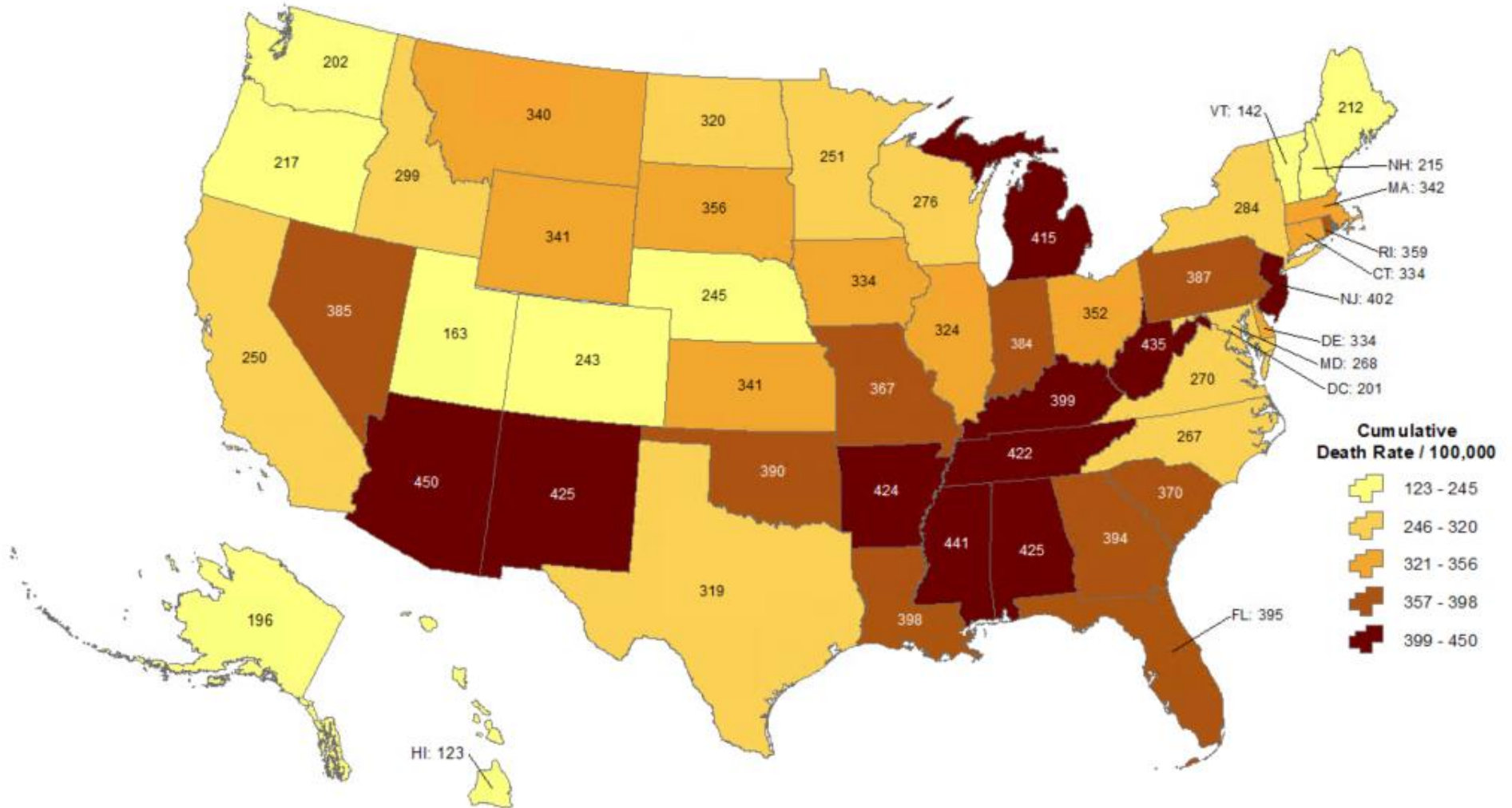

Cumulative death rate of reported COVID-19 cases

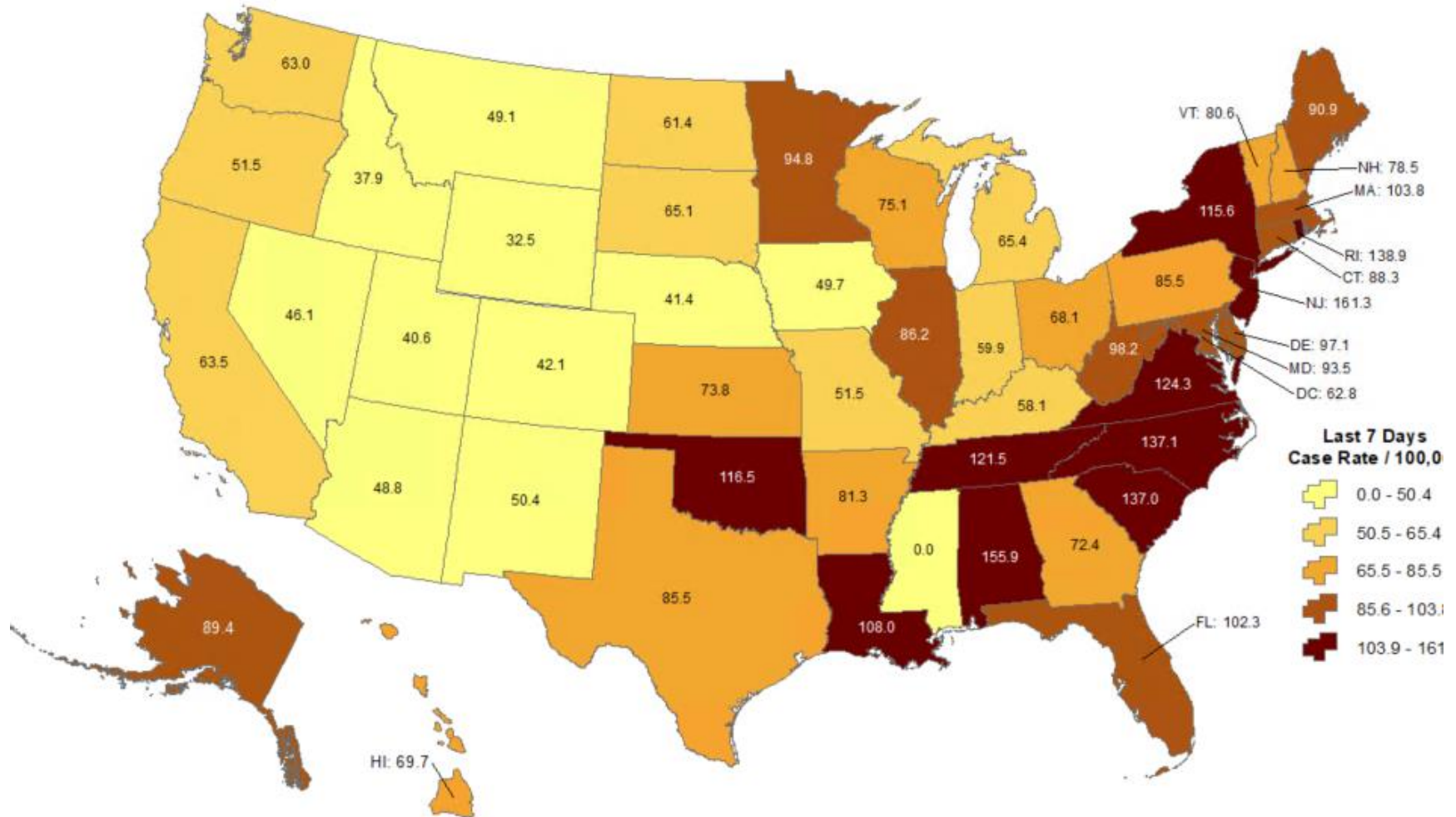

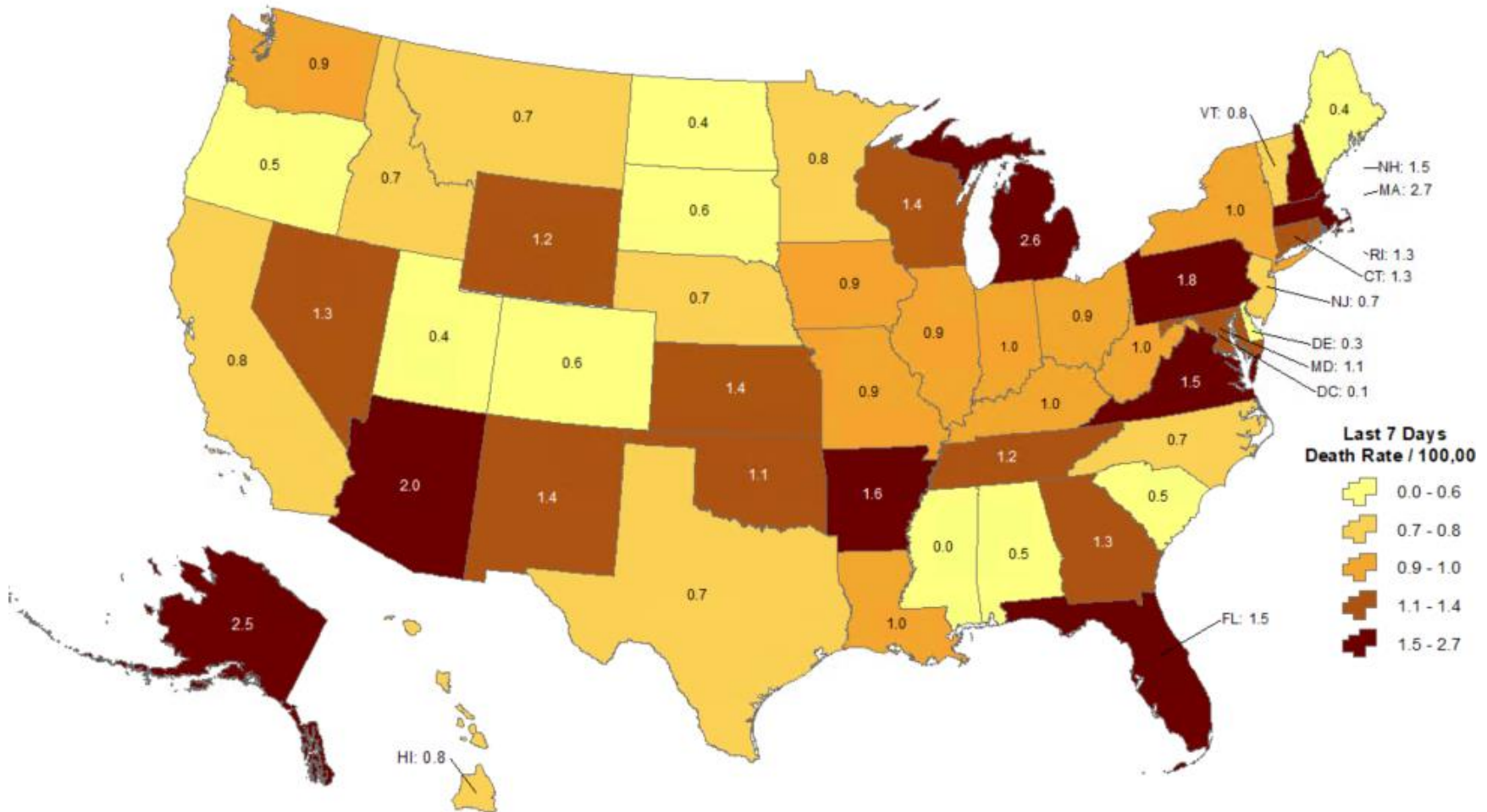

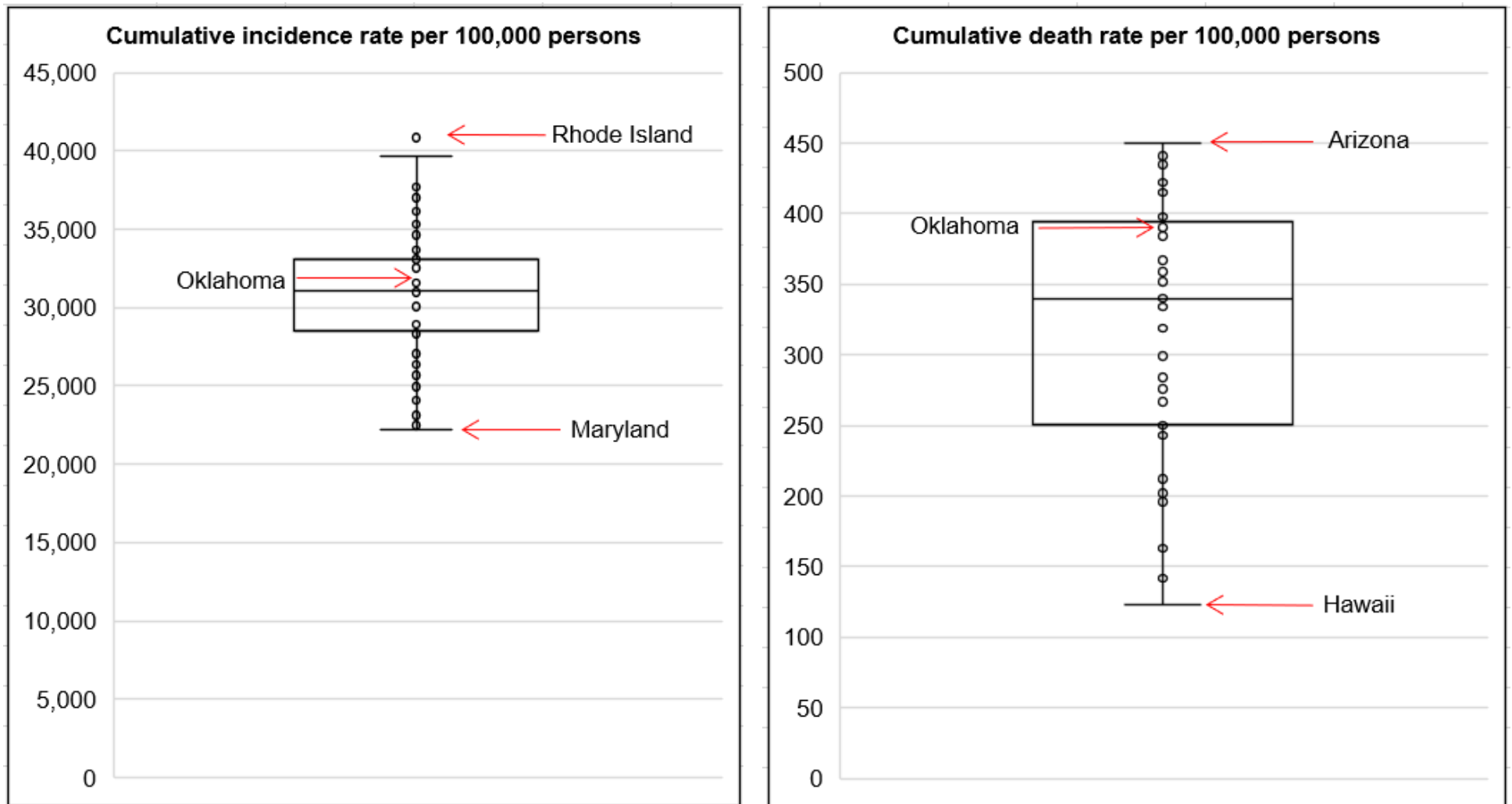

Cumulative incidence and cumulative death rate of reported COVID-19 cases



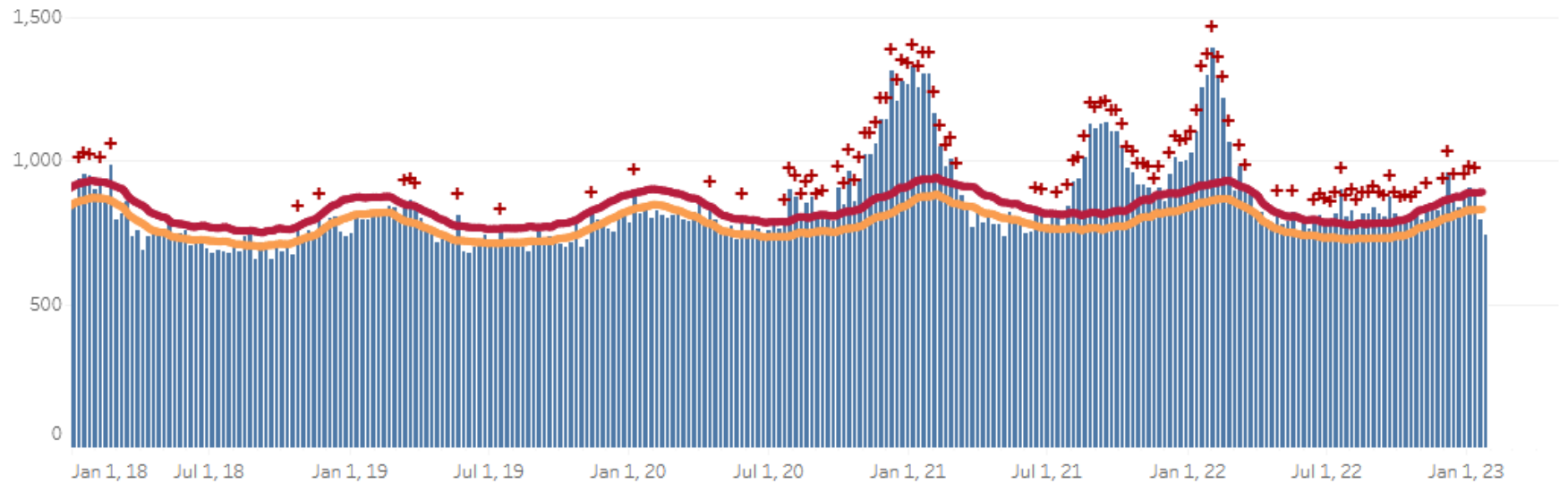
