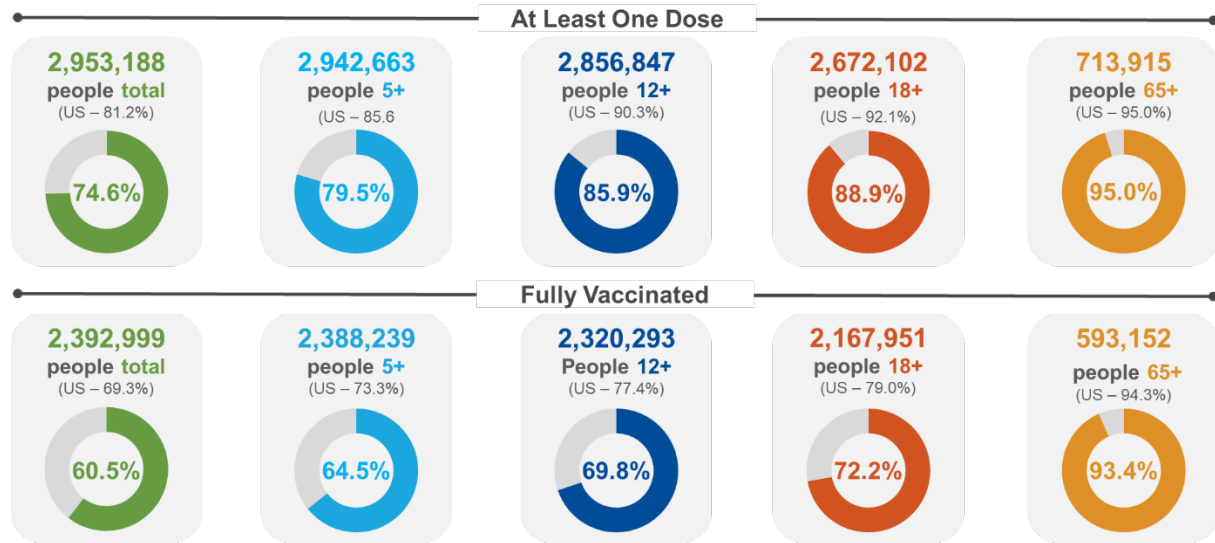

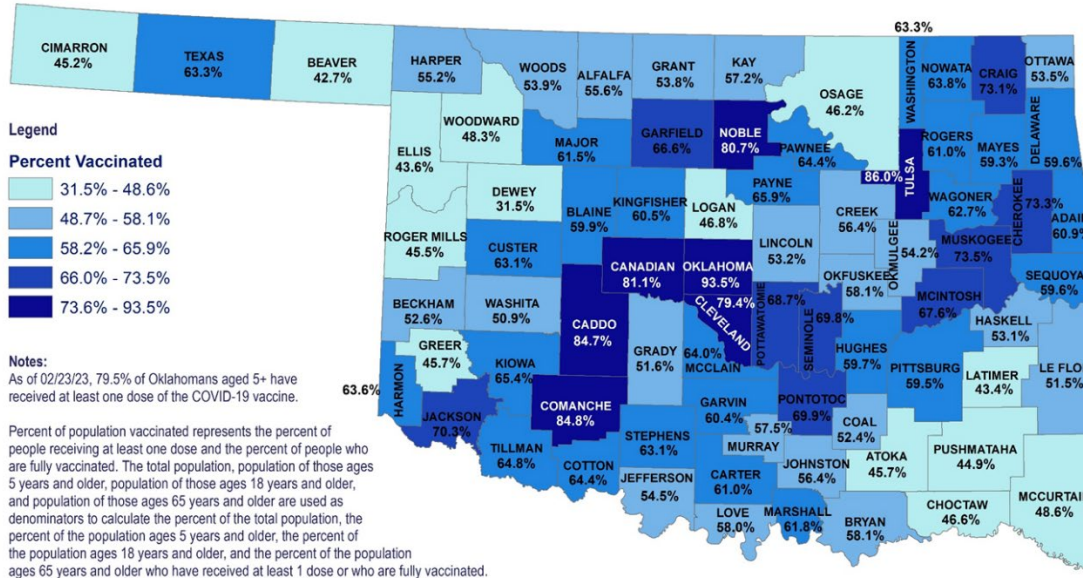

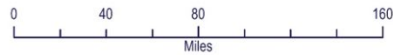

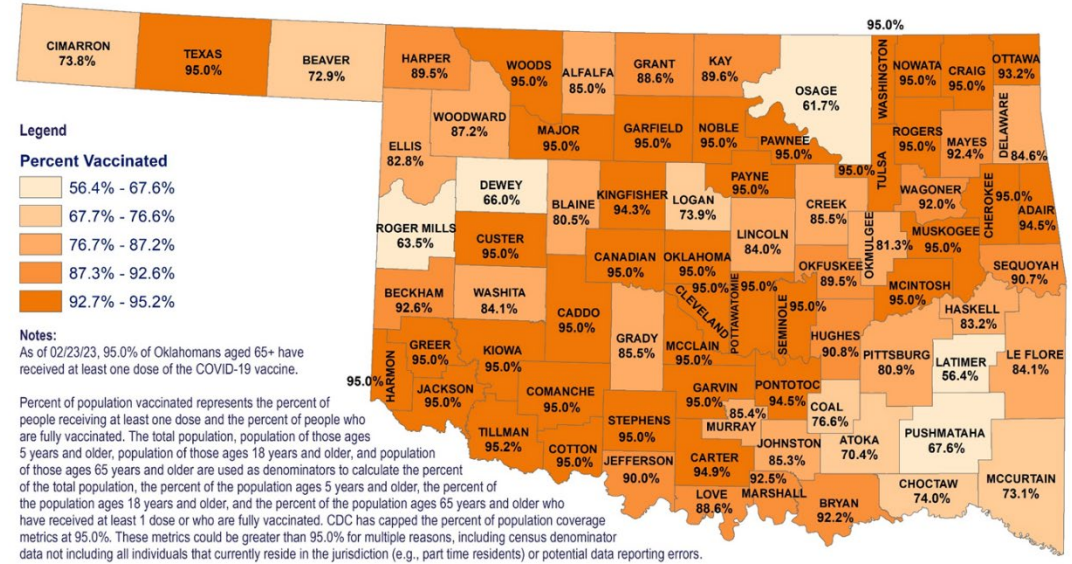

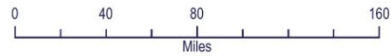

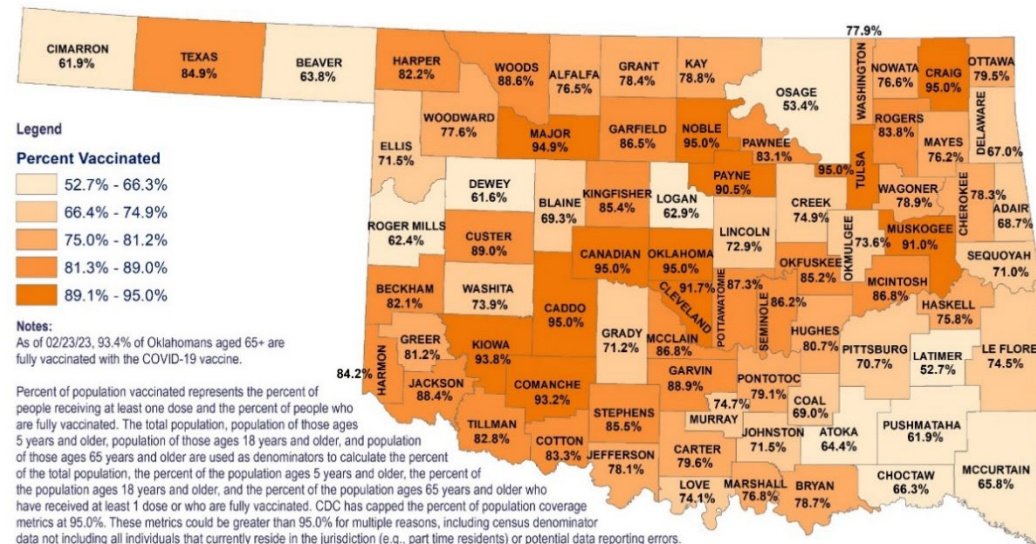

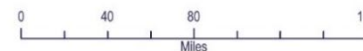

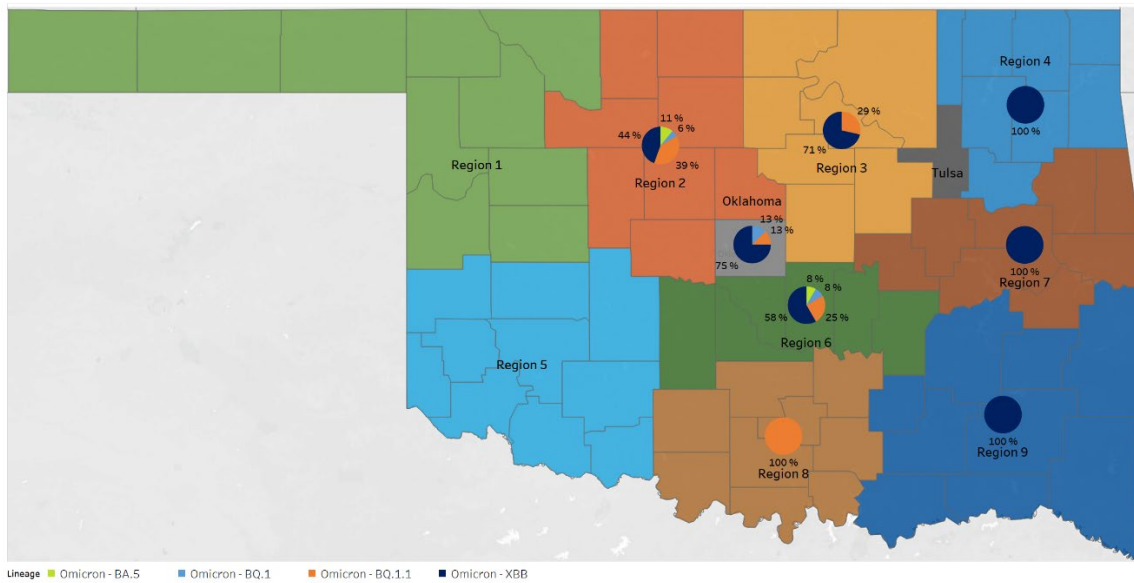

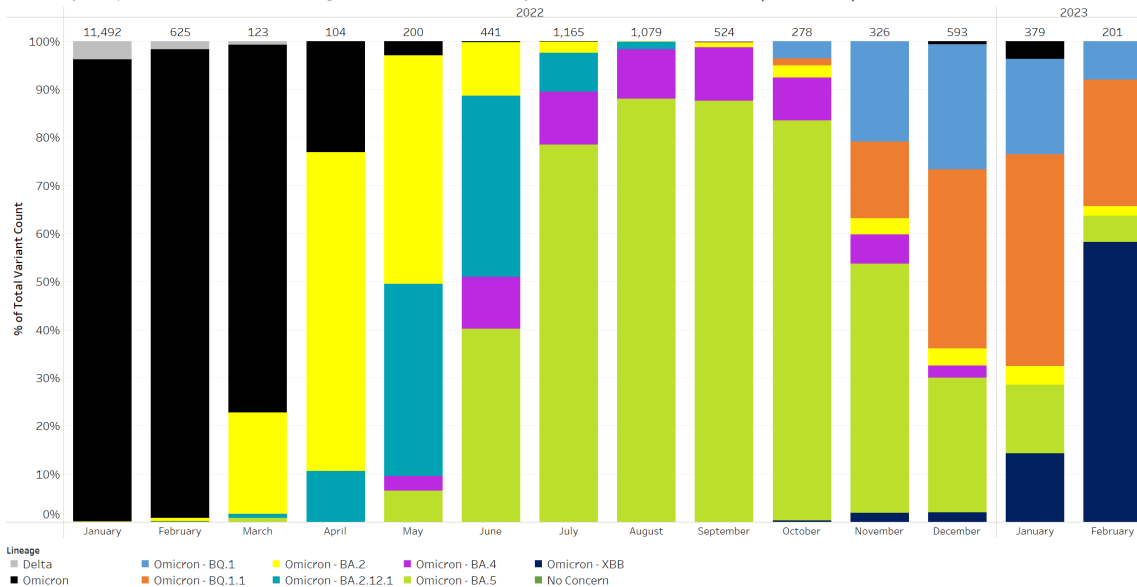
Variant Proportions by Region, Dates of Specimen Collection: February 17, 2023 - February 26, 2023, (N=74):

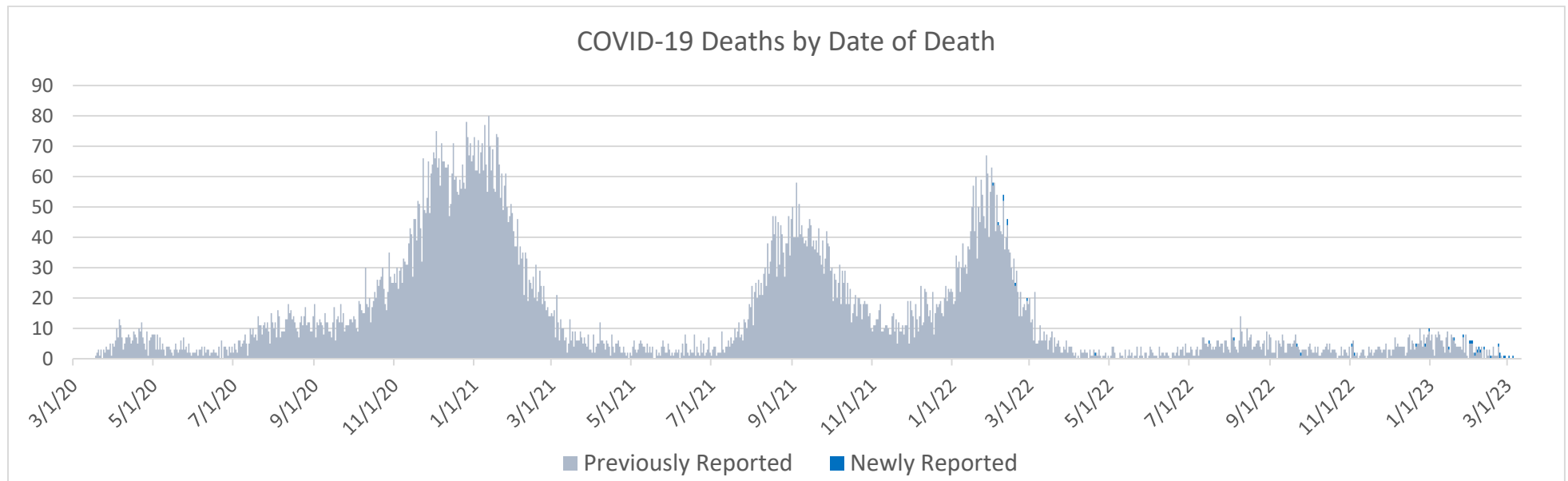
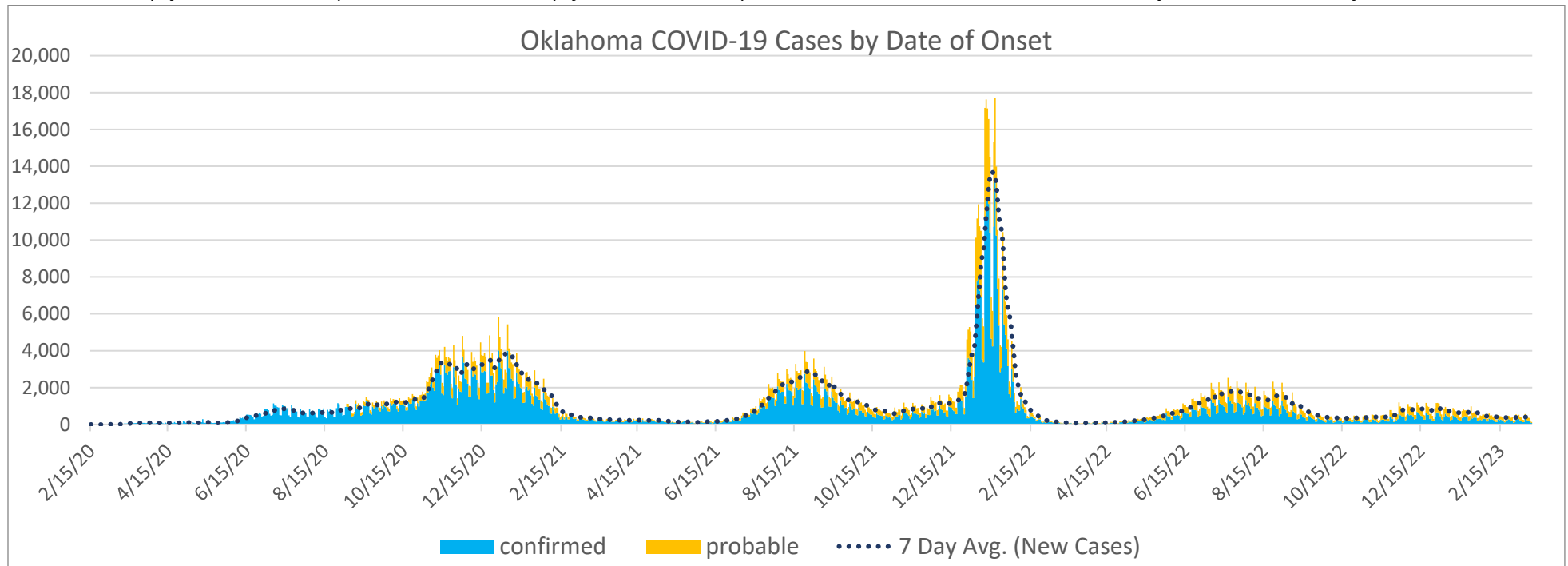
Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - March 14, 2023 (N=17,530)

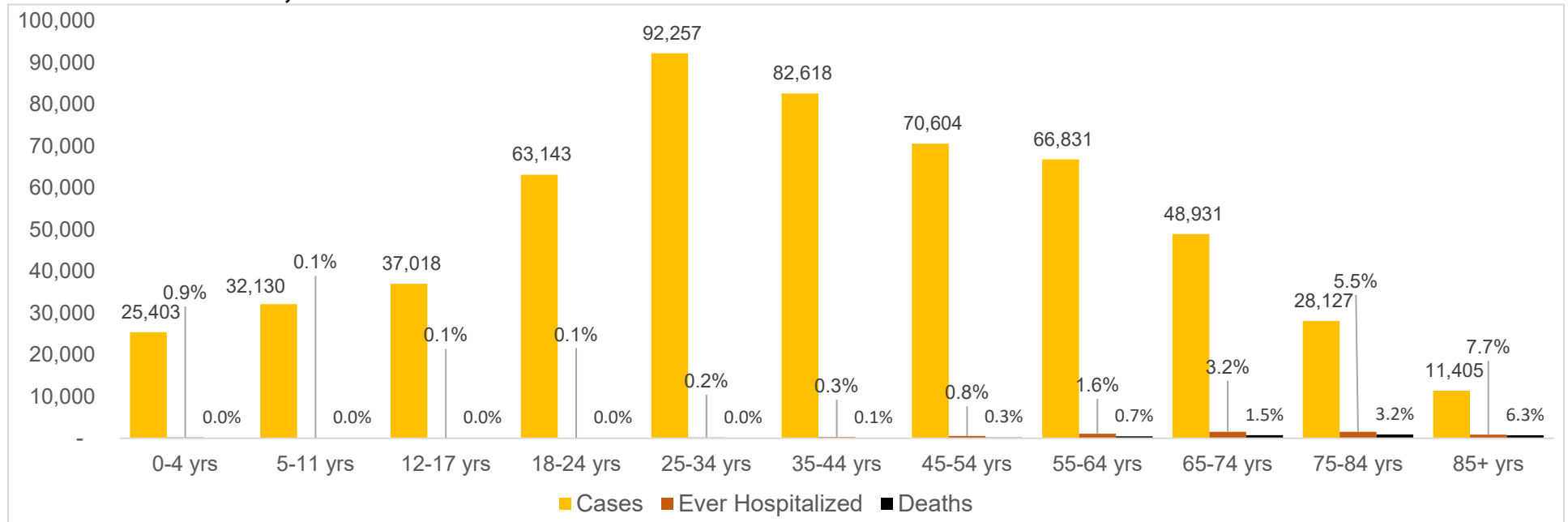

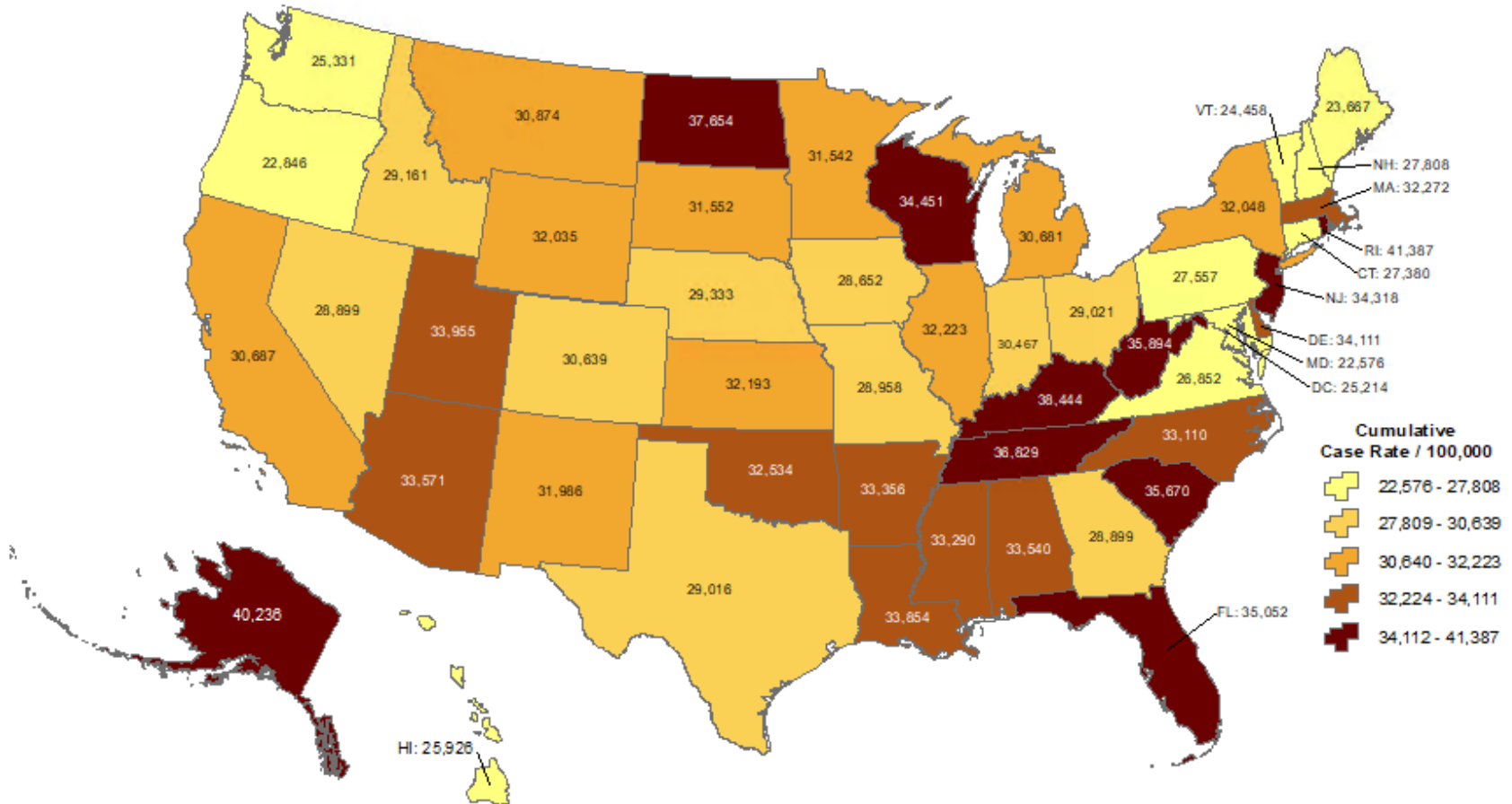
2022-2023 CASES, PERCENT HOSPITALIZED AND DEATHS BY AGE GROUP

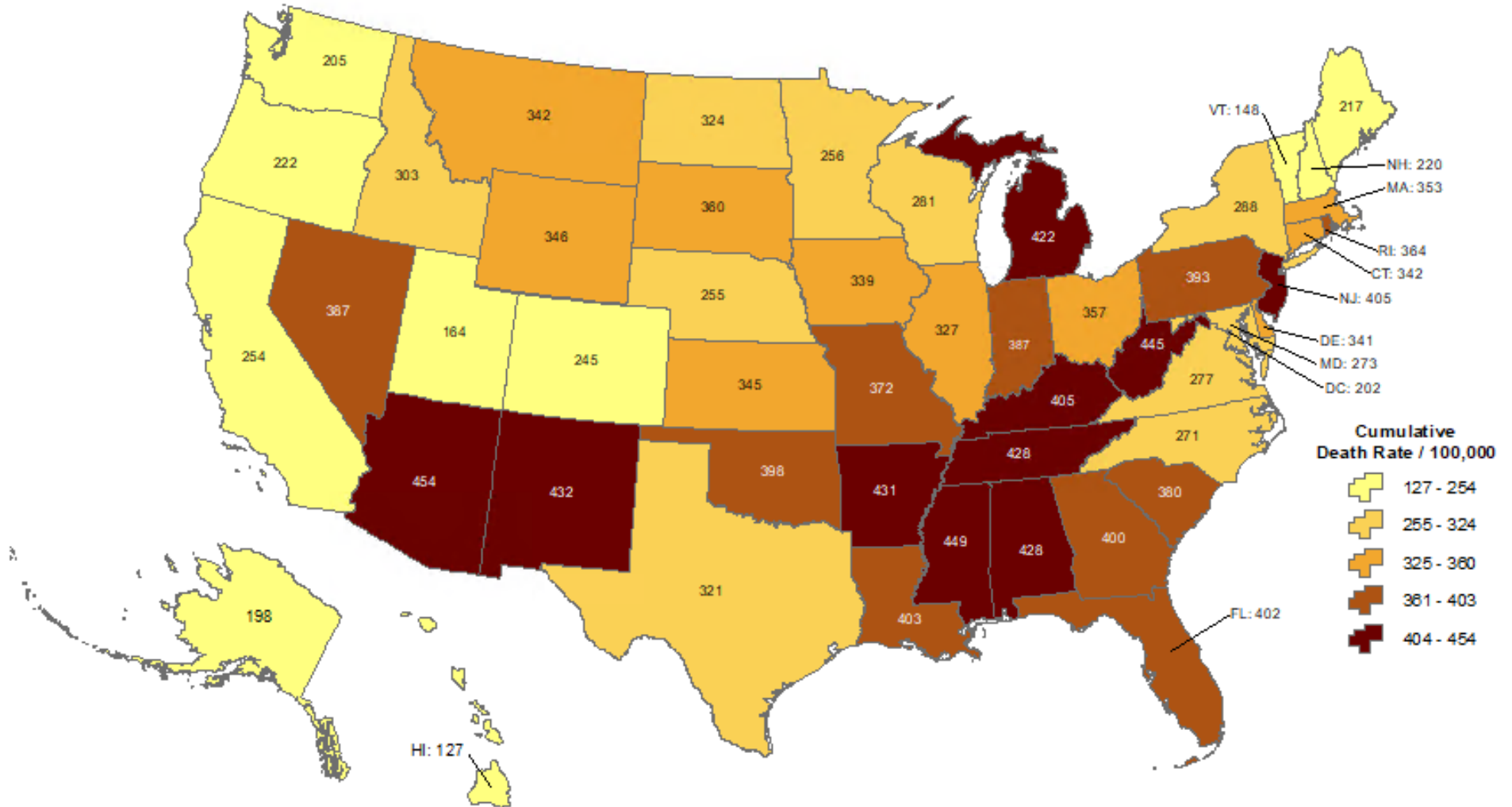

Cumulative death rate of reported COVID-19 cases

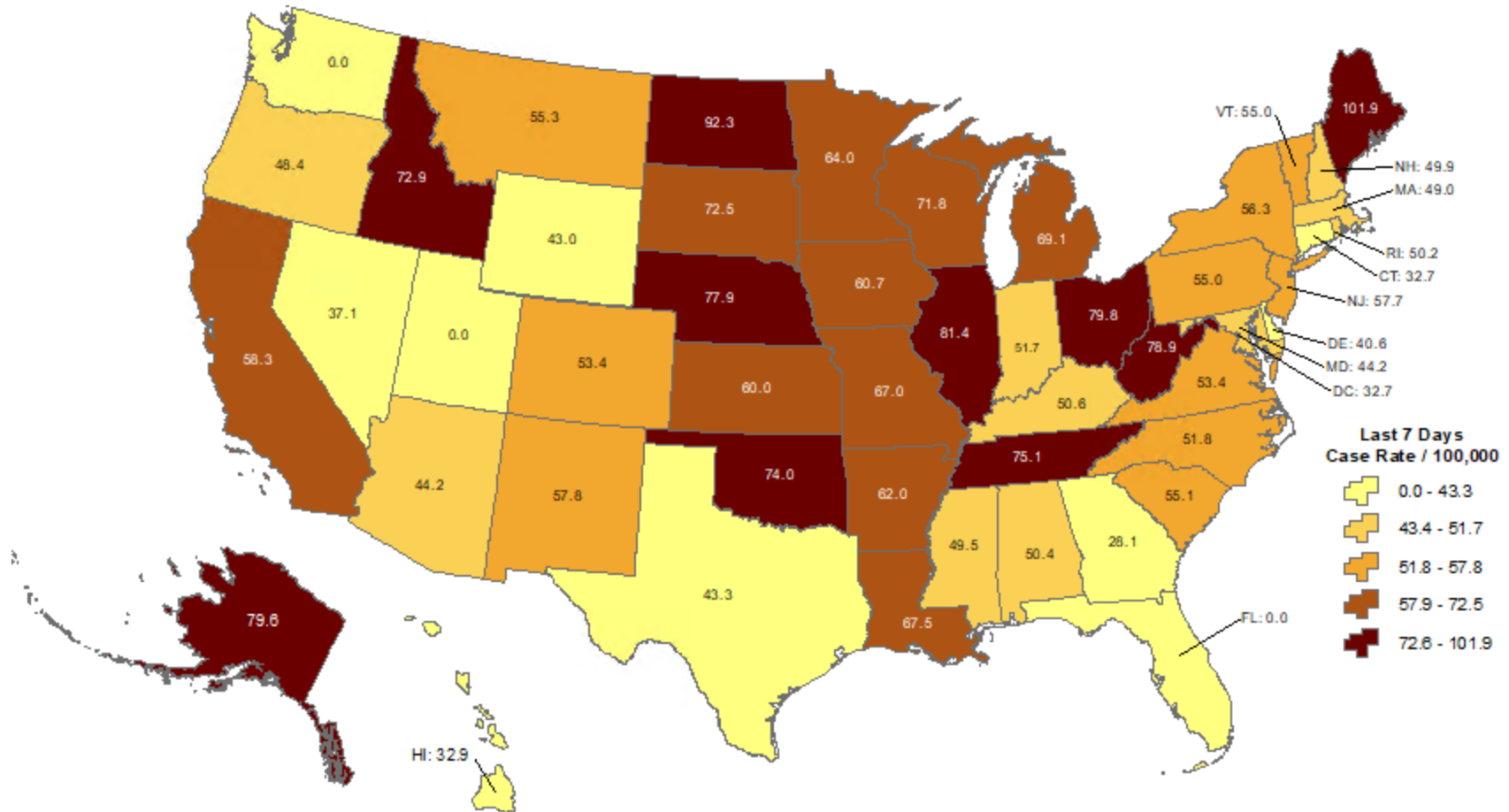

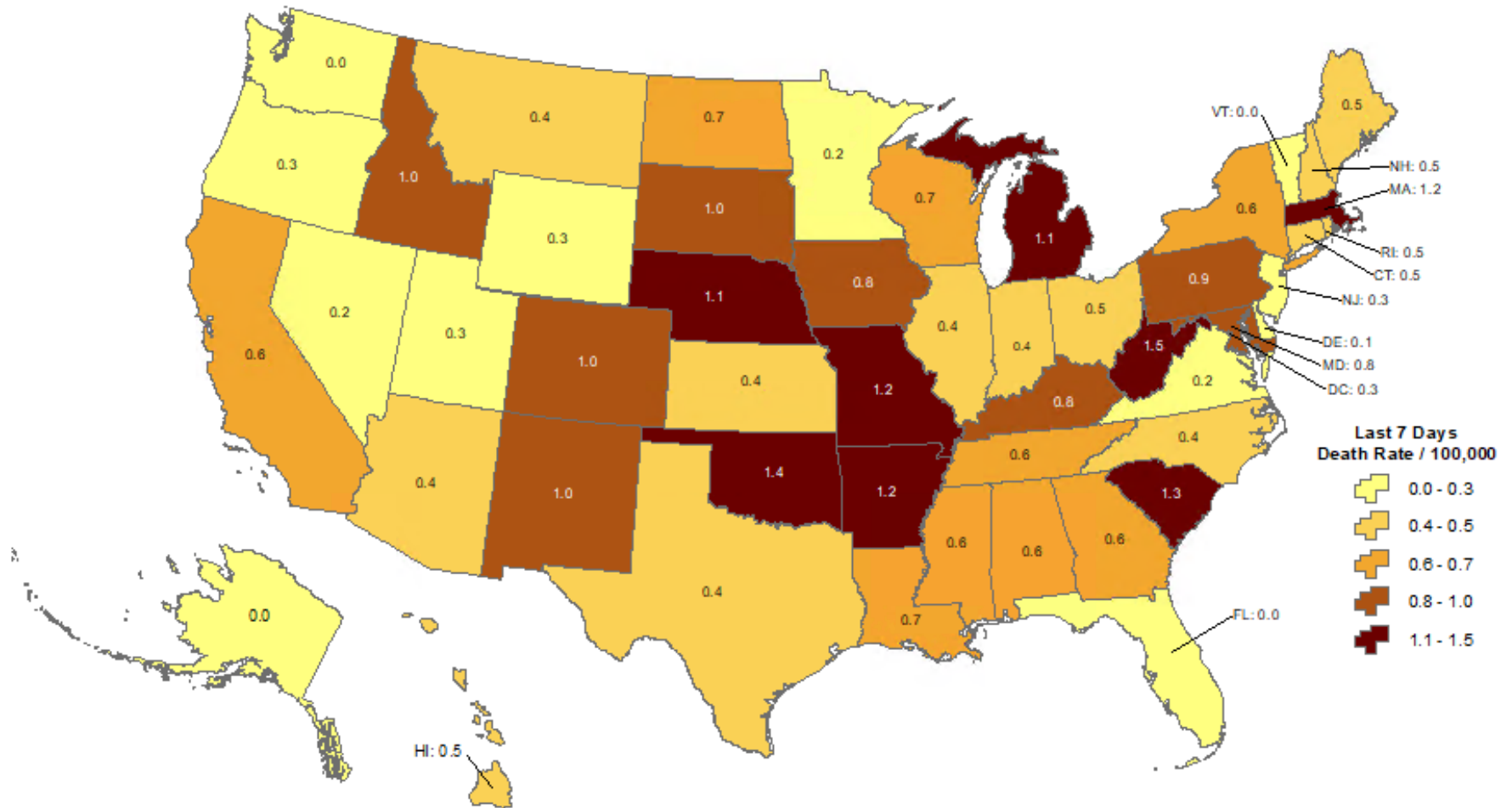

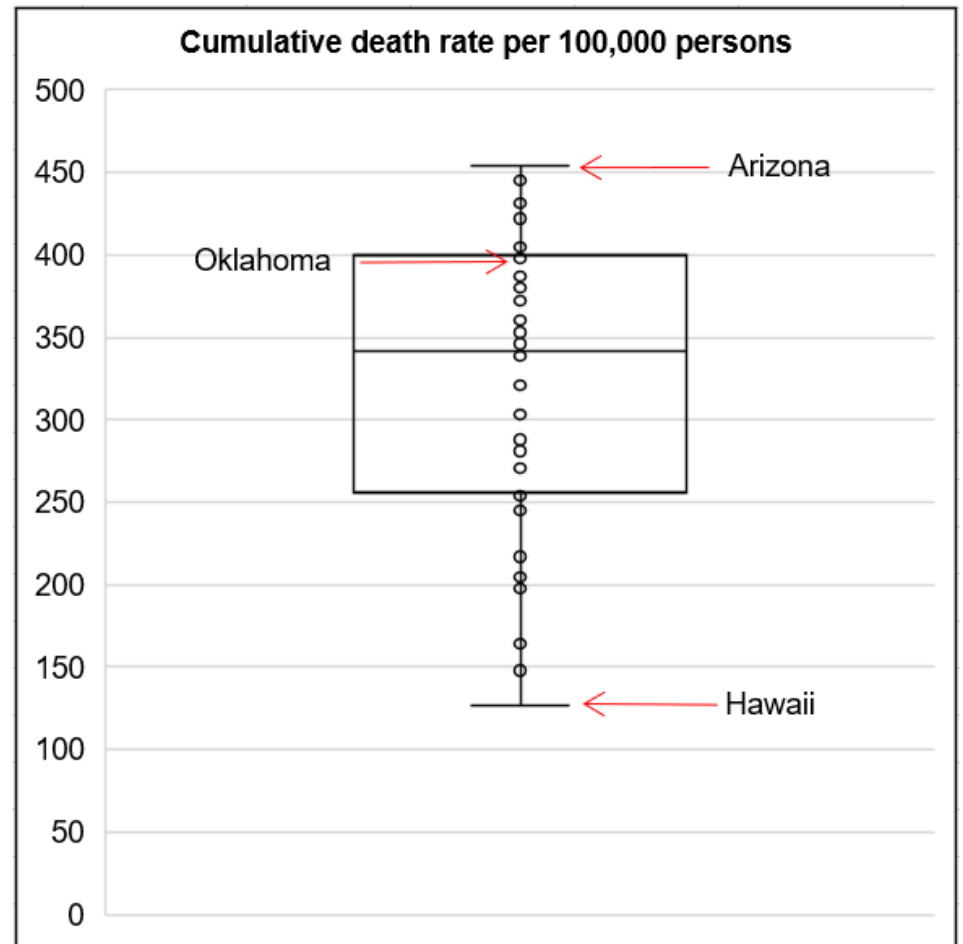
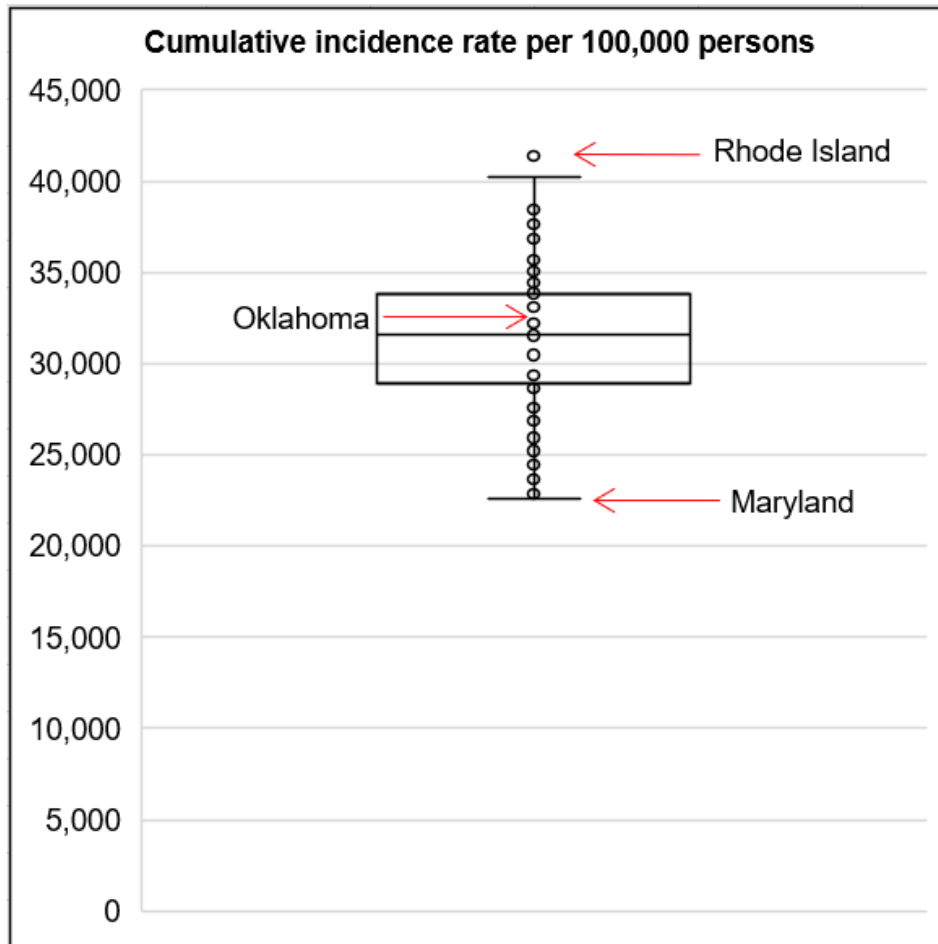

Weekly number of deaths (from all causes)

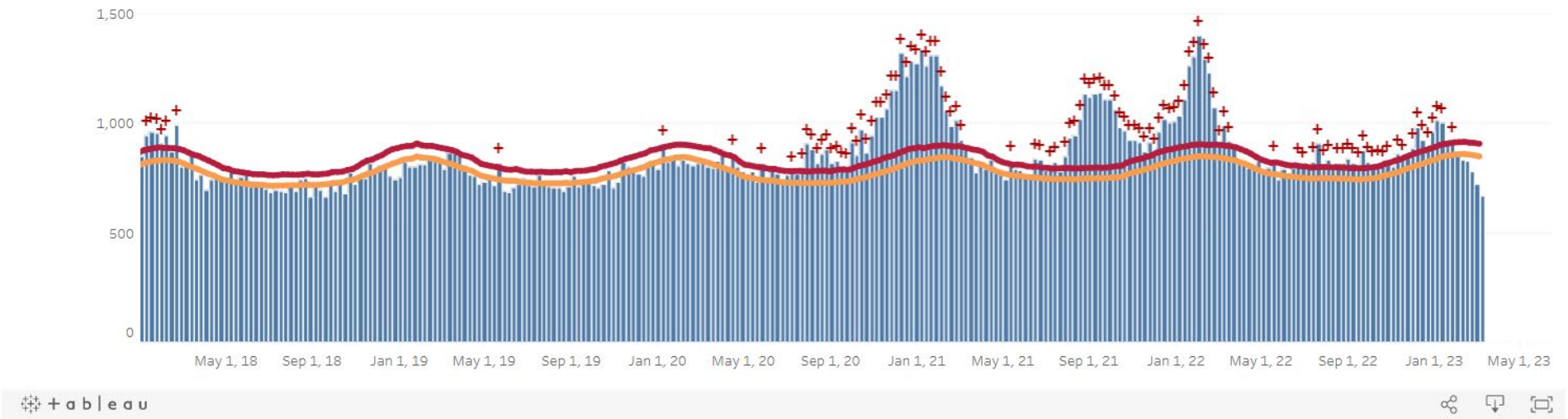
