Agenda Item IV Program Reports

Thentia Update- HADF is one of three programs currently using Thentia, which is the new processing software OSDH is using. We anticipate it going "live" soon and will be ready for Licensee use. It will be where applications, renewals and licensee lookup will all be completed online.

Legislative Review – The Health Department as a whole is tracking all legislative bills in a new way, and it is very beneficial. There are 28 bills that impact 11 of the CHS programs, 4 impact CPLAC.

HB 2013- has a provision to add laser hair removal to Medical Micropigmentation, and it makes some changes to body art (Tattoo/PB). Carryover from last year, but no movement at this time.

HB3002- Adjusts certifications for professions based on background check. Only impacts Medical Micropigmentation. Says that only criminal background related to the license would hinder the eligibility of the applicant.

HB3701 – Removes Sales Tax from hearing aid sales. Has moved through committee and is likely to be passed. HADF support this. There is another Senate Bill 328 that also addresses sales tax for Hearing Aid sales, but is effectively the same as HB 3701.

Agenda Item V

Hearing Aid Dealers and Fitters

Some HADF got together to discuss the recent rules to discuss the online/over the counter hearing aid sales, which is changing on the federal level. Senior Leadership suggested that CPLAC and OSDH not be on the "official" communication statement. Statement was submitted without that "official" recommendation. CPLAC is hoping for future direction when it comes to statements that CPLAC can back or put out.

The HADF Exam was sent to Career Tech, though verification is needed to ensure that they are using this new exam.

Hearing Healthcare Instructional Institute (HHII) asked that we approve some of their CEUs, but because their CEUs are approved by International Hearing Society (IHS). IHS CEUs are automatically approved, so HHII are also approved.
