- Angie Clinton read the dates for 2024 off. There was no discussion on the date, time, or venue.
- 8. Lori Strider presented attachment A and attachment B to the committee. She asked the committee to review the changes in attachment B to be able to vote on at the next meeting.
- 9. Christian Bonds with Injury Prevention presented a Concussion Prevention. He went over what a concussion is, the sign and symptoms of a concussion, the danger signs of a concussion, the long-term consequences from concussion, how to manage a concussion and how to prevent a concussion. Oklahoma has a state law over concussions for youth athletes; 70 O.S. § 24-155. The law was designed to protect youths' athletes in Oklahoma. A annual concussion fact sheet should be provided to parents/guardians. Team officials are required to complete a class over concussions yearly. The Training source must be from either the Center for Disease Control & Prevention (CDC), the National Federation of State High School Associations (NFHS), or other comparable source. The class covers prevention of concussion in athletes, such as safety equipment, safe sports play, culture and strong policies. Christian brought with him some material that will help school districts and youth organization create policies and guides over concussions.   - Lori Strider reported about the new criteria for Pediatric age limits and hospital capabilities.
  - Grace Pelley shared the roles and responsibilities of alternate campuses and the regional trauma plans
  - Grace Pelley reported ideas and ways to improve the professional communications between EMS and Hospital ED.
  - Allie Friesen reports that she is working on evidence-based care for behavioral health for the State of Oklahoma. Ms. Friesen reports working with the Department of Health to develop a bed board for EMResource to improve how patients get the psychiatric help they need. Discussions are had about the difficulties that health care providers face with psychiatric patients and care.
