 Brad LanCaster reports that OTERAC met yesterday with ODOT working on making highways safer and more efficient for EMS providers. Mr. LanCaster emphasizes that to recertify your license the courses must be OSDH or CAPCE approved courses.

Katrina Warden reports that OERSSIRF is in the process of being re-released. Once released, agencies will receive an email. Further information was requested on the difficulties and expectations with OERSSIRF with Grace Pelley reporting that OSDH is currently waiting on more information and to keep an eye on emails and updates will be sent. Ms. Warden also reports that EMS will be receiving compliance reports. Trauma Fund dates are listed in the packet for training as well as timelines.

Tessa Cleary-Smith reports that an updated OTEP is scheduled to be tested later this month with the updated trauma triage algorithms.

Rachel Talley reports that third quarter CQI meeting had five members present, ten cases were reviewed with seventeen letters authored. All authored letters require responses.

Rachel Talley reports that REPC met prior to the RTAB meeting and discussed affecting change in the Region. Ms. Talley reports that REPC group is addressing driving factors that are noticed by prehospital and hospital to create an understanding and allowing the region to work together to create a better system for the patients. Ms. Talley has assigned members of the REPC group to work on individual pieces of a plan to create a better relationship and understanding between prehospital and hospital.

Bob Stewart reports that in a July EMResource drill 81% of hospitals participated with 67% completing the drill accurately. 25% of EMS services participated with 22% completing the drill accurately. As of today, hospitals had 81% participation with 43% completed accurately. EMS services had 32% participation with 23% completed accurately. Mr. Stewart offered to do in-service training at your facility that will take approximately 30 minutes. A redundant communications drill is scheduled for October 31, 2023 scheduled from 8:00 a.m. to 4:00 p.m. RMPG is scheduled for 1:00 p.m. Medical Response Surge Exercise is scheduled for November 14, 2023. RMRS Awareness Training is October 6, 2023 at Region 3 MERC in



Lawton from 9:00 a.m. to 3:00 p.m. Mr. Stewart also introduces Colby Ashenfelter as the new Administrative Assistant.

- 7. Rachel Talley reports that OSSCAR AND OSSSAC created a working group to standardize EMS stroke education across the state. Comanche County Memorial Hospital hosted an EMS Systems of Care County Fair in May for stroke month.
- 8. Christian Bonds presents concussion awareness material that shows what the guidelines are for prevention and response. Mr. Bonds shares the state law and the requirements of schools and discusses options for schools to become compliant with Oklahoma's concussion law.

Allie Friesen introduces herself as the Director of Behavioral Health Clinical Program with INTEGRIS. Allie presents that she is working on having a collaborative bed board established for mental health facilities and is asking the difficulties that are experienced in Region 3 that can be addressed. It is reported that safety plans through the Department of Mental Health have been a huge help in the region. Questions are asked about transport of patients and where the responsibility falls. Discussion is had about the options that are presented outside of using police or ambulance with a contract company that has a positive impact on the community. It is reported that there has been an increase in pediatric patients with an increase in difficulty finding beds for the patients, especially those with chronic medical conditions.

Tessa Cleary-Smith discusses the pediatric age limit changes that have been made with the new trauma triage and transfer algorithm. For trauma patients, the pediatric age is 14 and under. Information sheets are in the process of being obtained to be distributed.

Across the state EMResource has been discussed to find what changes can or should be made to further help prehospital and hospital better identify what facilities have certain capabilities at the time.

The Oklahoma Trauma Triage algorithm has been revised and approved by OTERAC with the draft documents included in the packet.
