## 5. Reports

- EMS Vehicle inspections are still being scheduled online and conducted up by the State Capital. The State is out doing unannounced inspections. If business hours or contacts have changed, please let the State know by emailing <a href="mailto:Esystems@health.ok.gov">Esystems@health.ok.gov</a>. Trauma Registry compliance reports will be placed in BOX and there is upcoming training on how to use BOX. For OKEMSIS and Trauma Registry, those reports have to be submitted by 30 days after the previous month. All training for BOX, OKEMSIS, Trauma Fund, and Trauma Registry are in your packets, or you can email <a href="mailto:Esystems@health.ok.gov">Esystems@health.ok.gov</a> and put your question in the email body.
- Dr. James Campbell informed the committee that CQI went over 10 cases with the outcome of 18 letters with questions and 2 good job letters. The committee also reviewed 1 response letter.
- Mark Forrest informed the committee that RPC is working on feedback from hospitals to EMS, adding more to the STEMI plan, such as surrounding hospitals outside of the Region, and the group has tabled the Stroke Plan.
- Sam Murray informed the committee they had 1 multi-patient event; it was for a Fentanyl overdose. In the last REMMS meeting they adopted the S.A.L.T algorithm for triaging and they are hoping it will be adopted throughout the State. They are still planning for the solar eclipse that is to happen in April. Next meeting is February 28, 2024, in McAlester.
- 6. Jennifer Thompson informed the committee that they had a stroke coordinator meeting earlier in



the month. They have determined the names for stroke ready hospitals; comprehensive, Thrombectomy capable, primary, and acute stroke ready. They have identified 4 different stroke patients; S1, S2, S3, and S4 based on their last normal times. They have decided to take off CT scans from EMResource. The next meeting is April 3, 2024, they will discuss pre-arrival and transport. The meeting is at St Johns in Tulsa.

- 8. Dr. Lindsay DaVault, General Surgeon presented about the capabilities of rural Oklahoma where she defined rural assets and deficiencies. She discussed about the Surgical Extraction Foundation who started the (FAST) Formed Field Amputation Surgical Team. The FAST can perform field amputations or surgical manipulation to free the impinged patient. Dr. DaVault discussed how rural hospitals have limited ability of physicians, nurses, and equipment.
