5. Reports

- Pamela Cunningham reported that the Oklahoma Trauma Emergency Response Advisory Council provided congratulations for Region 5 on their near perfect attendance for the February 8, 2024 meeting. Great Job Region 5.
- Dean Henke shared Marshall County was moved to Region 3 by Homeland Security on January 3, 2024 because of the emergency response of aid and assets in the event of a catastrophic incident within Marshall County and to keep alignment with the Oklahoma Highway Patrol's Districts/ Troops. Mr. Henke shared any questions for our department they need to email Esystems@health.ok.gov. EMS Vehicle inspections are still being scheduled online and conducted by the State Capital. Trauma Registry compliance reports will be placed in BOX and there is upcoming training on how to use BOX. For OKEMSIS and Trauma Registry, those reports must be submitted 30 days after the previous month. Mr. Henke reported that the Trauma Funds are for Physicians, Hospitals, and EMS to receive funds for unreimbursed trauma calls. All training for BOX, OKEMSIS, Trauma Fund, and Trauma Registry are in your packets, or you can email Esystems@health.ok.gov.
- Continuous Quality Improvement Committee
 Pamela Cunningham reported the last meeting on April 12, 2024 and they reviewed 5 cases and sent out 10 letters requiring responses. 14 responses were reviewed. Next meeting will be July 12, 2024 via TEAMs.
- Regional Educational Planning Committee (REPC)
 Kari Beggs reported the Region 5 Envenomation Plan was approved and sending to the RTAB for approval. The REPC also reviewed the RTAB attendance for February 8, 2024 and the region has shown great improvement in attendance.
- Regional Medical Response System (RMRS)
 Kari Beggs, Director report Region 5 responded extremely well to the tornado on April 27, 2024.
 There will be two Surgical Extraction Team exercises for this summer, and she invited AELT to be a part of the exercises. Next RMPG meeting will be 6/26/2024.
- 6. Sarah Connally, Grant Administrator for EMS-C is providing training courses for Autism Awareness, CPR, ACLS, and PALS. Pediatric readiness surveys will be sent out to facilities. Contact Ms. Connally at 405.271.3307 ext. 2 or sarah-connally@ouhsc.edu for further information.
- 7. Laura Isom, Stroke Liaison reported the Region 5 Stroke Plan is still working on the rough drafts submitted in March. New leadership for OSSSAC is Dr. Barghois and for OSCAAR is Melody Bridges.
- 8. Dr. Alisa Cross gave a presentation over the challenges in the management of geriatric trauma patients. She provided an overview of geriatric trauma and a description of the current state of geriatric trauma at OU Health. She shared with the committee that geriatric patients are living longer and is 60% the fastest growing population and currently make up 20% part of the total population. They have higher mortality and complication rates than other trauma patients. This is due to their frailty rate being more than the age of the patients. Geriatric patients have decreased physiologic reserve and resistance to stressors. They have an increased vulnerability to poor outcomes.
