MINUTES

- I. Call to Order.....Jason Likens, Interim Chair
Meeting was called to order at 11:06 am.
- II. Roll Call.....Rebecca Novak
Roll call was taken with the following members present - Jason Likens, Elizabeth Lambert, and Julia Day.

- III. Introductions and Announcements.....Jason Likens, Interim Chair
None at this time.
- IV. Approval of Minutes – May 18, 2021.....Jason Likens, Interim Chair
A motion to approve the minutes as written was made and passed without discussion.
- V. Business
 - A. Discussion, consideration, possible action, and approve new Chair for Regional Planning Committee (RPC) – Elizabeth Lambert.....Jason Likens, Interim Chair
Mr. Likens appointed Elizabeth Lambert as the new RPC Chair. There was no discussion. No vote was needed.
 - B. Discussion, consideration, and possible vote to approve action pending review of the annual survey and Region 6 Trauma Plan.....Jason Likens, Interim Chair
Mr. Likens stated the goal of conducting an annual survey gave EMS services guidance for time sensitive conditions. At the time of the survey, it was noted that there was not a stroke plan implemented and services were not sure what to do for these patients. Discussion took place discussing how time sensitive issues such as stroke can be included in the regional trauma plan to help with consistency at hospitals. Mr. Likens suggested combining business items B and C. Business items B include the annual survey and Region 6 trauma plan remaining as currently written.
 - C. Discussion, consideration, possible action, and vote to approve amendments to the Region 6 Stroke Plan for recommendation to the RTAB.....Jason Likens, Interim Chair
Discussion took place on improving care, consistency at hospitals for EMS providers to know where to take a stroke patient, holding EMS and hospitals accountable by updating the necessary websites, and stroke initiatives. It was discussed that hospitals in Region 6 look at the stroke plan during the RTAB and acknowledge if the information is still accurate. The regional liaisons appointed by the Oklahoma State Stroke System Advisory Council (OSSSAC) are available for questions. A motion was made to combine business items B and C, accepting the annual survey as current, accepting the Region 6 trauma plan as voted on previously by RTAB, and implementing the current stroke plan as written and passed without discussion.

Updated statistic data is unavailable due to required data not being entered into OKEMIS or hospital requirements. There was discussion on how to get Region 6 hospitals and EMS working together to accomplish the two new trauma goals in 2022 that were voted on at RTAB. Suggestions of how to accomplish these goals were made by Mr. Likens and Ms. Lambert which included but were not limited to getting examples from Quality Improvement Committee, (QI Committee) and retraining crews and hospital personnel on how to recognize P-1 patients. Mr. Likens recommended in person training in small increments. Mr. Likens suggested including the RPC invitation to all RTAB members to get more help to accomplish goals.
