Minutes

The meeting notice was filed with the Oklahoma Secretary of State on November 18, 2021 at 8:53 a.m. The meeting notice/agenda was posted on the Oklahoma State Department of Health website for the Region 7 RTAB on Monday, April 18, 2022 at 11:00 a.m.

- I. **Call to Order**.....KC Nickels – Vice Chair
The meeting was called to order at 1:06 p.m. by KC Nickels – Vice Chair.
- II. **Roll Call**.....Brienne Smedley, Secretary
Roll Call was taken with members present and absent reflected on the attached attendance sheet.
- III. **Introductions and Announcements**.....Theresa Compos, Chair
There were no introductions and announcements.
- IV. **Approval of the October 19, 2021 minutes**.....Theresa Compos, Chair
A motion to approve the October 19, 2021 minutes as written was made by Air EMS and seconded by Miller EMS. There was no discussion and the motion passed 18-0.
- V. **Reports**
 - A. **Emergency Systems**.....Dean Henke, OSDH
Mr. Henke provided staffing updates: Administrative Assistant Samantha Hickson, Statistical Research Specialist Senait Teckle, and Medical Facilities Service Director Nena West. Open positions to include EMS Administrator II and Epidemiologist II/III. The individual EMS license renewal season has begun with approximately 6,000 applications expected. The time to process and issue license renewals is approximately six to eight weeks; applicants are encouraged to submit their application as quickly as possible to get ahead of the rush. Anya Grether was introduced and she had a presentation on EMResource Interface and the National Emergency Department Overcrowding Score reporting. Grace Pelley gave a presentation about Oklahoma Trauma Transfers and Physician Specialist Availability. The new Trauma Fund application period for January through June 2021 opens April 18, 2022; application forms will be located on the Emergency Systems website. The application deadline is May 31, 2022 for hospitals and June 15, 2022 for EMS agencies and physicians; applications are required to be stamped and received by OSDH by 5:00 p.m. Trauma Fund webinars are tentatively scheduled on April 27, 2022 for hospitals, May 11, 2022 for physicians, and May 18, 2022 for EMS agencies. Katrina Warden. The Oklahoma Emergency Response Systems Stabilization and Improvement Revolving Fund (OERSSIRF) request for proposal period will be open and posted on the OSDH EMS webpage soon. Anyone interested in serving on the OERSSIRF review panel should submit an email and biography to Dale Adkerson for appointment by the Commissioner. OSDH has updated their COVID-19 response points of contacts which are available from OSDH upon request. A Trauma Fund handout, a memorandum regarding the requirement for all licensed hospitals in Oklahoma to report assaults on medical staff to the Violence in the Workplace Registry, and a handout from the OU College of Public Health regarding geriatric trauma were provided in the member packet for review.

- B. Quality Improvement Committee.....Russell Martin, CQI Committee
Last meeting was April 5, 2022. The committee reviewed 10 cases and sent out 14 letters. Two letters were for “good job” and the remainder of the letters required a response back to the committee. Mr. Martin shared they reviewed 8 response they received back from agencies. Two were sent back for further information.

Mr. Nickels reported the committee is working on updating the Region 7 Trauma Plan. Mr. Nickels mentioned adding a Mass Casualty Incident plan to the Trauma Plan. He is receptive to feedback.

Ms. Belcher reported the next Health Care Coalition meeting April 28, 2022 and will be virtual and the Burn Plan will be discussed.
