1. Brad Smith, Chair called the meeting to order at 8:38 a.m.

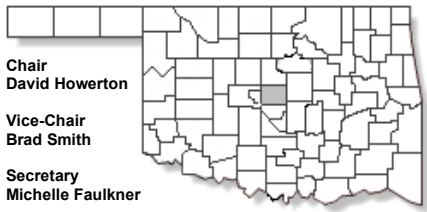

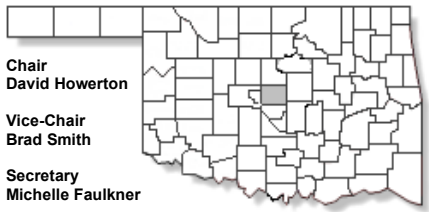

 - Review of Region 8 Trauma Plan Edits were discussed and pages 2, 3, 4, 6, 9, 10, 12, 13, and 14 were ok as written. Page 5 V-A, (Priority I Trauma Patients) or Level II was added. David Howerton suggested that the Region 8 trauma plan reflect the verbiage of the OTERAC approved T-3. Dr. David Smith suggested that the committee adopt the New T-3. Mr. Howerton said the new T-3 will be placed into Appendix C. Page 7 Trauma Rotation was changed to Hand Rotation. Page 8 the "on call" was removed and in Trauma Team "on call facility" was changed to Level I, Level II, or Level III facility. Page 11 Priority I adult and pediatric patient trauma destination and unassigned Priority II – Closest most appropriate Level I or Level II Trauma Center, 3.2. Priority I – Pediatric patients (<15 years of age) trauma destination – OU Health, 3. Priority II pediatric patient (<15 years of age), and within SSM Health Saint Anthony Midwest Regional EMS service area: Priority I adult and pediatric trauma destination – OU Health Closest most appropriate Level I or Level II Trauma Center Priority I – Pediatric patients (<15 years of age) trauma destination – OU Health.
 - Discussion about Region 8 Surgical Emergency Response Team (SERT) David Howerton said they are willing to share the SERT protocol with Region 8. Mr. Howerton suggested to take the headers off and just use the Operational Procedure verbiage in the appendix. Mr. Howerton suggested to get with Dr. Cross about rewording the plan for the trauma plan. Mr. Howerton suggested to table this business item until the July meeting. Mr. Howerton suggested to get the word out to Region 8 agencies should go through the MERC so it can be mutual aided appropriately. Yaz shared that Region 5 and Region 3 have surgical extraction teams but they only respond to their own regions. Item was tabled.
