



- 5. Reports
 - Emergency Systems

Dean Henke reminded that questions for our department to email <u>Esystems@health.ok.gov</u>. EMS vehicle inspections are scheduled online and conducted by the State Capitol. Trauma Registry compliance reports will be in BOX by the 15th of each month. Trauma Fund and Registry trainings are scheduled throughout April. Details are in your handouts. Heather Griffin responded to Brad Smith's inquiry regarding trauma center verification frequency.

- Region 6 & 8 Quality Improvement Committee
 Dr. Juan Nalagan reported they reviewed seven cases with15 feedback letters generated. The committee also reviewed six response letters with two letters to be sent back to sender for additional comments.
- Regional Planning Committee

Brad Smith reported the RPC is continuing to review the Region 8 Trauma Plan. There will also be recommending including a surgical extraction protocol that encompasses all EMS agencies in the region and the MERC coordinating the assets and transportation arrangements for physicians. While this process is finalized, EMS agencies with field amputation need are to contact the MERC. David Howerton reported that EMSA will provide mutual aid with surgical team, field amputation kit, whole blood, and paramedic.

- Regional Medical Response System
 Heather Yazdanipour shared the 5-year work plan is on hold. A region wide chemical surg event
 was conducted on March 28, 2024. Some hospitals went above and beyond by conducting the
 drill with their night shifts. The drill went well, and they received great feedback. Support for the
 solar eclipse has been completed. The RMRS is preparing for the Oklahoma Memorial Marathon.

- Maxine Council presentenced Region 8 Prehospital Trauma Transports SSM Data Reporting Priority I, Priority II, and Priority III patients. Listed are the destination facilities and breakdown of types of injuries. The handouts are in the meeting packets.

- 8. Presentation: Bill Justice shared SALT (Sort Assess Lifesaving interventions Treatment/triage) has been used for years. Mr. Justice described the different processes of SALT which has life saving interventions built into the program such as bleeding control. SALT has replaced the term Triage area with Causality Collection Point (CCP). Depending on the location there may be multiple CCPs such as a football field or a multiple floor structure. It is recommended that Law Enforcement and Fire Departments to use colored ribbons to start the tagging process then EMS will provide tags. Presentation slides are in the meeting packets. Heather Yazdanipour shared that all the Regional Emergency Medical Services Systems (REMSS) teams are currently using SALT.

 - Adoption of SALT as mass casualty triage model in Region 8 Trauma Plan.


