- **Project Respite Letter**

- Discussed having child care providers provide evening of Respite.
- Vicki Land spoke with Carrie Williams (Rainbow Fleet) and was informed that a lot of child care providers already provide these services
- St. Lukes in Oklahoma City provides Respite monthly and it's open to anyone without charge.
- The YMCA provides similar services to members.
- An eight question survey monkey will be sent to ask child care providers if they are interested and what they think.
- If a child care facility provides the Respite care, they will have to follow DHS guidelines even if it falls after daily hours of operation.
