 - The rule change will amend and revoke several section of the chapter, will correct the stroke certification classifications and address or correct other typographical errors.

Assistant Deputy Commissioner of Protective Health, James Joslin, presented timeline for the process of rulemaking changes.

- Process of Rulemaking Intent final version prepared and provided to Policy Leadership and Commissioner, submitted by January 25, 2019.
- Rulemaking Intent submitted to Secretary of State to be published on February 15, 2019 for formal comments. Comments will be evaluated and proposed responses made.
- Formal comment hearing March 19, 2019.
- Submit to Legislature by April 1, 2019 to be acted on this year.
- Approved and sent to Governor for final approval to adopt rule changes.
- Final document published September 11, 2019.

XI. Public Comment

LaWanna Halstead made the comment that a representative wants hospitals to publish weekend elective delivery schedules. If changes are made to the schedule, the hospital would have to notify the State Department of Health. Ms. Halstead stated "we will be killing that bill quickly".
