- V. Business (Business and Possible Action)
  - A. Consolidated Response Plan Working Group Update
    - 1. Laurel stated he spent most of his time working on repatriation. Looking for anything to do with repatriation. All he could find is between hospitals coming back from other countries. Not from facility to facility.
    - Laurel went over the Stroke Survey that the region put out. We didn't get
      a good response back. Some stated they didn't get the email with the
      survey on it. Lori found a blank survey and emailed it to Stacey. Stacey
      will make copies and hand them out at the RTAB meeting today.
    - 3. Brandon Bowen suggested they check with Texas. He stated that our team will reach out with their Racks in Texas.
    - 4. Brandon Bowen stated the other regions are not focused on repatriation; they are focus on determining their resources in their region and destination. Brandon gave a brief summary of what Region 6 and 8's last meeting was said with the Stroke plan.
    - 5. Laurel asked what the destination is. For Stroke patients is it the ED or CT. Who has the liability for the patient once it comes through the ED doors? Is it on the hospital or the EMS agency? Hospital bylaws could be used for regional plans with EMS working in the ED for stroke patients. For the liability reasoning.
