In regards to the Oklahoma Emergency Medical Services Information System, the Version 2 website is now official closed and agencies will no longer be able to submit data into this database. The data, however, is still accessible for review in the report writer option of the current system. A brief overview of the September 17<sup>th</sup>, 2017 Oklahoma Trauma and Emergency Response Advisory Council (OTERAC) was given. Current activities of the Council include passing Good Samaritan legislation to provide protection to good Samaritans that have received an exposure while providing patient care, disaster response planning regarding triage tags and patient tracking, and review of regional stroke plans for acceptance.

#### Presentation VII.

Trauma Data: Where We Were and Where We Are Now - Timothy Cathey, MD Dr. Cathey presented an overview of ten years of data collected from the Trauma Registry and provided recommendations based on this data. Dr. Cathey noted that, compared to 2006 with the exception of the tertiary trauma centers, fewer hospitals are providing trauma care and almost all those that do are providing less of it. Lee Martin asked what we can help the Region with to help the Trauma System improve. Out of the discussion education was needed for: TReC. EMResource. and CQI referral.
