Minutes

I. Call to Order

The meeting was called to order by Chair Chelsea Bishop at 10:31 am.

II. Roll Call

Roll call attendance was taken with the following Board Members absent: Air Methods and Atoka County Medical Center. The following General Members were absent: Alliance Health Seminole, Atoka County EMS, Choctaw Memorial Hospital, Holdenville General Hospital, Konawa EMS, Lane Frost Health and Rehab Center, Marshall County EMS District, McAlester Army Ammunition Plant and Wewoka EMS.

III. Introductions and Announcements

No introductions or announcements. Emergency Systems will provide introductions in their report.

IV. Approval of Minutes - May 11th, 2017

A motion to approve the minutes was made by Amy Beckham and seconded by Delbert Gay. The motion to approve the minutes passed unanimously.

V. Reports

A. Emergency Systems Report

Dan Whipple announced Dean Henke and Linda Dockery as new staff in Emergency Systems. The trauma fund timeline update is completed and ready for your review. Anyone interested please contact Marva in Emergency Systems. The Stroke Registry has been purchased but is not yet operational. There will be a working group on September 15th if anyone is interested. Version 2 of the OKEMSIS database is closed and only available through Report Writer. Just a reminder, if any BLS agency who wants to carry Narcan please contact OSDH Injury Prevention for more details.

B. Oklahoma Trauma and Emergency Response Advisory Council (OTERAC) Meeting Review Dan Whipple announced OTERAC met in June and provided an update to the Good Samaritan rule as it relates to finding out if a person has been exposed to a blood borne pathogen. They are also reviewing best practices for large scale events. If anyone is interested in the working group you can contact Mike Murphy. The next OTERAC meeting will be on September 6th, 2017.

C. Regional Sub-Committee Report

Continuous Quality Improvement (CQI) Sub-Committee
 CQI indicators will be brought to the committee for review, approval and presented to the RTAB during the next meeting.

2. Regional Education Planning Committee

The REPC discussed by-law changes concerning Board Member rotation for EMS licensed agencies with multiple licenses. Hillcrest Medical Center was added to the Stroke Plan to be reviewed and approved by the RTAB. The trauma plan Dallas/Fort Worth destinations will be added to the next REPC meeting agenda to discuss adding the word "Area" to incorporate all appropriate hospitals. REPC is working on a 1, 3 and 5 year strategic plan. A SWOT audit was conducted to assist with the plan. Sepsis and STEMI plans will be the next topics of discussion. Region 5 will consider applying for the next OERSSIRF grant.

- B. Field Assessment Stoke Triage for Emergency Destination Tammy Barnett provided the presentation on the Fast ED App. One of the creators will be in McAlester on August 15th, 2017 from 10:00 am to 3:00 pm at the Hospital if anyone is interested I their presentation. The creators are inputting information from the region and State. The level one hospitals' are entered and they continue working on level three and level four.

VII. Business: (Discussion and appropriate action)

A. $\,$ CQI Committee vacancy - Nominations and vote to fill vacancy

Chelsea Bishop opened up the nominations for the vacancy after Robyn Allen's resignation. Dan Whipple provided the names the Department received by email for the position: Eric Enlow from McAlester Regional Aircare, Amy Beckham from AllianceHealth Durant. Delbert opened the discussion of Mr. Enlow being from an air agency with the concern of multiple air agencies already on the board. James Wilkins provided the nomination for Mr. Enlow and withdrew the nomination based on filling the position with an equivalent background as Ms. Allen and will re-nominate him at the next meeting. A motion to approve Amy Beckham as the new CQI member was made by James Wilkins and seconded by Delbert Gay. The motion passed unanimously after the roll call vote

- B. Regional Strategic Planning Discussion
 Strategic Planning was discussed in the REPC review.
- C. Discuss absences and possible contact with each organization Chelsea Bishop advised the authorized representative forms have not been updated when there is a turnover in an organization. There are multiple agencies with outdated contact information. Outreach will be conducted by Board Members to agencies who were absent at previous meetings. The licensed agencies that have contracted with other agencies to provide EMS coverage will be contacted.
- D. Discuss Bylaws as they relate to absences (Board Members are in violation and required to be removed) Chelsea Bishop advised Bylaws require Board members to maintain 100% attendance. Two Board Members have not met this requirement (Colbert EMS and EMS of Leflore County). EMS of Leflore County has requested an excused absence.
- E. EMS of Leflore County Vote to Excuse Absence Jeff from EMS of Leflore County was introduced. A motion to excuse the EMS of Leflore County was made by Delbert Gay and seconded by Evie Stover. The motion passed unanimously after the roll call vote.
- F. Discuss 2018-2019 Board Member rotation

Two separate board rotation suggestions were presented for review. Since Leflore County EMS received an approved absence. Pafford EMS will remain on the board but would not be a permanent Board Member. With the suggested Bylaw changes there will be nine EMS agencies and eight hospitals. A bylaw change for agencies to combine representatives is for EMS agencies specifically air agencies. As more hospitals combine resources they will still be considered separate given the differences of each hospital and the importance of relaying information from the meetings to the facilities. The Board Member rotation will be voted on during the 4th quarter meeting.

A. Shared Success Story

Two weeks ago McAlester Regional had a huge influx of stroke patients. TPA was administered three times. Resources were combined and medications from other hospitals were moved from St. Johns to McAlester Regional by McAlester Regional AirCare helicopter.

IX. Public Comment

Dr. Cathey stated the Oklahoma Supreme Court struck down the increase in tobacco tax. GAO helicopter analysis came out last week with concerns of helicopter costs. The Big 6 met this week to talk about advances in stroke care. Expect changes in stroke care procedures including use of technology in transferring diagnostic reports.

Sara Richmond asked everyone to consider moving forward on the STEMI system. Dr. Cathey advised the Heart Hospitals have not yet come on board. Dr. Cathey recommended agencies work on best practices for STEMI inside the Region.
