I. Call to Order

The meeting was called to order by Chair Tammy Barnette at 10:32 am.

II. Welcome and Introductions

There were no introductions.

III. Roll Call

Roll call was taken with all Board Members present but Holdenville General Hospital. EMS of LeFlore County arrived at 10:47 am. Quorum was met.

V. Reports/Updates

A. Emergency Systems Quarterly Activity Report – Dean Henke

The 2018 OSDH protocols are being released. Emails have been sent and postcards are in the outgoing mail. Important updates are changes to spinal motion restriction, addition of splinting procedures, urinary catheterization and formulary additions.

Updated Trauma Fund handouts are in the packets. Trauma registry training will be conducted by Dr. Stewart on May 23rd, 2018 at OUMC from 8:30 am to 4:00 pm.

OKEMSIS has updated custom codes and Report Writer has had a recent patch that restored key functionality. The next OKEMSIS training will be May 22nd, 2018 at Kiamichi Tech McAlester from 10:00am to 4:00 pm. Contact Martin Lansdale for questions.

OTERAC last met on March 18th, 2018. The topics of discussion were the Good Samaritan rule, Triage Tags, CQI indicators for the State, and Kathy O'Dell gave a presentation on the National Emergency Department Overcrowding Score. The next OTERAC meeting is at the OSDH June 6th, 2018 at 1:00 pm.

Dan Whipple provided a presentation on Ambulance Codes, Hospital Levels, Patient Priorities, and TReC data.

B. Regional Committee Quarterly Activity Report

Regional Planning Committee

Kari Beggs discussed the RPC is working on a new Regional Stroke Plan which will include Motor plus VAN screening to present at the 3rd quarter RTAB meeting. Ms. Beggs shared that the committee is working to roll out regional education to include Trauma, Sepsis, and Stroke. Ms. Beggs shared that the new CQI membership bylaws were passed making it easier to fill vacant positions.

Kari Smoot discussed case reviews and process improvement. She shared how to make the process educational and systematic.
