## IV. Approval of Minutes – November 15, 2016

A motion was made by Greg Reid to approve the minutes as written. The motion was seconded by Celesa Green and passed unanimous roll call vote.

## V. Business

A. Vote to amend definition of Stroke 2 patients in draft Regional Stroke Plan Eddie Sims discussed the meeting that was held in August 2016 where the doctors met and compromised on the language about Level II Stroke hospitals doing endovascular clot removal till January 1, 2020. A few changes were made to the Stroke Plan for the TIA language and emergent driving for Level I or Level II stroke. The Stroke Plan with revisions was read to the committee. Dan Whipple informed the committee that there were some matter of fact changes to the plan that will not need to be voted on; Norman Specialty Hospital is closed and the FDA requested the drug should not be referred to tPa but it should be referred to alteplase. A motion was made by Celesa Green to have the Stroke Plan taking to OTERAC for approval. The motion was seconded by Valerie Austin and passed unanimous roll call vote.

Greg is going to initiate a discussion at OTERAC that the Glover letter be applied to the Stroke plan as the same for trauma patients.

Eddie is going to talk with Dr. Cathey about making another work group. He would like radiologist and IT to see what it would take to make compatible radiology happen in the state.

B. Discussion of future regional plans such ST-segment Elevation Myocardial Infarction, sepsis, and envenomation.

Eddie asked the committee if we wanted to start plans for other time sensitive matters. At this time the committee has agreed to ask the RTAB today if they would like to continue on other time sensitive matters.
