MINUTES

CALL TO ORDER I.

The meeting was called to order by Chairman Greg Reid at 1:44 p.m.

WELCOME AND INTRODUCTIONS II.

There were no introductions.

III. **ROLL CALL**

Attendance was taken with all Board Members present. All General Members

APPROVAL OF MINUTES - May 17th, 2016 IV.

A motion was made by Celesa Green (Purcell Municipal Hospital) to approve the minutes as written. The motion was seconded by Gail Grego (Norman Regional Health System). There was no discussion, and the motion passed with unanimous approval.

REPORTS V.

A. Emergency Systems Report

Grace Pelley (Oklahoma State Department of Health) provided the Emergency Systems report. She introduced Kellie Clark as the new Clinical Health Facilities Surveyor and Daniel Whipple as the new Trauma Systems Coordinator. She also announced that the new version of the Trauma Referral Center (TReC) Quick Reference Guide were printed and available for agencies at this meeting. She also discussed the recent EMS Director Training sessions that were led by OSDH personnel at the central office and in Woodward. She briefly reviewed the benefits that were had by both experienced and novice agency directors. The proposed EMS rules were signed by the governor and will take effect on the 11th of September. Martin Lansdale is preparing the data for the EMS survey that was taken earlier this year. Ms. Pelley also reviewed the purpose of the Trauma Care Assistance Revolving Fund and the basic process for distribution of the funds. Ms. Pelley also described the history and purpose of the Oklahoma Trauma and Emergency Response Advisory Council (OTERAC) and its working groups to include the rules, legislative, stroke, and medical direction working groups. She talked about the Quarterly Emergency Systems report and asked for feedback relating to its appropriateness. She introduced Dan Oller as the Trauma Referral Center (TReC) manager. Ms. Pelley also introduced Heather Booher as the Continuous Quality Improvement (CQI) coordinator and outlined the need for CQI as well as the process and how to enter it.

Regional Planning Committee (RPC)

Mr. Reid referenced the RPC meeting regarding the draft regional stroke plan that was held immediately prior to the RTAB in view of the Board.

C. Region 8 Update

Jason Likens (Samaritan EMS) provided the Region 8 update. He stated that there has been discussion at that Board about their stroke plan and who best to author it. Their nominations for Officers have been made and the elections will take place at the next quarter meeting.

D. OTERAC Update

Mr. Reid stated that the proposed EMS rules have been passed and mostly involve a reordering of the sections so that an agency will have all the required information in one section as opposed to the current rules where an agency must review multiple sections to see all applicable rules. There have been some new rules created, but the summary of changes is not yet available. OTERAC is also working to revise the Oklahoma Emergency Response Systems Stabilization and Improvement Revolving Fund (OERSSIRF) is funded.

BUSINESS VI.

A. Vote to send Stroke Plan to OTERAC for review

A motion was made by Eric Chase (Mercy EMS El Reno) to forward the draft stroke plan to OTERAC for review. The motion was seconded by Celesa Green. During discussion of the plan, it was noted that several hospitals that may be appropriate destinations were not included in the list of stroke centers. These hospitals included: OU Edmond; Stillwater Medical Center; INTEGRIS Bass Baptist Hospital; St. Mary's Regional Hospital; and Hillcrest Hospital Cushing. Verbiage was also requested to be placed into the Consolidated Regional Plan to that specifies a review period for all Regional plans. After discussion, the motion to send the draft plan to OTERAC for review was passed unanimously.

There was some discussion about the various tools that currently exist and also the various protocols used by agencies throughout the region. The Chair stated at this time he does not feel it to be beneficial to adopt one single tool. The Chair also thanked all who attended as this meeting was one of the best attended in recent memory.
