MINUTES

I. Call to Order

The meeting was called to order by Chair Jason Likens at 1:00 pm.

II. Welcome and Introduction

Jason Likens introduced Daniel King as Base Manager of Samaritan EMS – Yukon.

III. Roll Call

Roll call was taken with quorum met; members present and absent reflected on the attached attendance sheet.

IV. Approval of Minutes – November 20th, 2019

A motion to approve the November 20th, 2019 minutes as written was made by INTEGRIS Canadian Valley Hospital and seconded by Purcell Municipal Hospital. There was no discussion and the motion passed 10-0.

V. Reports/Updates

A. Emergency Systems Quarterly Activity Report and Presentations

Jennifer Woodrow introduced David Share and Brandee Keele as new Quality and Survey Analyst and Xana Howard as the new Trauma Registrar for Emergency Systems. In regards to Oklahoma EMS Informational System (OKEMSIS), the migration of the database is complete and agencies cannot submit a file containing more than 200 runs into OKEMSIS effective November 6th, 2018. OKEMSIS training dates for 2019 were announced to include:

- February 28th, 2019 at Great Plains Technology Center
- March 28th, 2019 at Kiamichi Technology Center
- April 25th, 2019 at Tri-County Technology Center
- May 30th, 2019 at OU Medicine

Invites for Box have been sent to Trauma Registrars for Trauma Fund submissions. Facilities were encouraged to ensure registrars are able to log into Box. Other regional activities were announced to include

- The Region 3 Quality Improvement Committee is planning to send letters to Emergency Department Directors and Trauma Registrars.
- Region 4 is reviewing their stroke plan and drafting a regional STEMI plan.
- The Region 6/8 Quality Improvement Committee is sending letters to hospitals encouraging on-call physicians to make an in-person assessment of patients before deciding to transfer.

B. Oklahoma Trauma and Emergency Response Advisory Council (OTERAC) Update

Eddie Sims discussed activities occurring at the December 12th, 2018 OTERAC meeting which included establishing subcommittees and work groups to address specific issues including Medical Direction and Coordination, Education and Training, EMS Protocol Guidelines, Regulations, Systems Improvement and Development, and EMResource. All matters related to Stroke will now be referred to the Oklahoma State Stroke System Advisory Council (OSSSAC) with a liaison established to attend and represent OSSSAC at all OTERAC meetings. The February 6th, 2019 meeting was canceled with the next meeting schedule for June 5th, 2019.

C. Quality Improvement Committee Quarterly Activity Report

Jennifer Woodrow gave a brief overview of TReC data collected regarding the following:

- Region 6 TReC Data Collection Calls by Calendar Year Quarter and Priority
- Region 6 TReC EMS Data Collection Calls by Transporting Agency, Patient Priority, and 2018 Calendar Year Quarter
- Region 6 TReC EMS Data Collection Calls by Receiving, Patient Priority, and 2018 Calendar Year Quarter
- Region 6 TReC Facilitated Transfers by Calendar Year Quarter and Priority
- Region 6 TReC-Facilitated Transfers by Sending Facility, Patient Priority, and 2018 Calendar Year Quarter
- Region 6 TReC-Facilitated Transfers by Receiving Facility, Patient Priority, and 2018 Calendar Year Quarter
- Percentage of Transfers with Injury Severity Score of 16 or greater at the Initial Facility in less than 60 Minutes
- Region 6 Transfers of Patients with Injury Severity Score of greater than or equal to 16 by Initial Facility Length of Stay for June 2016 through December 2017
- Trauma Patient Transfers at Initial Facility in less than 120 Minutes with Systolic Blood Pressure less than 90 mmHG by Trauma Region and Half Year

VII. Presentation – OSDH Public Health Lab

No presentation was given.

VIII. Public Comment

Alicia Webster, the new American Heart Association Quality Improvement Systems Director, introduced herself and discussed The Oklahoma Mission Lifeline EMS Challenge. The study focuses on EMS agencies using four criteria: The number of chest pain patients that are transported; number of chest pain patients that received a 12-lead EKG within ten minutes; the number of ST-segment Elevation Myocardial Infarction (STEMI) patients where the receiving facility was contacted within ten minutes of STEMI recognition; and the length of time from first medical contact to intervention at the hospital. There is no fee to enter the project. PJ Richards of Genentech introduced herself and offered stroke resources to hospital based members. Grace Pelley of Emergency Systems announced the EMResource Workgroup meeting will be held on March 15th, 2019 and encouraged members to participate stating hospital representation is needed.
