## **Description of Amendment:**

- a. This is to incorporate the following: Questions and Answers
- 1. Question: The RFP appears to be for the Take Charge Program, breast & cervical care. Is this correct?

**Answer:** Yes, this RFP is for the Take Charge! Program which provides breast and cervical cancer screening services and limited diagnostic services.

**2. Question**: I think we may have been a provider in the past as a subcontractor, as it was the patient's clinician that was the contractor and we performed the pathology/cytology services and billed back to the clinician to receive payment at the take charge fee schedule rates. This appears to be a direct contract, is this correct?

Answer: We are requesting bids to obtain a direct contract.

**3. Question**: If we were to be contracted, who are the physicians/medical groups that will be obtaining/collecting the specimens to send for pathology and where are they located?

**Answer:** Due to pending contracts with the Take Charge Program, we are submitting the complete list of contractors from last Fiscal Year 2019. A current list of contractors, at the time of the Pathology award, will be provided to the awarded vendor. (See attachment)

**4. Question**; What EMR's do the Take Charge providers currently utilize that a contractor will be required to transmit electronic results to?

**Answer**: The Take Charge! contractors use a variety of EMRs. The selected contractor would be allowed to work with the TC contractor to determine how to electronically submit results including the option of faxing the results.

5. Question: Will OSDH consider splitting the PAP and HPV testing away from the FNA testing?

Answer: Yes, the OSDH will allow for splitting PAP and HPV testing from the FNA testing via subcontracting.

6. Question: In regards to courtier services, the previous contract we had allowed for us to pick up all specimens from DSDH (in OKC) each day. This RFP mentions picking up from each site, making us think this may include Tulsa and potentially other sites. Can you confirm that we would be able to utilize OSDH as the lone pickup spot?  Answer: No, OSDH will not be the lone pickup spot. Specimens will not be sent to OSDH. Specimens should be picked up at TC contracted facilities.
