MINUTES

I. Call to Order

The meeting was called to order by Chairperson Stacey Jarrard at 1:00 pm.

Approval of Minutes - February 15th, 2018 IV.

A motion to approve the minutes as written was made by Dr. James Campbell and seconded by Mark Forrest. There was no discussion and the motion passed 14-0.

V. Reports/Updates

A. Emergency Systems Quarterly Activity Report

Lori Strider provided the quarterly Emergency Systems. She informed the committee that Dr. Cathey has left the department, but is still helping with the new 2018 protocols. The 2018 protocols have been sent out, if anyone has any questions please contact Bill Henrion. The latest timeline for the trauma fund was in the packet, please contact Marvia Williamson with any questions, OKEMSIS's custom codes have been updated on OSDH's website. Report writer has had a recent patch restored for key functionality. Please contact Martin Lansdale for any question regarding OKEMSIS. Lori Strider gave a brief synopsis on the activities of the other regions in the State. The last OTERAC was March 07th, 2018, the Good Samaritan rule working group is continuing, but may need to be a rule change and possibly worked through the STD division. Dr. Patrick Cody and Kelly McCauley are working on the triage tag/mass casualty working group. At the last Region 2/4/7 Quality Improvement Committee the region reviewed the indicators for the entire State. Kathy O'Dell gave a presentation over "National Emergency Department Overcrowding Score" (NEDOCS). The next OTERAC meeting is at the Oklahoma State Health Department; June 6th, 2018 at 1:00 pm. Lori gave brief synopses of the other Regions activities. Lori reviewed the Oklahoma trauma terminology; the difference between "code 1 and code 3", the level of hospitals, and the priority definitions.

- Regional Committee Activity Reports
 - 1. Regional Planning Committee Laurel Havens provided an update he committee on the transfer agreements, the Stroke language, and the bylaw language revision. A STEMI work group was created.
 - 2. Quality Improvement (QI) Committee Dan Whipple provided the committee with an update from the last meeting. A presentation was done with the 16 indicators the committee voted on. The data is being looked at again. The benchmark that has been presented is not adequate enough, a medium and mode will be looked at to establish a timeline.
