Agenda Item 6:

Alternative Fuels Program and Legislative Updates

Jim Williams, Director, Safety Standards Division, reported on program updates. Jim stated that station inspections have been completed in the Northeast region to include Sapulpa, Mannford, Tulsa, Okmulgee, Muskogee, and Stillwell. Inspections in the Northwest region included Oklahoma City (2), Weatherford, Choctaw, Chickasha, Anadarko, Clinton (2), Edmond, Yukon. There were also 4 compliance checks completed.

Jim reported that a recent inspection at a metro station found a dispenser that would register the first ³/₄ gallon and then stopped measuring the sale. At least one customer was taking advantage of this as he paid inside for a small amount of fuel and fueled for a fairly long period before it was found to be defective. The store personnel did notice that people preferred it.

At a private location, a bullet stack of cylinders was reinspected for out of date PRV valves. During the reinspection it was identified that none of the PRV valves were locked in the open position, and one PRV was in the closed position which would have prevented it from relieving pressure in the event of an overpressure failure.

Victor Self discussed witnessing the Bedrock Solutions Hydrogen pressure test for the gasket that will be used in their pods. It was at a dedicated facility called Testers, Inc. There were leaks in the fittings but not the cylinders. The goal was to reach 5000 psi, but the cylinders were depleted and could not reach that level.

David Frick, Air Quality and Clean Cities Planner II, reported that round 2 of the charging infrastructure grant is available for application. The deadline is August 28th if you know anyone interested. They should hear something in July regarding the Climate Production Grant. There is 20 million dollars for electric school buses and vehicles. They are doing some small town electric vehicle public interaction which has had some interest. June brings in ozone season and it is being monitored closely. If needed there is federal funding for cleaner air.
