Laws Affecting Libraries



Children's Internet Protection Act or CIPA

• The Children's Internet Protection Act (CIPA) requires that K–12 schools and libraries in the United States use Internet filters and implement other measures to protect children from harmful online content as a condition for federal funding.



CIPA cont.

- Access by minors to inappropriate matter on the internet
- The safety and security of minors when using electronic mail, chat rooms, and other forms of direct electronic information
- Unauthorized access, including so-called "hacking", and other unlawful activities by minors online
- Unauthorized disclosure, use, and dissemination of personal information regarding minors
- Measures restricting minors' access to materials harmful to them



Americans with Disabilities Act

- The Americans with Disabilities Act of 1990 is a civil rights law that prohibits discrimination based on a disability.
- Library materials, buildings, and websites must be accessible.

First Amendment

- The First Amendment to the United States Constitution guarantees freedom of the press, freedom of speech, and open discussion of ideas
- Limited Public Forum rules placed on using meeting rooms by outside groups must apply to all groups



Open Meetings

Open Meetings Law – also a State Law, Title 24, Articles 301-314

- Notice
- Annual Schedule
- Agendas
- Minutes
- Executive sessions



Open Records and Confidentiality

Open Records Act
Title 51, Articles 24A.1 - 24A.9

- Minutes of board meetings
- Names and salaries of library employees
- Library policies
- Records of income and expenses
- Library card holder records

Confidentiality
Title 65, Articles 1-105

- Library records showing what was checked out or used by individuals (computers) is confidential
- Except library administration, authorized in writing by individual, or court order

OKLAHOMA

 2013 addition: minors records "shall not be disclosed"

HB 3702

- Requires schools and libraries to have safety policies to prevent access to obscene materials
- Vendors for digital and online database resources must verify that the resources comply with the law



Laws Affecting Employers



Fair Labor Standards Act and Equal Employment Opportunity Laws

FLSA

- Minimum Wage Law
 - Federal minimum wage is \$7.25
- Exempt and non-exempt employee limits

EEO

 Prohibits discrimination of protected classes in hiring, promotion, and other personnel actions



Occupational Safety and Health Administration and Family Medical Leave Act

OSHA

 Sets safety guidelines and training requirements for establishing a safe workplace

FMLA

 Requires covered employers to provide employees with jobprotected, unpaid leave for qualified medical and family reasons



Americans with Disabilities Act for Employers

- The ADA prohibits employers from discrimination against people with disabilities
- Reasonable accommodations may be required



SQ 788

- Legalized medical marijuana in Oklahoma
- Employers cannot "discriminate" based on the individual's status as a medical marijuana license holder



Advocacy



Oklahoma Library Association Advocacy Group

 Coordinates OLA's legislative involvement, promptly communicates with the officers and membership about state or federal legislation concerning Oklahoma libraries and encourages understanding and involvement of members in the legislative process.
