

**AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING

- Two programs, "What's Changing in Fundraising and How Nonprofits Should Adapt" and "How to Get Your Board to Fundraise," to be presented by Chad Barger on November 16, 2022.
