Any attempted termination of this obligation is not effective, however, until this obligation is released by the Surety Department of the Commission's Oil and Gas Conservation Division.

PROVIDED, HOWEVER, the aggregate liability of the surety under this agreement shall in no event exceed the total sum of this financial instrument.
