The condition of this obligation is that the above bounden Principal proposes to land apply fluids, soils and/or drill cuttings within the State of Oklahoma pursuant to Commission rules. Now, therefore, if the above bounden Principal shall land apply fluids, solids and/or drill cuttings within the State of Oklahoma at the time and in the manner prescribed by the laws of the State of Oklahoma and the rules and orders of the Corporation Commission of the State of Oklahoma, then this obligation shall be null and void; otherwise, the same shall be and remain in full force and effect. This obligation may be terminated upon a minimum of thirty (30) days notice in writing to the Oil and Gas Conservation Division and evidence furnished of acceptable alternate surety if required (OAC 165:10-7-10) or as the rule or statute may be amended. Such termination is not effective until this obligation is released by the Surety Department of the Oil and Gas Conservation Division, and subsequent to a determination by Oil and Gas Conservation Division personnel, after inspection or review, that the release of surety is appropriate.

Provided, however, the aggregate liability of the surety hereunder shall in no event exceed the sum of this bond.
