APPLICATION

COMES NOW Lori Wrotenbery, Director of the Oil and Gas Conservation Division, Oklahoma Corporation Commission, and shows to the Commission as follows:

I. PARTIES:

A. That the Applicant is Lori Wrotenbery, Director of the Oil and Gas Conservation Division, Oklahoma Corporation Commission, Jim Thorpe Building, 2101 North Lincoln Boulevard, Oklahoma City, Oklahoma, 73105.

B. That the Respondents are listed by name and address in the Affidavit of Mailing filed in this cause.

II. ALLEGATION OF FACTS:

A. That the Applicant is the duly appointed and qualified Director of the Oil and Gas Conservation Division of the Oklahoma Corporation Commission, and that by virtue of her office and on behalf of the State of Oklahoma, is authorized to institute this proceeding.

B. That the Commission has heretofore issued orders governing the production of gas in the State of Oklahoma; and that in order to prevent waste, protect correlative rights, and ensure ratable taking of gas pursuant to said market demand orders, and pursuant to previous orders issued by the Commission governing the testing, production, and marketing of gas for various gas pools and combination oil and gas pools within the State, that it is now necessary that the Commission conduct a hearing to determine the anticipated gas production for the months of August, 2008, through January, 2009.

C. That the Commission has heretofore issued orders classifying and naming various pools within the State as dry gas pools and by special pool rules classifying certain wells within combination oil and gas pools as gas wells, and that the Commission should consider the naming and classification of any new gas pools or combination gas and oil pools, and fixing the rate of production pursuant to the market demand and/or special pool rules which have established the method and procedure in determining the amount of gas that may be permitted to be produced from the individual classified gas wells.

D. That the operators and producers, purchasers, takers and carriers of gas, should make such reports as are now required by general rules and regulations and/or special pool rules, and that such additional reports should be required as deemed necessary in determining the potential, shut-in pressures, monthly production and status of wells or leases producing gas; and that the Commission should further consider, where necessary, the method of producing the amount of overage and underage not already established by field rules.





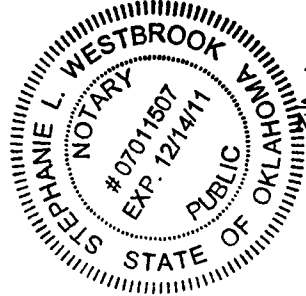
