NOTICE OF INTENT TO CONSTRUCT

In order to comply with the requirements of Section 2 of Oklahoma Senate Bill 808¹ ("OK Siting Laws"), which was approved by the legislature and signed by the Governor, and in advance of certain rules that are to be promulgated by the Oklahoma Corporation Commission ("Commission") pursuant to the passage of SB 808, Caddo Wind, LLC, hereby informs the Commission of its intent to construct the Caddo Wind wind energy project (the "Project") located in Caddo County, Oklahoma.

The Project has been under active development for several years. The most recent FAA form 7460-1 filing was made on February 16, 2017. A summary of the February 16, 2017 FAA form 7460-1 filings for each wind turbine tower location within the Project boundary is attached as Exhibit A. Exhibit B to this letter presents a diagram showing the real estate analyzed and included in statutory setback compliance. As of the date of this notice, and based on publicly available data, Caddo Wind, LLC, attests that the Project design complies with the setbacks required by the OK Siting Laws.

In accordance with the OK Siting Laws, Caddo Wind, LLC, also confirms it is submitting a notice of intent to construct to the Oklahoma Corporation Commission in the form attached hereto as Exhibit C. No project facilities are located within an incorporated area of a municipality, and thus no additional notice is required under SB 808.
