



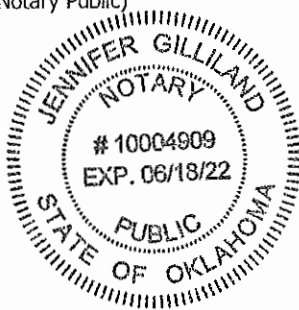

Pursuant to the notice requirements contained at Section 160.21 of the Oklahoma Wind Energy Development Act, 17 O.S. §§ 160.11-160.22 (the "Act"), the notice requirements contained at OAC 165.35-45-4 of the Oklahoma Corporation Commission's (Corporation Commission's) Wind Energy rules, and the notice requirements contained at OAC 25.40-3-1 of the Oklahoma Aeronautics Commission's ("Aeronautics Commission") Wind Energy Rules, NextEra Energy Resources, Inc. hereby submits to the Corporation Commission, notification of intent to build the Skeleton Creek wind energy project ("Skeleton Creek").
