The Auditorium doors were open to receive members of the community to be part of the meeting, to know about the project, to ask questions and to learn more about the company and the construction plans and schedule of the project.

There were 4 Wild Horse Mountain Project maps displayed in the room for the community to review. The maps showed detail information about the design of the project, proposed locations of the wind turbines, substation, transmission line, temporary offices, access roads to the project, new proposed roads to be build inside the project area, and distribution of the underground electric circuits.

Since the community members didn't attend at the same time to the Auditorium, the presentation of the project was done individually to each of the attendants and the questions were answer one on one through the morning. The meeting started with the attendance of the School principal. Later, Mr. and Mrs. Xxxx, who are neighbors of the project on the north side, came by curious to learn the actual distance from their house to the turbines and the potential noise that they could heard. Their house is located 2 miles away from the project. Mr. John XXXX stop by the meeting, he introduces himself as a representative of the labor community in Clayton city, after learning the details of the projects his questions were focused on the employment opportunity that the project could offer to the community. Mr. John... received the

contact information where he can submit applications to work with RES and also to provide information about the areas of the expertise to the people he represents so RES can pass along the information to the subcontractors that will work on the project. Later members of the school stopped by to learn about the project. Also received general explanation of wind energy, how is produce and how the wind turbines operate.

The questions received from the community were:

- Where is the actual location of the project? the question was answered by showing the project area on a map and the distance to the city.

- What is the distance to the city?

- What is the distance to their homes? the question was answered by showing the project area on a map and having them locating their homes, then measuring the distance on google maps.

- What is the size of the project? the question was answered by showing the project area on the map, also by mentioning that the total area that is part of the project is 6,698.4 acres. The actual area that will be part of the project, or that will have some infrastructure is 1,200 acres.

- What benefits is the project bringing to the community? Besides the production of clean renewable energy with no contamination, the project during construction will host around 100 people working on the project that will need to have basic services like accommodation and food service. Also, the project may bring some work opportunities during construction.
