FOREWORD



OKLAHOMA Transportation

2023-2026 Asset Preservation Plan

The Oklahoma Department of Transportation is pleased to present the 2023-2026 Asset Preservation Plan which encompasses preservation activities on our interstates, U.S. and state highways and bridges. The projects in this plan were developed through a rigorous process led by our eight field district engineers with stakeholder input.

The 2023-2026 Asset Preservation Plan includes projects to improve the pavement condition of interstates and highways, rehabilitate bridges and provide accessibility improvements throughout the state. This plan serves to supplement the activities of the Eight-Year Construction Work Plan and works to preserve our existing assets as ODOT strives for Oklahoma to become a Top 10 State in transportation infrastructure.

The Asset Preservation Plan continues to be a key component in reducing the amount of Oklahoma's on-system, structurally deficient bridges from 1,168 bridges in 2004 to 45 at the end of 2021. This latest plan update leverages the focus and resources needed to maintain highway bridges, along with increased investment in projects to improve and extend the lifespan of pavement conditions. The plan includes improvements to 2,209 lane miles of highway pavement, 39 projects addressing accessibility deficiencies and rehabilitation of 117 bridges at risk of becoming structurally deficient. Altogether, the plan includes 330 projects statewide for a total value of about \$502 million.

The need for preventative maintenance is most directly influenced by the unpredictable forces of nature, the aging of the highway and bridge infrastructure, and a previous history of underfunding that caused a deferral of critical maintenance projects. Since the condition of highway pavements and bridge structures can change dramatically in a short window of time, the Asset Preservation Plan is presented as informational and should be considered flexible and subject to regular re-prioritization and adjustment as dictated by ever-changing needs.

On behalf of Governor Stitt and ODOT, thank you for the opportunity to present this information and for your continued support of construction, improvement and maintenance of Oklahoma's transportation infrastructure.

Budgetary Projections

ASSET PRESERVATION PLAN - FY 2023 through FY 2026

The budgetary projections utilized for the basis of the fiscally responsible and financially balanced Asset Preservation Plan were established through a systematic evaluation of the Department's anticipated State and Federal revenues and expenditures. Projections were performed for State Fiscal Years 2023 - 2026 with the State Fiscal Year defined as beginning July 1st and ending on June 30th. The budgetary projections only address funding that has been historically and/or categorically committed to State asset preservation.

For the purposes of the initial projections, an estimated budgetary baseline amount of \$132 million was utilized as the benchmark for SFY 2023. This baseline amount provides \$84 million for roadway preservation, \$42 million for bridge preservation and engineering, and \$6 million for accessibility projects statewide.

A formula that includes consideration for conditions and that is influenced by the lane miles in each Field District is applied to the roadway asset preservation baseline amount to insure an equitable geographic distribution of each Fiscal Year projection. Likewise, a formula that is focused on the square footage of bridge deck in each Field District is applied to the bridge preservation baseline amount to achieve a similar distribution of the available bridge asset preservation funds. Lastly, a formula considering common demographic, physical and historical criteria, and yields a District percentage that renders an equitable distribution of funds set aside for accessibility projects.

Balancing Process

The development of Asset Preservation Plan begins with our Field District Engineers and is guided by their knowledge of the transportation needs and priorities in their respective Districts. They and their staff work to maintain an understanding of the condition of the roads and bridges in their areas of responsibility.

Their daily experiences and knowledge of the transportation assets is then coupled with the careful consideration of the improvements anticipated to be delivered through the Eight Year Construction Work Plan (CWP). It is important to maintain a clear perspective of the project development schedule for the improvements encompassed by the CWP. The timing of preservation activities is paramount in order to avoid potential project conflicts and to maintain the transportation system in a serviceable and manageable condition until any planned larger scope improvements can be achieved.

The Asset Preservation Plan is a function of each Field District's condition assessments of the highway network, the associated critical needs and the work to be accomplished in the CWP along with the anticipated preservation budgets. Annually, the Field District Engineers review and validate the scheduled Asset Preservation Plan projects and target their needed preservation activities in accordance with the projected funding availability. The Asset Preservation Plan is crafted with foremost consideration for maintaining the integrity of the Field District Engineer's transportation system management strategy and project priorities. In addition, the balancing process seeks to insure that each Field District is allocated available funding in accordance with the aggregate budget projections.

ADDITIONAL CONSIDERATIONS

System preservation can be dramatically influenced by the unpredictable effects of weather, deterioration and ever changing traffic patterns. Therefore, asset preservation activities are somewhat more reactionary in nature than the calculated improvements encompassed in the Construction Work Plan. Some re-prioritization of the preservation activities depicted herein is acceptable and expected.

The Asset Management Plan is balanced within these guidelines and has been determined to be an equitable representation to the satisfaction of the Department and the Transportation Commission.
