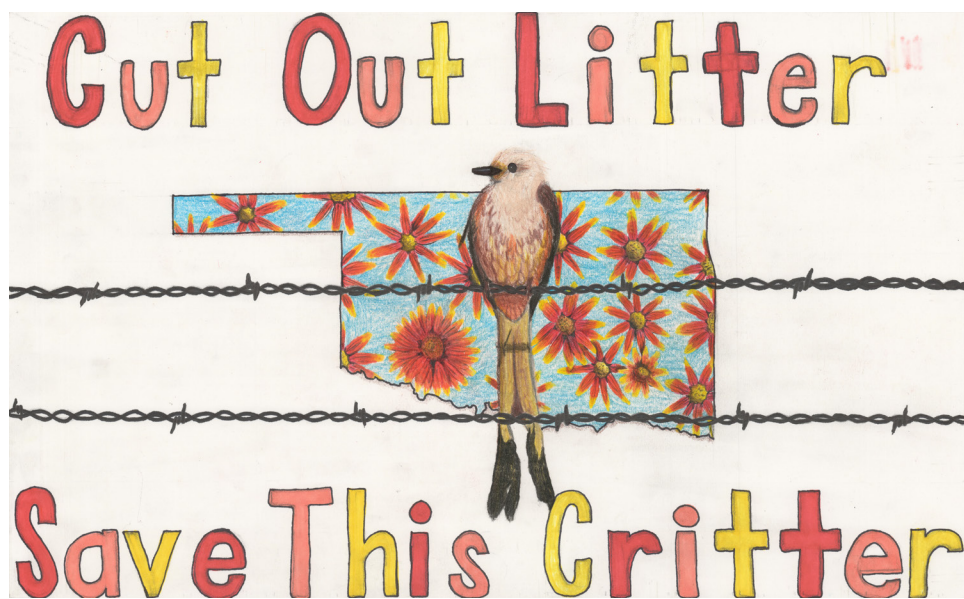

- NO glue; NO glitter; NO attachments; NO signatures; NO year dates on front of posters!
- NO syndicated & NO copyrighted & NO clipart images; NO name brands, NO Company or Corporate names!
- NO computer-aided poster entries! NO copy-machine poster entries!
- NO profanity; NO sexually explicit content; and NO drawings of a suggestible nature allowed.
- Attach **FULLY COMPLETED ENTRY FORM** to back of poster in "upper right corner".
- Reproducibility, spelling, grammar, and poster message also factors into judges' decisions. **Use good lettering, high contrast, & bright colors on paper or posterboard preferred sizes 11" x 17" or 12" x 18"**.
- Please follow all poster contest rules or face disqualification of poster entry.
