Hand Delivered bids will be received at the <u>Oklahoma Department of Transportation Building</u>, Facilities Management Division, 200 N.E. 21st Street, Room 1-B7, Oklahoma City, Oklahoma 73105 on July 14, 2022 until 1:30 PM CST. The bids will be opened and immediately read publicly on July 14, 2022 at 1:30 PM CST. in the ODOT Project Management Conference Room located at the address above.

Description of Property:

A strip, piece, or parcel of land lying in part of Government Lot 4 of Section 5, T15N, R12E, Okmulgee County, Oklahoma. Said parcel of land described by metes and bounds as follows:
