The bids will be opened and immediately read publicly on July 08, 2021 at 1:30 PM CST. in the ODOT Project Management Conference Room located at the address above.

Description of Property:

A strip, piece or parcel of land lying in part of Government Lot 4 of Section 19, T6S, R21E in McCurtain County Oklahoma. Said parcel of land being described by metes and bounds as follows:
