The bids will be opened and immediately read publicly on **January 13**, **2022 at 1:30 PM CST**. in the ODOT Project Management Conference Room located at the address above.

Description of Property:

A strip piece or parcel of land lying in the SW/4 of the SW/4 of Section 28, T16N, R2W in Logan County, Oklahoma. Said parcel being described as metes and bounds as follows:

<u>Tract A:</u> Commencing at the SW corner of said SW/4, SW/4; thence N00°01'37"W, along the west line of said SW/4, SW/4, a distance of 127.22 feet; thence N89°42'23"E, parallel with the south line of said SW/4, SW/4, a distance of 33.00 feet to the **POINT OF BEGINNINEG**; thence N00°01'37"W, parallel with the west line of said SW/4, SW/4, a distance of 544.03 feet; thence on a non-tangent curve to the left having a radius 2984.75 feet and an arc length of 369.65 feet (having a chord of S23°49'54"E - 369.41 feet); thence on a non-tangent curve to the right having a radius of 158.37 feet and an arc length of 63.95 feet (having a chord of S25°30'29"W - 63.52 feet); thence S37°59'59"W a distance of 33.59 feet; thence on a non-tangent curve to the left having a radius of 642.96 feet and an arc length of 159.06 feet (having a chord of S39°30'17"W - 158.65 feet) to said **POINT OF BEGINNING**.

<u>Tract B:</u> Commencing at the SW Corner of said SW/4, SW/4; thence N89°42'23"E, along the South line of said SW/4, SW/4, a distance of 139.89 feet; thence N00°01'37"W, parallel with the west line of said SW/4, SW/4, a distance of 33.00 feet to the **POINT OF BEGINNING**; thence on a non-tangent curve to the right having a radius of 502.96 feet and an arc length of 195.03 feet (having a chord of N41°04'03"E - 193.81 feet); thence on a non-tangent curve to the left having a radius of 2984.75 feet and an arc length of 171.75 feet (having a chord of S32° 24'00"E - 171.73 feet); thence S89°42'23"W, parallel with the South line of said SW/4, SW/4, a distance of 219.34 feet to said **POINT OF BEGINNING**.

Containing in both parcels 1.32 acres (57,304.39 square feet) more or less.
