
The Chickasaw Nation is pleased to support the Oklahoma Department of Transportation in its efforts to construct a signature bridge spanning the Oklahoma River on Interstate 35 near downtown Oklahoma City. The new span will serve as a visual touchstone the millions of travelers who pass through Oklahoma City at the intersection of Interstates 35 and 40, often referenced as the Crossroads of America.

The Chickasaw Nation recently broke ground on the OKANA Resort and Indoor Waterpark, a \$400 million resort-style destination adjacent to the recently opened First Americans Museum in the area where this bridge would stand. We believe the creation of a signature bridge crossing the Oklahoma River at this location will greatly enhance access to both our resort development and the museum.



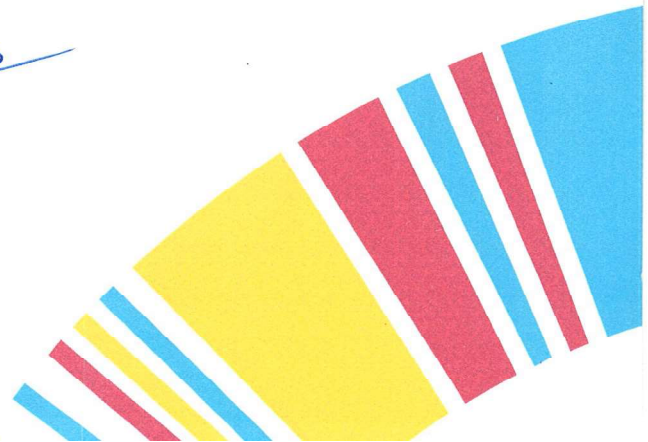
