## Project

- Reconstruction/Rehabilitation of roadway
- Addition of turn lanes
- Provide adequate sight distance
- Remove unnecessary or duplicate driveways
- Consolidation of median openings where appropriate

## Purpose

The purpose and need of the project is to Improve:

- Highway Conditions
- Highway Safety
- Highway Operations

## Project Improvements

- Add left turn-lanes at median openings & right-turn lanes at all major intersections.
- Traffic signals will be replaced at Plainview Road and Michelin Road.
- New right-of-way will be required.
